Attached at Tab I is a self-explanatory memorandum to the Department of State for signature by Michael Wheeler, reaffirming that visas be denied to Tair F. Tairov and any other official of the World Peace Council who applies for it. (8)

The incoming State Department memorandum is at Tab II. At Tabs III and IV, respectively, are the documents of January 11 and February 13, 1982. (U)

Mike Guhin does not concur in the recommendation. Tairov has been invited by the UN and thus his case relates to the 1947 UN Headquarters Agreement. For this reason, State strongly recommends that Tairov be admitted. Guhin believes that State makes a reasonable case for admission in light of our laws, international obligations, and practices. He recommends, therefore, that we approve State's recommendation for admission but, at the same time, tell State that Tairov should be legally restricted to the Headquarters District and ask State where it plans to draw the line on such cases.

Bill Stearman and Paula Dobriansky concur.

Proposed Travel of World Peace Council Representative to the United States

The memorandum from the State Department, dated April 29, raises the question whether a high official of the World Peace Council, a Soviet national should be exempt from the provisions of the memorandum of January 11, 1982. This memorandum instructed the Department of State to deny visas to foreign visitors connected with the World Peace Council (WPC) as well as other individuals planning to visit the United States to attend WPC functions. A clarification, dated February 13, 1982, stated that such visa applications should be handled on a case-by-case basis "taking into account the degree of WPC involvement and the purpose of the trip". (S)

The objective of the February 13 memorandum was to enable the Department to waive the prohibition in cases where its enforcement clearly would cause embarrassment to the United States or undue hardship to the individual concerned. Such cases would involve individuals whose connection with the WPC was tenuous or dated back many years. It certainly did not mean to apply to current officials of the WPC: indeed, such officials were the principal target of the original prohibition.

and possibly other officials of the We understand that WPC, including its President, Mr. Chandra, wish to attend the United Nations Special Session on Disarmament in June and propose to enter the country as UN guests. Since, however, the Department makes it clear that there are no effective ways of preventing any person who enters the U.S. under these auspices from leaving the immediate area of New York City and engaging in any public activities he chooses, to issue visas in such cases would contravene the purpose of the original prohibition. The WPC makes no secret of the fact that it intends to stimulate and organize massive demonstrations against the U.S. Administration in favor of Sovietsponsored arms control proposals. It is clearly not in the interest of the United States to permit such activity by aliens, some of them individuals directly connected with Soviet security services. (S)

SUBJECT: Travel of World Peace Council Representives to the United States

With reference to the NSC memorandum of February 11 authorizing the Department to adjudicate visa applications by aliens connected with the WPC on a case-by-case basis, the Department has now received several applications by such aliens which raise a serious additional issue.

Most prominent is world Peace Council. has applied for a visa to attend a meeting at the United Nations from April 19 to May 4 in preparation for the UN Special Session on Disarmament (SSOD II) in June. The WPC is a non-governmental organization (NGO) accredited by the UN for purposes of consultation and has been invited by the UN

This official invitation from the UN brings his case within the purview of the United Nations Headquarters Agreement of 1947 which contains provisions guaranteeing access to the Headquarters District to certain classes of aliens, including "representatives of nongovernmental organizations recognized by the United Nations for the purpose of consultation under Article 71 of the Charter, ...". The Headquarters Agreement provides that the United States will not "impose any impediments to transit to or from the headquarters district..." of such persons and that "the laws and regulations in force in the United States regarding entry of aliens shall not be applied in such a manner as to interfere with the privileges referred to in section 11."

Pursuant to this agreeement we have consistently claimed and exercised the right to refuse to issue visas to UN invitees when there is clear and convincing evidence that the alien in

question is coming to the United States for purposes outside the scope of UN business and prejudicial to US national security interests. Aliens denied entry on this basis are generally spies (working for a foreign hostile intelligence service) or terrorists who are engaged in hostile intelligence or terrorist activities and who are presumed to be coming to the US for activities prejudicial to our national security.

On the other hand, we have not heretofore claimed a right of exclusion in cases such as where there is no indication of espionage or terrorist activitiy. Denial in such a case would be tantamount to asserting a right to prevent a Communist - front non-governmental organization from participating through its own officials in UN NGO meetings. Accordingly, such an exclusion would be seen as a direct challenge to the UN's ability to hold such meetings in the U.S. without political interference from us. It is the Department's opinion that the US would lose if the UN challenged us on this point through arbitration. The Department believes that in view of our international obligations to facilitate entry to the Headquarters District for UN business and the fact that a visa denial in this case would represent a departure from previously agreed upon practice, issuance is advisable. You should be aware, however, that in a memorandum dated October 20, 1980, the Office of Legal Counsel of the Department of Justice disagreed in certain respects with the Department's position concerning our obligations under the Headquarters Agreement, although it is not clear that they would disagree about a case such as this.

is admitted on UN business, he legally can be restricted to the Headquarters District. Usually such a restriction also includes the "immediate vicinity" of the District, which is defined to include an area having a 25 mile radius around Columbus Circle, New York. Also, the FBI could be directed to keep him under surveillance. It would be legally permissible to restrict his activities to those specifically tied to his UN consultations. Any violation of either kind of restriction would form a basis for instituting deportation proceedings. It should be noted, however, that acting upon violations or intended violations could involve quasi-judicial and judicial proceedings which could be politically embarrassing and could even necessitate taking into custody if he were to persist in keeping an unauthorized speaking engagement, for example, in the face of a warning that doing so could lead to his deportation.

In spite of the potential difficulties which his admission might create, the Department strongly believes that our long-term interests vis-a-vis the UN and our position as host country require that the entry of an alien connected with the WPC be authorized when his specific purpose of entry brings him within the purview of the UN Headquarters Agreement, unless the clear and convincing evidence test mentioned above justifies his exclusion. Accordingly, we recommend that you authorize our taking the steps necessary to authorize entry.

Your memo of Jan. 11, 1982, instructed the Department to refuse visas to foreign visitors connected with the World Peace Council (WPC) as well as other individuals planning to visit the U.S. to attend WPC functions. We accordingly instructed our posts abroad to refer any such visa applications to us for our information and verification prior to refusal.

We interpret your memorandum as absolutely barring the travel of all persons connected with the WPC, regardless of the purpose of their visit. The currently pending case of a prominent and the prospect of similar controversial cases of other nationalities) suggests a need to clarify whether an absolute bar was intended.

The visa applicant is foremost writer, poet, and novelist, who is listed as a member of the WPC. His novels have been translated into many languages and are widely read in the U.S. is already ineligible to receive a visa because of past membership in the Communist Party, although he has been openly critical of many aspects of communism during the past twenty years. He joined the WPC when it was first established after World War II, understanding that it was not a communist organization per se. He has been completely inactive in the organization since the first years and has had nothing to do with it for the past twenty years. He has not attended a WPC meeting since 1962. His very apathy about the organization is the reason he has not resigned formally and accounts for the WPC carrying his name on its membership rolls. The purpose of his proposed trip is to lecture at the University of Puerto Rico in mid-February. He will be making later wisits to discuss business matters with his American publisher and to collaborate with producer David Merrick on the Broadway production of one of his novels. Absent his connection with the WPC, the Department would routinely recommend to Justice a waiver of his ineligibility, as required by the "McGovern Amendment." He has received waivers in the past. "

In this connection, a WPC membership list provided by CIA shows that a number of international figures are WPC members, including Jacques Mitterand, brother of President Mitterand of France, Joshua Nkomo of Zimbabwe, Gabriel Garcia Marquez, a well-known Colombian author, Melina Mercouri, the Greek actress and member of the Greek Parliament, Satyajit Ray, a highly regarded film director from India, and six Labour Party members in the British Parliament.

There are also a number of Canadian members. Canadian citizens are not required to obtain visas for temporary travel to the United States and may enter without a visa. Thus, the State Department does not have an administrative mechanism to implement the President's decision as it affects Canadians. Only the Justice Department's Immigration and Naturalization Service (INS) can do so, through its port of entry inspection process. You may wish, therefore, to consider transmitting a copy of the January 11 memorandum to the Department of Justice for appropriate action.

In view of the complexities and variety of individual cases that we are likely to confront, and assuming that the intent of the January 11 directive was not to bar indiscriminately travel to the U.S. by all aliens connected with the WPC, the Department will question all, applicants on a caseby-case basis. Salient factors will include the degree of WPC involvement and the purpose of the trip. Using those

Last year I forwarded to the President the 1981 "Program of Action" of the Helsinki-based but Moscow-sponsored "World Peace Council". As you know, this organization is the prime mover behind the international "peace" movements and demonstrations in favor of "national-liberation struggles". They brazenly publicize their activities ahead of time. On pages 6 - 16, you will find the whole plan of action which is followed by regional and organizational activities. The President was very impressed by this document last year, and I believe that he should be made aware of what Soviet mass actions against us and our Allies are being projected in the period immediately ahead. I call your attention especially to the propaganda and mass activities listed on pages 6 - 8 which are directed against our rearmament effort.

Latest "World Peace Council" Action Program

You will recall receiving last year the 1981 Program of Action of the Helsinki-based Communist Front organization, so-called the "World Peace Council". Attached (Tab A), please find the latest version of this document. On pages 6 - 8 is outlined a massive propaganda campaign against our new defense effort, with the targets precisely identified.

A large delegation from this organization, headed by its Chairman, a Mr. Chrandra, is planning on coming to the United Nations in the next few weeks. Although you have issued instructions to the Department of State to deny visas to any associate of that organization, there seems to be some problem implementing this decision when the invitation is issued by the United Nations. We are seeking to find ways to prevent World Peace Council members from reaching these shores under UN auspices.

INTRODUCTION

NEGOTIATION, NOT CONFRONTATION!

The Programme of Action of the World Peace Council for 1982 is focused naturally on the mobilisation of public opinion in all parts of the world against the grave danger of a nuclear confrontation.

The Programme covers a period which goes beyond 1982 and into 1983. It is directed through vast mass actions on a national scale, through international and regional conferences, seminars and other meetings to the world congress of all the forces working against nuclear war which will be held in Prague from June 15 to 20, 1983.

The main emphasis in the Programme is on national activities which seek cooperation and unity with the widest range of political parties, trade unions, women and youth organisations, religious circles, social and cultural bodies and outstanding personalities in all fields. A key feature of the Programme of Action is that of visits by delegations of the World Peace Council headed by the President and Vice-presidents to different countries with a view to strengthen the national movement and to take part in national events connected with the worldwide campaign against the danger of a nuclear war.

The Programme is based on the firm belief which is shared by hundreds of millions in all parts of the world, that while the danger of a nuclear war is greater than at any time before, the power of the peoples — the peace movement — is equally stronger and stronger than at any time before.

It is to the vital task of strengthening the unity and increasing the striking power of the peace movement that this entire Programme is dedicated.

The Programme of Action was formally adopted by the Bureau of the World Peace Council Presidential Committee when it met in Copenhagen from January 6 to 8, 1982. The draft Programme was circulated for 3 months before the Copenhagen meeting to all national movements and to international organisations with which the World Peace Council cooperates closely. The final Programme is thus the result of contributions

made by national organisations in almost every one of the 137 countries represented in the Council.

Each of the various events planned by the World Peace Council is a milestone on the road towards a world free of nuclear weapons.

The vast mass movement in Europe has given great strength and inspiration to all peace forces on every continent. At this moment, mass actions are directed particularly towards the 2nd Special Session of the United Nations for Disarmament which opens in New York on June 7th, 1982. The World Peace Council's conferences and meetings — on a national, regional and international scale — cover all issues which affect human beings and are planned to be held on every continent.

The World Peace Council also is cooperating with many other international organisations, with the United Nations and its specialised agencies and special committees, with non-governmental organisations, with a whole variety of national mass movements to organise dialogues and discussions on all the key issues of our times.

The running thread of this entire programme is the determination of the peoples to ensure successful and effective negotiations and political solutions. The Programme is of actions and events which are directed against the policy of confrontation, of aggravating international relations, of attempting to weaken the process of detente.

A nuclear war is not inevitable, it can be stopped, it must be stopped! The peoples have the power to ensure peace for all time and to build a new world from which hunger and poverty, oppression and aggression have been banished forever.

PROGRAMME OF ACTION

I. WORLD CONGRESS

Prague, Czechoslovakia (June 15-20, 1983)

- II. MEETINGS OF THE LEADING AND OTHER BODIES OF THE MOVEMENT
- i. Session of the Presidential Committee:

The Presidential Committee will meet in November 1982.

ii. Session of the Bureau of the Presidential Committee

There will be two sessions of the Bureau of the Presidential Committee during 1982.

The first session will be held in January in Copenhagen, Denmark. The second session will be held in mid-1982.

In addition, international developments may require the calling of an emergency meeting of the Bureau on a specific issue.

iii. Meetings of WPC Standing Commissions

WPC Standing Commissions will meet during the session of the Presidential Committee and in connection with events dealing with issues and problems related to the work of the Commissions.

iv. Continental and Regional Meetings of Representatives of National Movements

Continental and regional meetings will be held in 1983.

v. Meetings of Members of the WPC in Each Country

Regular meetings of members of the WPC from each country will be organised by each national peace movement to discuss the work of the World Peace Council, and the resolutions and statements of the Council.

III. STRENGTHENING AND BROADENING OF NATIONAL MOVEMENTS FOR A WORLDWIDE NETWORK OF PEACE ORGANISATIONS

The worldwide broad movement against the danger of a nuclear war and the arms build-up has laid the basis for close cooperation among peace committees and organisations at different levels - national, state and provincial, district and city. local and grass-roots.

Visits by WPC delegations to different countries will focus particular attention on strengthening the national movements and encouraging cooperation at all levels with other bodies.

IV. PREVENTING NUCLEAR WAR, ENDING THE ARMS PROMOTING DISARMAMENT AND BUILD-UP. DETENTE

A Mass Activities for the Prevention of Nuclear War:

To stop the production and deployment of, and to ban the neutron bomb and other neutron weapons.

To prevent the deployment by NATO of the U.S.

Eurostrategic weapons.

To exert the full weight of public opinion for the rapid, successful conclusion of the U.S.-Soviet negotiations on medium-range nuclear missiles and forward-based nuclear systems in Europe.

To halt the imperialist military build-up, direct and indirect intervention and aggression around the world, as in the Indian Ocean, the Gulf region, Middle East, Southern Africa, Central America and the Caribbean,

Asia and elsewhere.

To prepare for the Second Special Session of the UN General Assembly on Disarmament (Summer of 1982) and to campaign for its successful conclusion and implementation of its decisions.

To campaign for the rapid, successful conclusion of

negotiations on Strategic Arms Limitation.

To expose the myth of limited nuclear war and the notion that a nuclear war can be won. To disseminate widely information on the horrors of nuclear war.

Among the activities will be:

support of national and regional events, marches, demonstrations, marathons, car and bicycle caravans, peace ship flotillas; including Easter Marches as well as conferences, seminars, symposia, petitions, campaigns for the prevention of nuclear war, and peace relays and other initiatives of the vouth:

special enlarged Session of the Standing Commission on

Disarmament in preparation for SSD II

support of international meetings in preparation for the

UN Special Session on Disarmament;

- support of actions for mobilisation of intellectuals, parliamentarians, trade unionists, religious forces, women, scientists, physicians and artists against the war danger.
- B. Further campaigns to stop and reverse the arms build-up, against nuclear and other weapons of mass destruction, and for international security, cooperation and detente among states:
 - To prohibit all further production of nuclear and other weapons of mass destruction; to be immediately followed by rapid reduction of existing stockpiles leading to their complete elimination.

To achieve a comprehensive ban on all nuclear weapon tests.

To achieve a ban on chemical, laser, radiological and space weaponry.

To achieve a reduction in armed forces and armaments

and the disbanding of military blocs.

To broaden and achieve the full observance of the

Non-proliferation Treaty.

To realise a reduction in military budgets; and conversion of arms production and all resources to peaceful purposes.

To create nuclear weapon-free and peace zones.

To campaign for implementation of the U.N. Convention on banning especially brutal conventional weapons (including napalm, pellet bombs, phosphorous bombs, etc.).

To achieve the implementation of the decision of the First Special Session of the General Assembly of the

U.N. on Disarmament (1978).

To promote confidence-building measures.

To implement the U.N. Declaration on the Preparation

of Societies for Life in Peace.

- To campaign for negotiations on every possible level for the reduction of war danger; including the U.N. Security Council; and through the holding of the World Disarmament Conference the decisions of which would have the binding force of treaties.

poverty, hunger, starvation, disease, unemployment and inflation.

- Support regional and national seminars, conferences and other initiatives giving wide publicity to the decisions of the 6th Summit Conference of Non-aligned States (Havana).

- Cooperation and regular contacts with the Non-aligned

Movement and its Bureau.

INTRODUCTION

NEGOTIATION, NOT CONFRONTATION!

The Programme of Action of the World Peace Council for 1982 is focused naturally on the mobilisation of public opinion in all parts of the world against the grave danger of a nuclear confrontation.

The Programme covers a period which goes beyond 1982 and into 1983. It is directed through vast mass actions on a national scale, through international and regional conferences, seminars and other meetings to the world congress of all the forces working against nuclear war which will be held in Prague from June 15 to 20, 1983.

The main emphasis in the Programme is on national activities which seek cooperation and unity with the widest range of political parties, trade unions, women and youth organisations, religious circles, social and cultural bodies and outstanding personalities in all fields. A key feature of the Programme of Action is that of visits by delegations of the World Peace Council headed by the President and Vice-presidents to different countries with a view to strengthen the national movement and to take part in national events connected with the worldwide campaign against the danger of a nuclear war.

The Programme is based on the firm belief which is shared by hundreds of millions in all parts of the world, that while the danger of a nuclear war is greater than at any time before, the power of the peoples — the peace movement — is equally stronger and stronger than at any time before.

It is to the vital task of strengthening the unity and increasing the striking power of the peace movement that this entire Programme is dedicated.

The Programme of Action was formally adopted by the Bureau of the World Peace Council Presidential Committee when it met in Copenhagen from January 6 to 8, 1982. The draft Programme was circulated for 3 months before the Copenhagen meeting to all national movements and to international organisations with which the World Peace Council cooperates closely. The final Programme is thus the result of contributions

made by national organisations in almost every one of the 137 countries represented in the Council.

Each of the various events planned by the World Peace Council is a milestone on the road towards a world free of nuclear weapons.

The vast mass movement in Europe has given great strength and inspiration to all peace forces on every continent. At this moment, mass actions are directed particularly towards the 2nd Special Session of the United Nations for Disarmament which opens in New York on June 7th, 1982. The World Peace Council's conferences and meetings — on a national, regional and international scale — cover all issues which affect human beings and are planned to be held on every continent.

The World Peace Council also is cooperating with many other international organisations, with the United Nations and its specialised agencies and special committees, with non-governmental organisations, with a whole variety of national mass movements to organise dialogues and discussions on all the key issues of our times.

The running thread of this entire programme is the determination of the peoples to ensure successful and effective negotiations and political solutions. The Programme is of actions and events which are directed against the policy of confrontation, of aggravating international relations, of attempting to weaken the process of detente.

A nuclear war is not inevitable, it can be stopped, it must be stopped! The peoples have the power to ensure peace for all time and to build a new world from which hunger and poverty, oppression and aggression have been banished forever.

PROGRAMME OF ACTION

I. WORLD CONGRESS

Prague, Czechoslovakia (June 15-20, 1983)

- II. MEETINGS OF THE LEADING AND OTHER BODIES OF THE MOVEMENT
- i. Session of the Presidential Committee:

The Presidential Committee will meet in November 1982.

ii. Session of the Bureau of the Presidential Committee

There will be two sessions of the Bureau of the Presidential Committee during 1982.

The first session will be held in January in Copenhagen, Denmark. The second session will be held in mid-1982.

In addition, international developments may require the calling of an emergency meeting of the Bureau on a specific issue.

iii. Meetings of WPC Standing Commissions

WPC Standing Commissions will meet during the session of the Presidential Committee and in connection with events dealing with issues and problems related to the work of the Commissions.

iv. Continental and Regional Meetings of Representatives of National Movements

Continental and regional meetings will be held in 1983.

v. Meetings of Members of the WPC in Each Country

Regular meetings of members of the WPC from each country will be organised by each national peace movement to discuss the work of the World Peace Council, and the resolutions and statements of the Council.

III. STRENGTHENING AND BROADENING OF NATIONAL MOVEMENTS FOR A WORLDWIDE NETWORK OF PEACE ORGANISATIONS

The worldwide broad movement against the danger of a nuclear war and the arms build-up has laid the basis for close cooperation among peace committees and organisations at different levels — national, state and provincial, district and city, local and grass-roots.

Visits by WPC delegations to different countries will focus particular attention on strengthening the national movements and encouraging cooperation at all levels with other bodies.

IV. PREVENTING NUCLEAR WAR, ENDING THE ARMS BUILD-UP, PROMOTING DISARMAMENT AND DETENTE

A. Mass Activities for the Prevention of Nuclear War:

 To stop the production and deployment of, and to ban the neutron bomb and other neutron weapons.

- To prevent the deployment by NATO of the U.S.

Eurostrategic weapons.

To exert the full weight of public opinion for the rapid, successful conclusion of the U.S.-Soviet negotiations on medium-range nuclear missiles and forward-based nuclear systems in Europe.

To halt the imperialist military build-up, direct and indirect intervention and aggression around the world, as in the Indian Ocean, the Gulf region, Middle East, Southern Africa, Central America and the Caribbean,

Asia and elsewhere.

To prepare for the Second Special Session of the UN General Assembly on Disarmament (Summer of 1982) and to campaign for its successful conclusion and

implementation of its decisions.

- To campaign for the rapid, successful conclusion of

negotiations on Strategic Arms Limitation.

 To expose the myth of limited nuclear war and the notion that a nuclear war can be won. To disseminate widely information on the horrors of nuclear war.

- Among the activities will be:

support of national and regional events, marches, demonstrations, marathons, car and bicycle caravans, peace ship flotillas; including Easter Marches as well as conferences, seminars, symposia, petitions, campaigns

for the prevention of nuclear war, and peace relays and other initiatives of the youth;

special enlarged Session of the Standing Commission on

Disarmament in preparation for SSD II

support of international meetings in preparation for the

UN Special Session on Disarmament;

- support of actions for mobilisation of intellectuals, parliamentarians, trade unionists, religious forces, women, scientists, physicians and artists against the war danger.
- B. Further campaigns to stop and reverse the arms build-up, against nuclear and other weapons of mass destruction, and for international security, cooperation and detente among states:
 - To prohibit all further production of nuclear and other weapons of mass destruction; to be immediately followed by rapid reduction of existing stockpiles leading to their complete elimination.
 - To achieve a comprehensive ban on all nuclear weapon tests.
 - To achieve a ban on chemical, laser, radiological and space weaponry.
 - To achieve a reduction in armed forces and armaments and the disbanding of military blocs.
 - To broaden and achieve the full observance of the Non-proliferation Treaty.
 - To realise a reduction in military budgets; and conversion of arms production and all resources to peaceful purposes.

- To create nuclear weapon-free and peace zones.

- To campaign for implementation of the U.N. Convention on banning especially brutal conventional weapons (including napalm, pellet bombs, phosphorous bombs, etc.).
- To achieve the implementation of the decision of the First Special Session of the General Assembly of the U.N. on Disarmament (1978).

To promote confidence-building measures.

- To implement the U.N. Declaration on the Preparation

of Societies for Life in Peace.

- To campaign for negotiations on every possible level for the reduction of war danger; including the U.N. Security Council; and through the holding of the World Disarmament Conference the decisions of which would have the binding force of treaties.
- To widely expose the arms build-up as a major cause of

poverty, hunger, starvation, disease, unemployment and inflation.

To promote extensive education on the role of the TNCs' drive for profits from arms production as the major cause of the arms build-up and war danger.

To participate in the Conference on World Public Opinion and the SSD to be organised by the Geneva NGO Special Committee on Disarmament (Geneva. March 31 to April 2, 1982).

To participate in the World Conference of Intellectuals

against Nuclear War.

C. Intensify mobilisation of public opinion to ensure success for the work of the U.N. bodies:

The U.N. Disarmament Commission, U.N. Committee on Disarmament and the U.N. Centre for Disarmament.

- Mobilise world public opinion for the implementation by governments of the decisions of the UNESCO World Congress on Disarmament Education (1980).

D. Increase cooperation with:

NGOs, the NGO Special Committee on Disarmament and the Ad Hoc Liaison Group on Disarmament.

All mass movements and organisations working for

disarmament.

The International Liaison Forum, particularly in the holding of the International Conference - Dialogue for Disarmament and Detente - The Vienna Dialogue (January 29 - February 1, 1982).

Mass actions for the observance of:

Week of Action (August 6-13) for the Banning of Nuclear Weapons and Solidarity with the Hibakushas including Hiroshima Day (August 6).

World Peace Day (September 1).

U.N. Disarmament Week (October 24-31).

International Women's Day (March 8) as a day of Women's Actions for peace and disarmament.

International Day of Action of Women for Peace

(October 25).

V. ACTIONS FOR SECURITY AND COOPERATION IN EUROPE AND IN SUPPORT OF THE HELSINKI FINAL ACT

Further intensification of actions against the danger of nuclear war and the deployment of new U.S. weapons of mass destruction in Western Europe, for immediate concrete and constructive negotiations on stopping the arms build-up and for disarmament.

Support for the convening of a conference on military

detente and disarmament in Europe.

Support for effective steps to bring about a successful conclusion of the Vienna talks on mutual reduction of troops and armaments in Central Europe.

Actions on national and international levels for the establishment of a Nordic nuclear-weapon-free zone (Kekkonen proposal); and in other European regions.

Support for campaigns and events against imperialist military build-up (nuclearisation, military bases, etc.) in the Mediterranean.

Further actions for the implementation of all provisions of

the Helsinki Final Act.

Actions against a new cold war atmosphere, against the so-called "feasibility of a limited nuclear war", against fascist and racist activities and groupings wherever they appear.

National events (demonstrations, seminars, colloquia, etc.) with international participation "against nuclear arms build-up and the deployment of U.S. missiles in Europe; for

peace and detente in Europe".

Observance of the Week of Action for European Security

and Cooperation (May 3-9, 1982).

- International meeting of mayors and elected representatives (city councillors, municipalities, etc.) and of peace forces from European towns and regions where new U.S. nuclear missiles are to be deployed and from towns which suffered heavily from devastation during World War II.
- VI. ACTIVITIES FOR DEVELOPMENT, ECONOMIC INDE-PENDENCE. SOCIAL PROGRESS AND THE ESTABLISH-MENT OF A NEW INTERNATIONAL ECONOMIC ORDER

Launch campaigns:

in support of the demands of developing countries for equitable economic and trade relations and for the establishment of a New International Economic Order;

- in defence of the economic independence of developing countries and against imperialist economic pressure, such as the use of loans and economic aid as means of pressure and blackmail;
- against the plundering practices of imperialist powers and the TNCs:
- · in support of efforts to combat famine, desertification, etc.
- Organise an international conference on "The War Danger and the New International Economic Order".
- Devote special attention to problems of energy and development.
- Encourage the setting up by national peace committees of special groups on development.
- Support national events on development problems.
- Strengthen cooperation with U.N. bodies, intergovernmental organisations and non-governmental organisations concerned with development in particular UNCTAD, UNIDO, ILO, FAO and with the Non-aligned Movement, OAU, OPEC, OAPEC and others.
- Observe World Food Day (October 16).
- Continue cooperation with the Hungarian Peace Council in the production of the WPC journal "Development and Peace".

VII. STRUGGLE AGAINST THE DAMAGING ACTIVITIES OF TRANSNATIONAL CORPORATIONS (TNCs)

- Support national and regional activities exposing the damaging activities of TNCs nationally and internationally: the dangerous role they play in the political, social, economic, financial, trade, mass media and human rights fields; in promoting militarism, military build-up and the arms race; as well as in preventing the establishment of a NIEO.
- Campaign about the TNCs' role in support of the racist regime in South Africa and other reactionary and unpopular forces and governments in the developing world.
- Campaign against activities of the TNCs that worsen the living standard and retard social progress in the countries of origin and in developing countries.
- Cooperate with the U.N. Centre on TNCs and other relevant institutions.
- Promote activities in cooperation with the Special NGO Committee on TNCs.

VIII. ACTIVITIES IN SUPPORT OF THE CONTRIBUTION OF THE MOVEMENT OF THE NON-ALIGNED COUNTRIES TO PEACE AND INDEPENDENCE

- Launch campaigns in support of the Movement of the Non-aligned Countries and its struggle for peace and disarmament, for national independence, justice and social progress, against imperialism, colonialism, neo-colonialism and racism.
- Mobilise public opinion to give fullest support to the Movement of the Non-aligned Countries in their struggle for the establishment of a New International Economic Order and for the economic demands and proposals which the Movement has presented to the XXXIV Session of the General Assembly of the United Nations.
- Give wide publicity to the decisions of the Non-aligned Summits.
- Support regional and national seminars, conferences and other initiatives giving wide publicity to the decisions of the 6th Summit Conference of Non-aligned States (Havana).
- Cooperation and regular contacts with the Non-aligned Movement and its Bureau.
- Observe the International Solidarity Week in support of the Movement of Non-aligned Countries (September).

IX. ACTIONS AGAINST THE IMPERIALIST POLICY OF DESTABILISATION

- Draw attention to the question of the imperialist arms build-up and the policy of destabilisation, and their interconnection.
- Launch campaigns against the policy of destabilisation.
- Highlight the question of the impact of the policy of destabilisation of the struggle for national independence particularly in the Middle East, Africa, Latin America and the Caribbean.
- Seek the possibility of holding national events in countries threatened by the imperialist policy of destabilisation.

X. ACTIONS FOR PEACE AND SECURITY IN ASIA AND OCEANIA

- Organise an International Conference on the Indian Ocean: Zone of Peace (New Delhi, April 23-25, 1982).

- Organise an international conference in Kabul, Afghanistan.
- Launch campaigns of solidarity with Viet Nam, Laos and Kampuchea.
- Launch a campaign against the conspiracies of the Washington-Peking-Tokyo axis for the destabilisation of countries in Asia.
- Launch a campaign of solidarity with the people of Korea and observance of the International Month of Solidarity with the Korean People (June 25 – July 27).
- Observe Indian Ocean and Gulf Week For a Zone of Peace in the Indian Ocean and the Gulf, and for dismantling the imperialist military bases and ending the massive arms-build-up by U.S. imperialism in the region. (February 16-23).
- Observe Asia Week (April 5–12).
- Launch an international campaign for the withdrawal of U.S. troops from Asia, and the dissolution of military alliances in Asia, such as the U.S.-Japan military alliance, ANZUS and SEATO.
- Observe the anniversary of the Kwangju Massacre in South Korea (May 17).
- XI. ACTIONS IN SUPPORT OF THE STRUGGLES OF THE AFRICAN PEOPLES FOR PEACE, IN DEFENCE OF THEIR NATIONAL SOVEREIGNTY, FOR NATIONAL LIBERATION AND ECONOMIC INDEPENDENCE
- Holding of an international seminar on African problems.

WORLD PEACE COUNCIL: INSTRUMENT April 1982 OF SOVIET FOREIGN POLICY

The World Peace Council (WPC) was founded in 1949 as the World Committee of Partisans for Peace and first adopted its present title in It was based in Paris until 1951 when it was expelled for what the French Government termed "fifth column activities." It moved to Prague and then in 1954 to Vienna, where it remained until banned in 1957 by the Austrian Interior Minister for "activities directed against the Austrian state." However, it continued to operate in Vienna under the legal cover of the newly established International Institute for Peace until its move to its present location in Helsinki in 1968. The International Institute for Peace subsequently emerged as a separate Soviet front with strong links to the WPC.

In recent years, the WPC has expanded its activities while trying to broaden its appeal and sound less like a cold war propaganda It has sought support in vehicle. the Third World by posing as an independent body identifying with such causes as opposition to U.S. "aggression" in Vietnam, anticolonialism, and assistance to "liberation movements." In NATO countries, it has exploited fears of nuclear war by stimulating and/or sponsoring antinuclear rallies and advocating Soviet-supported disarmament policies.

The WPC and similar fronts periodically have faced internal problems because their Soviet affilia-

tion cannot always be reconciled with the desired image of independence and nonalignment. In 1949, following the expulsion of Yugoslavia from the Cominform, the WPC expelled its Yugoslav representatives. Similarly, the Sino-Soviet dispute led to the WPC's ostracism of China, which later became a major critic of all Soviet fronts. Nikita Khrushchev's revelations of Stalinist excesses at the 20th Soviet Communist Party Congress in February 1956 and the suppression of the Hungarian uprising by Soviet troops the following November cost the fronts considerable popular support. After the Sovietled invasion of Czechoslovakia in August 1968, Moscow, in order to restore discipline, replaced nearly all major Communist-front officials. Although opposition to Soviet control occasionally occurs within the WPC, the leaders are usually able to confine dissent to private meetings of commissions or subcommissions. Dissenting views seldom find their way into the large-scale WPC-sponsored public gatherings. When, for example, Soviet human rights activist Andre Sakharov sent a message in 1976 to a WPC-sponsored forum on disarmament in York, Great Britain, it was not read to delegates as. Sakharov had requested. At meetings in 1977, non-Communist participants embarrassed WPC leaders by asking questions about human rights violations in the U.S.S.R., but none of this found its way into the official reports. More recently,

1981), the Soviet Peace Fund helps to finance "some" of the WPC's "large public initiatives." 2 Writing in 20th Century and Peace (April 1980), Soviet Peace Fund Chairman Boris Polevoi asserted that his clients include "the leaders of the international democratic organizations working for peace: The Fund regularly gives them assistance in organizing their undertakings." Polevoi also revealed that the Fund works closely with the Soviet Peace Committee, which aims "to render financial aid to the organizations, movements and personalities fighting for stronger peace, national independence and freedom." Referring to the October 1973 World Congress of Peace Forces in Moscow, an event organized jointly by the WPC and the Soviet Peace Committee, the November 1973 issue of the WPC's Peace Courier reported that "Soviet public organizations. . . covered all the delegates' maintenance expenses in Moscow. Soviet citizens donated to the Soviet Peace Fund-which covered the delegates' maintenance expenses -- about \$200,000. Moscow's Patriarchate also donated 3 million rubles."

At a February 9-19, 1981, session of the U.N. Committee of Non-Governmental Organizations, the WPC was forced to withdraw its application for upgrading its consultative status with the U.N. Economic and Social Council (ECOSOC) in the face of adverse criticism from ECOSOC members. WPC President Chandra

said in response to questioning that the WPC's accounts were not independently audited but rather were reviewed by the WPC itself. In addition, he reported that the financial statements submitted to ECOSOC represented only a fraction of his organization's actual income and expenditure. Chandra made these statements while avoiding committee questions regarding the source of WPC financial contributions. cording to the ECOSOC Report (March 16, 1981), ECOSOC members concluded that the WPC "had received large-scale financial support from government sources, and had gone to great lengths to conceal that fact from the committee."

EXTENT OF SOVIET CONTROL

In June 1981, at a Kremlin ceremony, Soviet President Leonid Brezhnev presented Chandra, WPC president since 1977, with the Order of Lenin. Citing Chandra's service to the "ideals of peace, his selflessness in the bitter struggle against the forces of militarism and aggression," Brezhnev expressed gratification that the Soviet "peace program" for the 1980s met with "full understanding" from such an "authoritative movement as the movement of peace champions" (20th Century and Peace, August This act symbolizes the importance the Soviets attach to the The Order of Lenin is one of the most prestigious Soviet awards and is presented personally by Brezhnev only on rare occasions.

Control is exercised over the WPC by the Communist Party of the Soviet Union's (CPSU) Central Committee through its International Department (ID), which is headed by Central Committee Secretary and Politburo candidate member Boris Ponomarev. The ID maintains a special branch, known as the International Social Organizations Sector, which is responsible exclusively for front organizations. The special branch falls under the general responsibility of Vitaliy Shaposhnikov, a deputy ID chief who is at the same time a member of the WPC's

The Soviet Peace Fund is a nationwide organization with the representatives scattered throughout most of the U.S.S.R.'s cities, towns, and villages. A common method by which money is collected for the Soviet Peace Fund is for individual factories, plants, and collective farms to hold a 1-day "work shift for peace." According to the Soviet publication 20th Century and Peace (December 1981), the Krasnoyarsk Peace Committee received million rubles in donations for the Soviet Peace Fund in 1981.

Chandra told a press conference in New Delhi on November 30, 1981, that the WPC was seeking a "winter offensive" in support of the "mass movement for disarmament" in Europe.

The current priority of Soviet diplomacy is to prevent INF modernization in Western Europe, and the WPC is expected to concentrate its efforts on this issue. Nevertheless, in line with its past record, the

WPC will seek to operate however Soviet foreign policy interests dictate. As Romesh Chandra put it when speaking in Moscow in 1975: "The Soviet Union invariably supports the peace movement. The World Peace Council in its turn positively reacts to all Soviet initiatives in international affairs."³

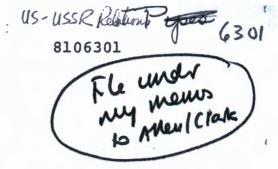

the World Peace Council intends to intensify its activities in the United States during the 1982-1983 period. As you know, this Soviet front organization has been highly successful in promoting and running the European "peace movement". If allowed to operate with impunity in this country, it could well engender a similar mass movement here, using for this purpose generous funds allocated to it by Moscow. (S)

In view of this fact, the President has concluded that visas should be refused to foreign visitors connected with the World Peace Council (its President, Romesh Chandra, among them) as well as other individuals planning to come to this country to attend World Peace Council functions. I would appreciate it if you would issue instructions to this effect to the appropriate office of the Department of State.

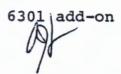

On several occasions your attention has been called to the agenda for 1981 of the so-called "World Peace Council," a Soviet front organization operating out of Helsinki. (C)

This group seems so pleased with its success that it now plans to expand its activities into the United States.

Given the great experience of the World Peace Council in organizing mass demonstrations on behalf of Soviet causes, it would be very important to prevent it from carrying out its plans in the United States. The Department of State in particular should refuse to issue visas to foreign travelers planning to attend World Peace Council functions in this country, which are usually international in scope. (6)

RECOMMENDATION

That instructions be given to the Department of State to refuse visas to foreign visitors connected with the World Peace Council or individuals planning to attend WPC functions. (C)
