For the Reagan-Gorbachev Summit:

START GIVEN HIGHER PRIORITY THAN CONVENTIONAL TALKS AS FOLLOW-ON TO INF AGREEMENT

This report is based on a USIA-commissioned personal interview survey conducted in Britain, France, the FRG, and Italy in September 1987.

START Preferred as Next Step for U.S. and USSR

By margins of two-to-one (three-to-two in France), the prevailing view in all four major West European countries is that, following an INF treaty, reductions of strategic nuclear forces rather than of U.S. and Soviet conventional forces in Central Europe would "contribute the most to the peace and security of Europe." (Table 1)

It is likely that West Europeans put the emphasis on reducing strategic nuclear weapons for two major reasons:

- o Preoccupation with Nuclear Weapons. USIA surveys over the past two decades have repeatedly shown that reducing nuclear weapons ranks first as the preferred agenda item for Summit meetings and as the most important U.S.-Soviet arms control issue.
- o Soviet Conventional Forces Not Seen as "Offensive." Despite considerable uncertainty, the publics in three of the four major West European countries (with the Italians the exception) judge that the Soviets enjoy conventional superiority in Europe. (Table 2) However, most West Europeans do not think Soviet conventional forces are intended to intimidate Western Europe; nor do they see any likelihood of a Soviet invasion. (Table 3) Furthermore, except in France, even those who regard Soviet troops in Eastern Europe as having hostile intentions prefer START over conventional reductions.

Even Defenders of Nuclear Deterrence Give START Top Priority

A majority in Britain and a large plurality in France, the two West European nuclear powers, consider nuclear weapons necessary for deterrence, while a majority in Italy and a large plurality in the FRG prefer relying only on conventional forces. (Table 4) Even among those who consider nuclear weapons necessary, large pluralities or majorities in every country give priority to a START accord.
