# Her special gift — giving friends a lift

"You know, I've got a house full of mice here," says Mary Harrington, sitting demurely in a rocking chair in her Ballston Spa home.

She leads you on for a few seconds. Then she points out a small curio cabinet across the living room. It's a mouse menagerie — packed with tiny glass, wood and cloth rodents.

Collecting images of mice is one of her habbies. Baking homemade bread is another one — one her family particularly enjoys. And writing poetry is her passion — the fruits of which many people, including the late -President John Kennedy and Pope John Paul II, have enjoyed.

Mrs. Harrington, 49, has written more than 300 poems since her high school days when she first discovered her talent for rhyme and rhythm. She storted out small, writing pieces an classmates and friends at school. Gradually, she worked her way up to poems on presidents and popes.

Recently, she received a letter from the Vatican expressing the pontiff's gratitude for one of her poems on his visit last year to the United States. Another of her works, entitled "So Deeply Moved Am I," has been set to

music and sung in Ballston Spa churches.

Mrs. Harrington writes on a variety of subjects. She's put together verses on Lonsing, her husband of 23 years, and their three children. She's done poems on sunsets and seasons. And every Christras, she sends a personal paetic greeting — rather than a commercial card—to her friends and relatives.

"I love paetry," says the former organist at St. Clement's Church, Saratoga Springs. "My father was a self-made artist and goet, but I never thought I had any talent and never wrote a line until I was in high school. The first thing I ever wrote was very simple."

It also, by the way, involved a mouse. It went: "Kittens running through the house, trying to catch a little mouse; But they never reached their gool, because the mouse jumped in his hole."

Mrs. Harrington grins now when she recites it. Her more recent output is a little more sophisticated, she suggests, os she reads a verse from her favorite, "Love Speaks to Me:"

"Love speakes to me in the laughing wind

It speaks to me so sweet and low In a robin's rhapsody."

Many of Mrs. Harringtan's poems have a religious theme. She "loves" writing poems about God, she says. And she loves reading them to patients at Sorotoga County Infirmary, where she valunteers in a religious education program. For her, it's a special ministry which grew out of what she calls a miracle in her life.

When she was four years old, she explains, she had an operation on her

ear which for some reason paratyzed her throat. When she was unable to speak after five days, her parents had a relic of St. Theresa applied to her neck. She then regained use of her

"As a result, I've dedicated my life to Christ. I asked for a ministry to serve Him and I think He's provided me that through my poetry," Mrs. Harrington said.

Another kind af ministry for her was also provided through her voice: she was a church soloist for many years and still sings occasionally in a choir. And it was her rendition of "Ave Maria" at a Christmas Mass in 1955 that first attracted the attention of the man that would later ask her to marry him.

"Lansing tells me that that night samething made him feel. I was to be his wife. He wasn't as bold as young men are today and it took him till the following November to meet me, however," according to Mrs.

Harrington.

She keeps her poems, many of which are just written on loose sheets, stuffed in a large notebook. Asked if she'd ever like to publish them, she said that she would.

"But I don't know if anybody'd buy them. What's in today is free verse and I don't write it. I always felt that a poem should rhyme. I just thought that was part of the definition," she said.

At present, Mrs. Harrington hammers out her poetic creations at on old upright Rayol she bought for \$5 from a minister.

"I thank God I have it," she said. "And I thank God for the 'liquid paper' (correction fluid) quite often, too."



# UET play somber season start

Way Home," opens the University of Evansville Theatre's 1980-1981 season this weekend on a somber note at Shanklin Theatre.

Presented to Firstnighters Friday, Tad Mosel's drama, based on James Agee's "A Death in the Family," will be repeated Saturday and Sunday and next week, Thursday through Sunday nights.

Under the capable direction of John David Lutz, its story presents a young family, just beginning to weld into a unity of soul as well as heart when it is exploded by a tragic death, against the background of another time and other social mores.

Production design by Joe Flauto effectively outlines an earlier era — Knoxville, 1915 — with a complete house and outside areas for movement. The house, with two bedrooms, stairway, parlor, kitchen and porches, is all there on the Shanklin stage, with a few solid basics complemented with ingenious suggestion.

Tom Kendall and Rebecca Klingler portray a young couple, Jay and Mary Follet, just beginning to share understanding as well as love despite opposing personalities and family pressures, and about to become parents again. Kendall's most endearing quality as Jay, in addition

to a fine physical appearance, is a fine voice which makes his habit of singing out frequently a welcome accent. Miss Klingler's Mary is thoughtful and sympathetic; she convincingly changes from a rather prim, fluttery girl, through a period of raging sorrow, and finally into a determined young matron one is sure will be sturdy enough to face the future with confidence.

John Honningford portrays their 6-year-old son, Rufus, with the aplomb of an old pro. A remarkably appealing young actor, Honningford is bedeviled by other neighborhood boys because of his name. All the boys, including Tom Buthod, David Wirthwein, Rob Zielinski and Michael Magan as the tormentors and with Daniel Seib as Rufus' cousin, Jim-Wilson, add color and zest to the mournful stories making up the body of the play.

Not only are Jay and Mary Follet tragic but their families are to be pitted as well. Adding their problems to the story are Jay's brother Ralph, well on his way to being a problem drunk; his father, John Henry, a semi-invalid following a close brush with death and his mother, Jessie, a nurse absorbed by her duties; Mary's deaf

mother, Catherine, blundering into situations and conversations.

Ralph is played with energy by John Short, who makes the character sympathetic as well as pathetic; John Henry is played by Ross Webb and his wife by Christia Stinson, a couple absorbed and isolated by their own worry, and Catherine, given to playing the piano silently, is well done by Nonie Daniels.

Most effective of all in the supporting cast (as she has been in a number of earlier UET productions) is Cheryl Heath as staunch Aunt Hannah, Mary's tower of strength in her sudden need. Hannah's shopping excursion with young Rufus is one of the high points of the play, and her vigorous presence in trouble is a source of energy to the bereaved family as it is to every scene in which Miss Heath has a part.

Other family members are portrayed by Beth North as Ralph's long-suffering wife, William Warner as Mary's father, Scott Willy as her brother, Ilene Kwitny as Jay's great-greatgrandma and Julia Fishell as an aging relative who cares for her. Dennis Ward has a small part as a priest.

A fine play for educational theater, "All the Way Home" has food for thought for almost every audience. It's a rare work, having won a Pultizer Prize as Agee's novel and both the Pulitzer and the New York Drama Critics Award as best play of 1961.







# UE dramatists in national finals 3rd time

The University of Evansville's production of "All the Way Home" has been chosen as a finalist in the American College Theatre Festival.

This is the third time a UE production has made it to the national level of the competition, held at the Kennedy Center in Washington, D.C. "The Imagi-nary Invalid" went in 1971 and "Ah, Wilderness!" was chosen in 1976.

"All the Way Home" is an adaptation by Tad Mosel of James Agee's novel, "A Death in the Family." Both novel and adaptation won the Pulitzer Prize in their respective categorie The play was presented in Evansville in October and at the regional competition in and at the regional competition in

Akron, Ohio, in January.

UE will be one of eight colleges represented at the finals, chosen from 440 entries all over the country. Although no further prizes are awarded, each production is critiqued by judges and reviewed in newspapers and profession-

The festival will be held March 30-April 18. "All the Way Home" will be performed April 6, 7 and 8 at the Terrace Theater in the Kennedy Center. Director John David Lutz says his student cast is quite excited about going to Washington, as are six boys, local grade school students between the ages of 8 and 14 who also appear in the play. Lutz said the boys' families all are planning to make the trip. to make the trip.

Of the other seven entries, five are

original plays. Oakland University of Rochester, Mich., will present "Jeri-rigg"; William Paterson College of Wayne, N.J., "Going On"; Northwestern University of Evanston, Ill., "Swan Song for a Unicorn"; the University of Iowa "House Across the Street"; and the University of Illinois "Red Peppers Plus."

The University of Nevada at Reno will present "The Private Life of the Master Race" by Bertolt Brecht and St. Michaels College of Winooski, Vt., will present "Story Theater" by Paul Sills.

The American College Theatre Festival is presented by the John F. Kenne-dy Center for the Performing Arts and the Alliance for Arts Education. It is produced by the University and College Theatre Association of the American Theatre Association and sponsored by Amoco



Dear Mr. Lloyd:

Your letter to the President in which you suggest sharing the music of America with people around the world has been referred to the International Communication Agency (USICA), which is responsible for U.S. cultural programs overseas.

We are pleased to learn of the role you have taken in promoting understanding through music with the people of Mexico. Your activity in this area is similar to the kind of international cultural exchange with which this Agency is concerned. In 1979, we completed 25 years of support for American performing artists who toured overseas under the auspices of the U.S. Government.

In view of your interest, I would like to explain briefly how our program is developed and the process by which we select individual artists and arts groups USICA will sponsor. With the help of our Cultural Affairs Officers at the American Embassies, we draw up an annual comprehensive program plan for all areas of the world. Categories are selected for each area, based on artistic qualifications, budget available, Embassv requests, and program balance. According to the terms of an Agreement signed in 1978, the National Endowment for the Arts recommends artists in each category who best meet the programming objectives of our Embassies. Our final selections are made from among those artists nominated by the Endowment.

Once again, thank you for your letter. We greatly appreciate your interest and active participation in international cultural exchange.

I am writing to tell you of an interesting activity that has been going on for the last few years that, I believe, has several positive international implications that are working for the benefit of the United States.

A few years ago; because of my travels in Latin America as a Mormon missionary, as Asst. Military Attache, Military Intelligence work and directing groups of my own students in High School international tours; I was asked by a High School band instructor to help him organize a performance Tour to Mexico. This led to several more requests and I have since taken down a fair number of school performance groups who have made real impressions on the people of Mexico.

After a choral performance arranged for by the Mexican Tourist Office and held at the Law School at the University of Mexico, one of the professors said "That group in one hour has accomplished more good for international good will and understanding than all the diplomats in the last 100 years."

We have found that music is truly an international language and that people of other nations are truly anxious to turn out to listen to well prepared, clean cut groups who are willing to sacrifice money, time and effort to share their talent and good will to promote a feeling of brotherhood and understanding between peoples.

Our own students come back not only with a great appreciation and love for others, but a deeper understanding and gratitude for what they have here at home.

Two of the groups that made an outstanding impression and consistantly performed to standing ovations were the Bellevue Community College "Celebration" from Bellevue, Washington, under the direction of Mr. Harley Brumbaugh, and the Henley High School Swing Choir from Klamath Falls, Oregon with Mr. Blaine Mack as director.

I would like to suggest that perhaps this type of program be encouraged by our own people because the thousands who listen would find it much more difficult to use the words "Ugly American" again.
