MEETING: Telecommunications Policy

We met with Bill Baxter to discuss how he wishes to proceed with the development of a telecommunications policy and the AT&T case. He indicated he was comfortable with the amendments that have been developed and given the current situation, he believes it is appropriate to begin work on an amendment to the 57 Consent Decree.

The following steps were agreed upon:

1. Bill Baxter will begin work immediately on drafting a consent decree amendment.
2. Bill Baxter will make contact with AT&T and hold an initial negotiation session. Future meetings and the timing of the negotiations will be determined by Bill Baxter as well as participation by other Administration officials. It was made clear that by embarking on this path we have not as an Administration reached any predetermined outcome and that Bill Baxter is to be the Administration's only representative in the negotiations. (i.e., Commerce is not to engage in the negotiating process.)
3. The White House will inform Commerce that they are not to be negotiating or participating in negotiations unless invited by Bill Baxter.
4. If the opportunity presents itself, the White House will inform those with an interest that Bill Baxter is our negotiator and that there is no predetermined outcome on negotiations.
5. Bill Baxter will work on developing the Exchange Access Amendment for consideration in the House.

Drew Lewis indicated that his intention is to try for a negotiated settlement with PATCO, but that he does not anticipate going beyond the \$40 million previously offered. Since Poli will probably ask for a \$550 million "compromise", the Administration should be prepared for a strike --- perhaps occurring on the 4th of August. E. Meese replied that the Administration is solidly behind Drew Lewis and that it is important to hold the line. Otherwise, other government negotiations could be adversely affected, particularly the ratification of the postal workers settlement.

D. Lewis will manifest his willingness to talk as long as necessary; if anyone leaves the bargaining table, it will be Poli. Poli will hold a press conference sometime today.

ACTION: D. Lewis will supervise negotiations with PATCO. C. Fuller and K. Cribb will monitor for the White House.

1. Dick Darman will recover a July 2 letter from Worth to the President and forward a copy to Ed Meese and Craig Fuller.
2. Bill Baxter indicated that Rodino pledged he would work to prevent any legislative delay and he took a dim view of dropping the suit.
3. Secretary Baldrige presented the results of his telephone calls to various interest groups.
4. The Senate Judiciary Committee is planning to hold a hearing on or about August 6 concerning the rationale for seeking a continuous in the AT&T suit.
5. After hearing the various arguments, Ed Meese indicated that it was his view that we should work for passage of the telecommunications legislation and in late October or early November review our options with regards to dismissing the suit. In addition we should review options for negotiating a consent decree.
6. Bill Baxter indicated that he will begin to review our options with regards to negotiating a consent decree immediately. Additionally, he indicated he would explore avenues for settling another suit which is being brought that would allow him to dismiss with prejudice the AT&T suit.

1. <u>Fairness Doctrine.</u> M. Fowler reported that Bernie Wunder had undercut him on the Hill by testifying that the Administration favored eliminating the Fairness Doctrine for radio, but not for television. E. Meese asked K. Cribb to find out why Commerce testified in this way.	KC
2. <u>Telecommunications Policy.</u> M. Fowler requested that FCC expertise in this area be tapped in future Administration deliberations on this topic. E. Meese asked K. Cribb to determine how the FCC and/or M. Fowler could have greater input in this area.	KC
3. <u>S. 898.</u> M. Fowler thinks that the "interconnection provision" is shaded too much in favor of AT&T: the provision in effect creates a new unregulated monopoly (Baby Bell). E. Meese asked M. Fowler to provide his personal views as to how S. 898 could be amended to cure this perceived defect.	MF
4. <u>FCC Appointments.</u> M. Fowler believes that the last two appointments to the FCC are loyal to their Hill sponsors rather than to the President. Accordingly, he has a very uncertain majority on the Commission. E. Meese indicated that Reagan loyalists are being considered for the upcoming slots and M. Fowler should be consulted before any such slots are filled.	EM
5. <u>Regular Contacts.</u> M. Fowler expressed an interest in establishing some form of regular communication between himself and the Administration. E. Meese replied that he was considering a proposal by which Loren Smith, as Chairman of the Administrative Conferences of the U.S., would coordinate such contacts in a way that would take account of the independent nature of the agencies. Past ABA President William R. Smith and current President David Brink sought this meeting to discuss the ABA's role in providing legal services for indigents. Mr. Smith indicated his strong support for continued funding of the Legal Services Corporation because it provides an administrative network throughout the country. Smith indicated that, in his experience, the private bar simply can't or won't provide necessary resources for meeting the legal needs of the poor.

E. Meese indicated that he would be interested in discussing a possible role for the organized bar in assisting with such legal services, independent of the disposition of legislation which would authorize the continuation of a modified Legal Services Corporation. He offered two possible approaches:

- (1) Getting younger lawyers involved in a way analogous to intern/resident programs in the medical profession.
- (2) Getting local bar associations back into providing such services.

The ABA representatives indicated they could offer a plan, but hinted that any such plan would be predicated on the continuance of the Legal Services Corporation. There was also an offer to provide ABA candidates for the Board. E. Meese indicated his willingness to accept suggestions but that the list of possible nominees for that Board is already circulating on the Hill.

E Meese was called to the Oval Office and asked K. Cribb to serve as a point of contact with Smith and Brink. It was agreed that three ABA representatives (including Messrs. Smith and Brink) would meet with three representatives from the White House (to include Cribb and Fielding) to discuss a concrete plan for ABA participation in providing legal services for the poor.

ACTION: K. Cribb will set up the above mentioned meeting for November 17.

Feds, manufacturers closer on pollution

The head of the President's Council on Environmental Quality (CEQ) sat down at the same table with a leader of the National Association of Manufacturers (NAM) in Boston yesterday and declared that the era of confrontation between environmental regulators and industry was ending.

A "non-confrontational" relationship between the administration and business is the goal of A. Alan Hill, appointed by Ronald Reagan as chairman of CEQ. The council oversees federal environmental programs and formulates environmental policies for the president.

Hill joined Richard D. Robertson, chairman of NAM's Environmental Quality Committee, at a press conference at the Colonnade Hotel, where 100 environmental experts from the private sector have gathered for a NAM-sponsored conference on environmental quality.

Robertson told reporters that the previous administration's environmental regulatory agencies had become "ad-

vocacy agencies" for environmental groups and that business had been excluded somewhat from environmental decision-making.

Hill claimed that under the Reagan administration, the council "is meeting

with everyone — business, environmental groups . . . to try to develop an understanding."

Both men acknowledged the need for environmental regulations, but Hill said they should be implemented on the local, not federal, level. Robertson, a vice-president of Phillip Morris in New York, said "a majority of industries" likely would comply with such restrictions. "There's a level of consciousness that's been raised by the environmental groups," he noted.

In a luncheon speech to the NAM gathering, Hill outlined the "philosophic foundation" of CEQ under Reagan. He listed four tenets of that philosophy:

- Mankind is part of the environment. The world is comprised of many inter-related parts, Hill said, and man should not be denied his part in the "environmental equation."

- Balance must be achieved. Hill said it isn't easy to balance nature and the social and economic needs of Americans, but he urged that individuals concerned make a good-faith effort. "A lowering of current rhetoric would be most helpful to all concerned," he added.

ADMINISTRATION OFFICIALS DISCUSS PLANS FOR INDUSTRY ROLE IN ENVIRONMENTAL POLICY

BOSTON — (By a BNA Staff Correspondent) — Three top federal officials at an Oct. 21 through 23 conference told representatives of business and industry that the Reagan administration wants to work more closely with them in developing environmental policy than have past Administrations.

A. Alan Hill, chairman of the Council on Environmental Quality, told members of the National Association of Manufacturers' (NAM) Environmental Quality Committee the Administration intends to reduce, and hopefully eliminate, "the confrontational style of environmental policy-making which was so prevalent in the 1970s."

Joseph A. Cannon, acting associate administrator for policy and resource management at the Environmental Protection Agency, said, "We don't intend to shut the environmentalists and others out of the process. We don't intend to accept your laundry list uncritically. The difference is that we expect to review your laundry list."

In his remarks to the NAM group, Hill noted the need to re-establish a balance between the goals of environmental quality and economic growth. However, he added that the Administration recognizes that economic growth cannot be made at the expense of environmental quality.

"However, there are issues, such as the primary health standard in the Clean Air Act," Hill said, "when very careful consideration must be given to assure that economics do not overpower sound judgment in arriving at the best decision for all concerned."

Hill and Cannon, along with Lester Sutton, EPA Region I administrator, also commented on the need for simplifying federal regulations.

Sutton said, "Many of our environmental regulations are too complex, too lengthy, and often totally incomprehensible. I have talked to numerous business leaders whose major complaint is that they really do not understand what the EPA expects of them."

"It's not that they don't want to cooperate," he noted. "It's just that they are confused by the cumbersome language of the regulations, overwhelmed by the number of forms to fill out, and baffled by the sometimes conflicting intents and procedures of the statutes."

Sutton indicated that EPA intends to cut back red tape. "Our goal of working for a quality environment for all Americans will not change, but our method of obtaining our objectives will change," he stated.

Cannon indicated that his office is working to attain uniformity among the regions in enforcing EPA regulations and in inspection and permitting procedures.

"We recognize there is a big problem in permitting and we will thoroughly re-analyze the consolidated permit program. It was designed to be a one-step process and has become a nonstop process," he said.

NAM Supports Administration

Richard A. Robertson, chairman of the NAM Environmental Quality Committee and vice president of Philip Morris, USA, told a press conference NAM supports the efforts of the Administration in listening to the concerns of industry.

Robertson said that during the previous Carter Administration, industry was placed in an adversary role.

"The adversary position is something we feel this administration does not want to have. The feeling of industry is that if we create a problem we certainly must be willing to correct it," Robertson stated.

He said it will be easier for industry to have a working relationship with the federal government if that relationship is handled in a "nonconfrontational manner."

In a later session, Robertson called on industry and business to openly support the efforts of EPA Administrator Anne Gorsuch in working more closely with industry, particularly when environmental groups have been so vocal in their opposition to this.

"I guess in the 20 years or more of having their ways it's not surprising how several environmental groups and their friends in Congress are reacting to this Administration's efforts to restore balance and fairness," he said.
