In a similar tragic incident in 1978 the Soviets also shot down an unarmed civilian airliner after having positively identified it as such. In that instance the Soviet interceptor pilot clearly identified the civilian markings on the side of the aircraft, repeatedly questioned the order to fire on a civilian airliner, and was ordered to shoot it down anyway.
