MAIN OBJECTIVES

1. Reaffirm the need for Guyana to take and stick to hard economic decisions that can lead to resumed growth.
2. Avoid substantive response to any GOG request for more aid, support for the Upper Mazaruni hydro scheme, or backing in their border dispute with Venezuela.

BEAR IN MIND

1. The GOG has not responded to our proposed performance-based strategy to make future U.S. aid contingent on better economic performance.
2. The GOG wants to retain high levels of U.S. aid (through bilateral and IFI channels), while taking positions at home and abroad that generally are not in our interest.
3. Our policy is to remain neutral and uninvolved in the dispute with Venezuela.
4. Jackson may ask for a bilateral between Burnham and the President, which we would not favor.

CHECKLIST

1. Stress need for Guyana to put its economic house in order.
2. Emphasize our desire to continue helping Guyana to the extent that it pursues reasonable economic policies.
3. As appropriate, stress importance of reaffirming agreement to have no agenda and no communique at the Cancun Summit. Express our hope that it will change tone of multi-lateral consultations.

BEAR IN MIND

1. Ivorian leadership is unabashedly anti-Communist and concerned about Libyan expansion in Africa.
2. Ivory Coast takes a moderate stance on southern Africa and accepts US arguments that we are doing our best to achieve an acceptable Namibian settlement.

CHECKLIST

1. Thank the Foreign Minister for the constructive and moderating role Ivorians play in Africa.
2. Say that we are serious about a Namibia settlement and will be discussing practical measures in a wider context. We hope we can count on Ivory Coast.
3. As appropriate, stress importance of reaffirming agreement to have no agenda and no communique at the Cancun Summit. Express our hope that it will change tone of multilateral consultations.

MAIN OBJECTIVES

1. Register appreciation of Japanese aid to strategic countries with hope of further programs in Caribbean.
2. Express continued interest in Japan's defense improvement.

BEAR IN MIND

1. Atmospherics of US-Japan bilateral relations and Suzuki Government's political position are strengthened after trouble-free Ottawa summit.
2. Lack of defense discussion at Ottawa was appreciated as not putting Suzuki on spot but risked signalling lessened US interest in inter-ministerial budget negotiations.
3. Japan's aid budget is reportedly hard pressed by Finance Ministry budget cutters.

CHECKLIST

1. You will see Sonoda in September at the UNGA and in October at Cancun.
2. As appropriate, stress importance of reaffirming agreement to have no agenda and no communique at the Cancun Summit. Express our hope that it will change tone of multilateral consultations.
