MAIN OBJECTIVE

1. Assure Nigeria we are committed to resolution of southern African problems.
2. Express appreciation for Nigeria's dedication to negotiated settlement of regional problems, and urge continued pressure on Libya.
3. Indicate interest in upcoming bilateral economic talks.

BEAR IN MIND

1. Nigerians consider Namibian independence their highest foreign policy priority.
2. Border dispute with Cameroon is long-standing, highly sensitive.
3. Nigeria is our second largest supplier of crude petroleum.

CHECKLIST

1. Stress importance of economic and political consultations.
2. As appropriate, stress importance of reaffirming agreement to have no agenda and no communique at the Cancun Summit. Express our hope that it will change tone of multi-lateral consultations.

MAIN OBJECTIVE

Reaffirm U.S. willingness to consult on Summit issues.

BEAR IN MIND

We have not sought a meeting with Romulo, and have no indication he wants to speak with you. He could raise (as Marcos has already) possibility of Marcos/Reagan meeting at Cancun Summit. Philippines has not discussed Summit thinking directly with us, and it appears preliminary.

CHECKLIST

- Reaffirm willingness to consult on summit. Elicit views.
- (If asked) Advise that White House is not yet scheduling bilaterals for President at Cancun.
- As appropriate, stress importance of reaffirming agreement to have no agenda and no communique at the Cancun Summit. Express our hope that it will change tone of multilateral consultations.
