1. PRESS AND RADIO REPORTS HERE EARLY SEPT 21 SAID
AIR FRANCE'S SNPL UNION PILOTS DECIDED EVENING SEPT 20
TO CONTINUE THEIR BOYCOTT OF FLIGHTS TO MOSCOW UNTIL THE
RESULTS OF AN IFALPA MEETING CURRENTLY IN PROGRESS IN
MONTREAL ARE KNOWN. THIS INFORMATION AGREES WITH
INFORMATION GIVEN TO US BY AIR FRANCE EVENING OF SEPT 20
THAT IT BELIEVED PILOTS WOULD CONTINUE BOYCOTT.

2. PILOTS' UNION SPOKESMAN, HOWEVER, TOLD US MORNING
SEPT 21 THAT PRECISE INFORMATION ON AGREEMENTS REACHED
AT SNPL MEETING LAST NIGHT IS NOT YET AVAILABLE AND
THAT PRESS REPORTS ARE CONFUSING. THEY AGREED TO LET
US KNOW DECISIONS REACHED AS SOON AS POSSIBLE THIS
MORNING.

3. AIR FRANCE REPRESENTATIVE TOLD US HIS UNDERSTANDING
OF SNPL DECISION IS THAT THE BOYCOTT WILL CONTINUE
AT LEAST FOR THE SHORT-TERM. HE SAID AIR FRANCE'S
POLICY IS TO CONTINUE TO TRY TO OPERATE ITS FLIGHTS TO
MOSCOW. THE GOF WANTS THE FLIGHTS TO CONTINUE.
THEREFORE, IF POSSIBLE, AIR FRANCE WILL OPERATE THEM.
HOWEVER, HE NOTED THAT IT HAS BEEN PROVING ALMOST
IMPOSSIBLE TO OBTAIN CREWS WILLING AND ABLE TO TAKE
