Dear Ron:

Never before has it been so urgent and so necessary to help the countries of the Third World, with the gap between rich and poor countries constantly growing wider.

As their resources diminish, in particular as a result of the drop in the prices of raw materials, as they face famine, epidemics, and natural disasters, and as extreme poverty increases in Africa, Latin America, and many regions of Asia, the poorest developing countries are and will be unable to repay in full the loans from developed countries under the conditions imposed on them today.

We can no longer allow a situation in which financial transfers from the South to the North exceed by close to \$30 billion the transfers in the opposite direction, with repayments outweighing new credits.

During the summit in Venice, we recognized the need to create a special program for the poorest countries that have undertaken "adjustment" efforts. We agreed to seek an agreement to extend the payback period and this was done. Conversely, we have made no progress in terms of applying lower

interest rates for debt consolidations.

In order to overcome the current impasse, I propose to make the payback terms of the poorest countries more flexible, such countries being defined according to the same criteria we established during the Venice summit, allowing the creditor countries the choice of proposing to them one of the three following alternatives:

- immediate cancellation of one-third of the debt, within the context of consolidation agreements over a period of about ten years;

- debt consolidation at market rates, but with a maximum period of 25 years (instead of the maximum of 20 years today);

- debt consolidation at a preferential rate, reduced by at least half, with a reimbursement period of about 15 years.

I hope that this proposal will meet with your approval and that of all the other Heads of State and Government participating in the next summit in Toronto.

I can tell you already that France is planning for its part to offer, in any case, to cancel one-third of the debts of all debtors concerned that are interested. This option has the advantage of resulting in an immediate drop in the outstanding debt and seems to me to be the most appropriate to the situation of the poorest countries.

The intensification of action intended to benefit the poorest countries obviously does not mean that we should relax our effort in favor of so-called "middle-income" countries that are often heavily in debt.

We must show more imagination and be more realistic, for example by expanding the scope of public debt consolidations to include interest maturities if necessary. The mobilization of new resources and the recourse to new financial instruments, inspired by market techniques, must be encouraged for bank claims. Finally, it is essential to implement more rapidly the recent multilateral decisions reached in the area of government aid to development. An example that comes to mind is the increase of capital of the World Bank.

I am looking forward, Mr. President, to discussing all these issues with you in Toronto and renew to you the assurances of my high consideration and warm regards.

" Monsieur le Président, Cher Ron,

Jamais il n'a été aussi urgent et aussi nécessaire d'agir pour aider les pays du Tiers Monde, le fossé ne cessant de s'élargir entre pays riches et pays pauvres.

Alors que diminuent leurs ressources, en raison notamment de la chute du cours des matières premières, alors qu'ils ont à affronter famines, épidémies, fléaux naturels et que l'extrême pauvreté croît en Afrique, en Amérique-Latine et dans de nombreuses régions d'Asie, les pays en développement les plus pauvres ne sont pas, et ne seront pas, en mesure de rembourser aux pays développés l'intégralité de leurs dettes, selon les conditions qui leur sont aujourd'hui imposées.

Nous ne pouvons plus admettre une situation où les transferts financiers du sud vers le nord excèdent de près de 30 milliards de dollars les transferts inverses, le poids des remboursements l'emportant sur les crédits nouveaux.

Lors du sommet de Venise, nous avons reconnu la nécessité d'un programme spécial en faveur des pays les plus pauvres qui ont entrepris des efforts "d'ajustement". Nous étions convenus de rechercher un accord sur un allongement des périodes de remboursement cela a été fait. Nous n'avons pas en revanche progressé dans l'application de taux d'intérêts plus bas pour les consolidations de dette.

Pour sortir de l'impasse actuelle, je propose donc d'assouplir les conditions de remboursement des pays les plus pauvres, définis selon les mêmes critères que nous avons arrêtés lors du sommet de Venise, en laissant le choix aux pays créanciers de leur proposer l'une des trois possibilités suivantes :

- une annulation immédiate du tiers de la dette, dans le cadre d'accords de consolidation portant sur une période de l'ordre de 10 ans ;

- une consolidation de la dette aux taux du marché, mais avec une durée maximale de 25 ans (au lieu de 20 ans au plus aujourd'hui) ;

- une consolidation de la dette à un taux préférentiel, réduit au moins de moitié sur une durée de remboursement de l'ordre de 15 ans.

Je souhaite que cette proposition puisse rencontrer votre approbation et celle de tous les autres Chefs d'Etat et de Gouvernement participant au prochain sommet de Toronto.

Je vous indique d'ores-et-déjà que la France entend pour ce qui la concerne offrir, en tout état de cause, à tous les débiteurs concernés qui le voudraient, d'annuler le tiers de ses créances. Cette option présente l'avantage d'entraîner une baisse immédiate de l'encours de la dette me paraît la mieux adaptée à la situation des pays les plus pauvres.

L'intensification de l'action menée au bénéfice des pays les plus démunis ne signifie évidemment pas pour autant que nous devrions relâcher notre effort en faveur des pays dits "à revenu intermédiaire" qui sont souvent lourdement endettés.

Il faut faire preuve de plus d'imagination, et de réalisme, par exemple en élargissant le champ des consolidations des créances publiques, étendu si nécessaire aux échéances d'intérêts. La mobilisation de ressources nouvelles et le recours à de nouveaux instruments financiers, s'inspirant des techniques de marché, doivent être encouragés pour les créances bancaires. Enfin, il est indispensable de mettre en oeuvre plus rapidement les décisions multilatérales récentes, je pense par exemple à l'augmentation du capital de la Banque Mondiale, prises en matière d'aide publique au développement.

Je me réjouis, Monsieur le Président, de pouvoir discuter avec vous de toutes ces questions à Toronto et je vous prie de croire à l'assurance de ma haute considération et de mes fidèles sentiments.

Japan Concerning Their Bilateral Discussions in Toronto
Last Week

As you know, an agenda of bilateral issues was developed for discussions between the President and the Prime Minister of Japan that occurred in Toronto last week. We understand that a scheduling mix-up shortened the time allotted for these discussions and prevented the President from addressing the issues on his prepared agenda.

We have suggested, and Jim Baker concurs, that an appropriate way to follow-up these bilateral discussions would be for the President to send a letter to the Prime Minister of Japan setting forth the points that he would have made during their talks had the scheduling mix-up not occurred.

One of the issues that appeared on the President's agenda concerned the export of Alaska natural gas. John Herrington apparently requested that this topic be raised during the bilateral discussions, and we also discussed this possibility at Treasury (I enclose some draft Presidential comments that were previously submitted to Jim Baker on this subject).

In January of this year, the President issued a finding under the Natural Gas Act which removed one of the last important regulatory hurdles for the export of Alaskan natural gas. In recent weeks, the Department of Interior has completed the environmental review required for the commercial development and export of this important resource. The purpose of raising this matter with the Prime Minister is to request renewed cooperation with the United States and its private industry in mutual efforts concerning natural gas export.

We are hopeful that the comments which the President was prepared to make to the Prime Minister on this and other important issues may now be communicated by letter from the President to the Prime Minister of Japan. I would appreciate the opportunity to discuss this matter with you at your earliest convenience.

Presidential Comments at Bilateral Economic Consultations
With Prime Minister of Japan
Toronto, Canada
June 19-21

On November 11, 1983, our two countries issued a "Joint Policy Statement on Japan-U.S. Energy Cooperation." In that Statement, we agreed to pursue "further progress" in energy trade and cooperation between our two countries. We also agreed "that the sound expansion of U.S.-Japan energy trade will contribute to the further development of the close economic and energy security relationship which exists between the two countries".

In our Joint Policy Statement, we recognized that Alaska was a "particularly promising area for joint development of energy resources." We therefore agreed to

encourage private industry in both countries to undertake now the pre-feasibility or feasibility studies necessary to determine the extent to which Alaska natural gas can be jointly developed by U.S. and Japanese interests.

Thereafter, private industry in our two countries undertook the pre-feasibility studies contemplated by this Joint Statement. These studies indicated significant future demand for natural gas in Japan and enhanced prospects for further progress on energy trade as envisioned in our Joint Statement.

In a Presidential finding issued January 12, 1988, I authorized the exportation of Alaskan natural gas to Japan and elsewhere by any private party that develops this resource. In so doing, I removed all regulatory impediments to the exportation of Alaska's natural gas resources. On the following day, at our discussions on January 13, 1988, you and I reaffirmed the spirit of the 1983 U.S.-Japan Joint Policy Statement On Energy Cooperation.

In pursuit of these important understandings, we must now encourage private industry in both countries to intensify their discussions concerning Alaskan natural gas. I can assure you that private industry in the United States is prepared to move forward with these discussions on the basis of marketplace competitiveness and flexibility.

I am transmitting the attached talking points to you for the President's meeting with Japan's Prime Minister Takeshita at the Toronto Summit. These talking points address the importance we attach to the Japanese making a commitment to purchase our natural gas resources from Alaska.

SUGGESTED TALKING POINTS FOR THE MEETING WITH
PRIME MINISTER TAKESHITA

- As you know in January of this year we reaffirmed the 1983 Joint Policy Statement which encourages enhanced energy trade and cooperation between our two countries. What is important is that we both recognize that energy trade is mutually beneficial on an economic basis and from an energy security aspect.

- One result of the Joint Policy Statement is the joint study that was done by private entities in Japan and the United States on development and export of Alaska North Slope gas. The study did identify potential export markets for this gas in the Far East.

- In January 1988, in my commitment to increasing energy trade and cooperation between our countries, I issued a finding which removed a government obstacle to the export of this gas.

- I urge you to encourage your private industry to confirm its future demand for natural gas. Your companies' consideration of reserving 20^{-25%} percent of its market for United States natural gas by the year 2000, would be viewed as a very positive step in carrying out the spirit of the Joint Policy Statement. The United States would certainly encourage its private companies to move forward on the basis of marketplace competitiveness and flexibility.
