Middletown High School Inquiries

A number of Middletown High School students in a political science course have written seeking the answers to two questions:

- 1. Who becomes President if the President elect dies immediately prior to taking the oath of office?
- 2. What would happen if the United States were attacked shortly before the swearing in of the President elect? Would the incumbent handle the crisis or would the President elect?

The first question is answered by the Twentieth Amendment.
That amendment provides, in pertinent part:

If, at the time fixed for the beginning of the term of the President, the President elect shall have died, the Vice President elect shall become President. U.S. CONST. amend. XX, § 3.

The answer to the second question is also easy, at least as the question is posed. The incumbent acts as President until January 20 at noon, at which point the President elect should take the oath and assume the responsibilities of office. Presumably the two would work closely together in confronting an Inauguration Day attack on the country, but final authority and responsibility for decisions would shift as of noon.

The second question may assume some difficulty in proceeding with the Inauguration ceremony. Article II, Section 1, Clause 8 of the Constitution directs that the President take the prescribed oath "[b]efore he enter on the Execution of his Office." It only takes about ten seconds to take the oath, however, and there is no constitutional significance to the inaugural ceremony beyond the taking of the oath. Our response to the students should point out that there would be no need to proceed with the ceremony in the event of a national emergency.

Draft responses are attached for your review. Some students asked both questions, others just one, and the responses vary accordingly. I have also prepared an unsolicited response for the teacher who posed the questions to the class. I do not know if he told the students to write us or to do research themselves. If the latter is the case the teacher should know that some of the students have taken a shortcut. This may not seem particularly sporting to our correspondents, but I think it important to squelch the "let's ask the Counsel's office" impulse that has afflicted the younger generation before it gets out of hand.

Incidentally, I consider this project to have satisfied my obligations under the "Adopt a School" program. I've simply "adopted" the Middletown High School political science class rather than a class at Congress Heights.




