SUBJECT: Administrative Support for the Queen's Visit

In accordance with the request from the White House, the Department of State, Bureau of Administration, has agreed to support the official visit of Queen Elizabeth II to the United States and the trip to the West Coast of the President and Mrs. Reagan in conjunction with this visit. This means that certain expenses and areas of logistical support will be covered by the Bureau of Administration, and the same structure for achieving this support will exist as if this were an overseas trip by the President.

However, unlike most foreign trips, the Bureau of Administration will not have a representative in advance at all stops on the Queen's itinerary. Consequently, much responsibility will rest on the lead White House advance man at each stop to minimize the expenditure of government funds and to insure that maximum value is received when government funds are expended. Only White House lead advance men in each city are authorized to expend government funds. Furthermore, these funds can be expended only after specific authorization is received from one of the three Bureau administrative coordinators assigned to support the trip: Jeannie Bull, Lead State Department Coordinator, Lynwood Dent, Administrative Coordinator for the West Coast (based in the Los Angeles Century Plaza Hotel Coordinating Center), and Jim Walsh, Administrative Coordinator for San Francisco.

Below are outlined some specific administrative arrangements which have been made in advance.

Hotels: Hotels have been identified and rooms blocked in each city. The advance team should work closely with Jeannie Bull to insure that only those rooms actually needed are reserved.

Offices: Offices have been blocked in the hotel in each city. Typewriters, duplicating machines, and expendible office supplies have been arranged either through the city, GSA, or another government agency.

Telephones: Private business lines have been ordered for each office. These telephones are for official calls only. Personal calls should not be made in the office, and are properly chargeable to the individual's bills. All long distance calls should be made through the FTS system. Please contact Lynwood Dent in Los Angeles for the State Department access code into the FTS system. This will allow all long distance calls to be charged to the Department of State's account in Washington.

British Government Expenses: The White House has agreed to cover at each stop the cost of six limousines and two passenger vans which will constitute the official motorcade. Also a two and a half ton baggage truck and a baggage van will be supplied to move the baggage of the Queen and the official travelling party. Furthermore, when the travelling U.S. party displaces a member of the British official party from sleeping on the yacht, the U.S. will pick up the cost of the hotel room to house the British official party member. These are the only British expenses that will be defrayed by the U.S. government. Additionally, a British office has been blocked in each hotel where the U.S. Queen's advance is operating. However, the U.S. is not financially responsible for these offices.

Personal Charges: All personal charges such as food, laundry, etc. are to be paid for out of your per diem and bills cleared before departure from the hotel. Official phone calls and taxis may be claimed on a voucher on completion of the trip. No room service charges are to be made to the staff office unless paid by the individual.

There are many issues to be resolved regarding press coverage arrangements for the visit to the United States of Queen Elizabeth II and the Duke of Edinburgh. Most of these can be resolved between Michael Shea, Charles Anson, the press advancemen and me.

However, some fundamental questions need to be addressed early on so I can give the British guidance as to what they and their press will be responsible for during the visit.

--Will the U.S. Government take the responsibility for making hotel reervations for accompanying press and if so, would this be the responsibility of the White House Transportation Office or State?

--Will the U.S. Government take the responsibility for arranging for press centers (including telephones, telex facilities) and assume costs for same?

--Will the U.S. Government take the responsibility fort arranging transportation (chartered aircraft and/or buses) for accompanying press and assume costs for same?

--Will there be any WHCA support for the visit for lighting, sound systems and telephones?

I am told by Billy Dale that when the President visited London, we (the White House and the traveling press corps) assumed costs for all of the support we required. The Buckingham Palace press guidelines suggest that the British government provides some support to visiting press, but Billy Dale advises that we weren't offered anything.

Traditionally, when the President travels, virtually all costs for press support are billed, on a pro-rata basis, to the traveling press. The arrangements are made by the Transportation Office (which handles billing) and the press advancemen.

Basically, what we need to decide is how much, if any, free support we will give to the press covering the visit and who is responsible for arrangements. If it is handled as a Presidential trip, then we would involve the Transportation Office and Advance office in their traditional roles. I would recommend, however, that Mary Masserini have a role in this visit and if you have no objection, I plan to talk with her in the next few days to learn more about what has been done in the past for visits of this kind.

The British are anxious to have us name a media coordinator for the visit, but I would recommend waiting on this until I receive the letter from Michael Shea, which I mentioned in our meeting. At my request, Michael is going to tell me what kind of staff support he hopes to have during the visit and based on that, we can sort out who will be doing what in terms of press arrangements. In the interim, I will continue to keep in touch with Charles Anson.



Pay as you go

Remember that "free rent" issue Jerry Brown had a field day with during his recent campaign against Pete Wilson for the U.S. Senate seat of Sam Hayakawa? Well, Senator-elect Wilson, wrapping up his long reign as the "Wizard of Mission Bay" and preparing to decamp from the complimentary lodging provided him by pals for more than a year and necessitated by a divorce action, has finally bitten the bullet. Wilson has rented a \$575-a-month, one-bedroom apartment just one block from the sleek, but controversial, new Hart Senate Office Building on Capitol Hill. No immediate word on whether "Free-Rent" Pete got stuck with first and last month, plus a cleaning deposit. The new solon, who will open a Sacramento field office - something that neither Hayakawa nor senior Sen. Alan Cranston ever did - did take a look at Sam the Tam's home in Washington, But it was already sold. As one of his first acts besides renting a pad, Wilson hired a new office manager, named Bobble Donno. She occupied the same position for years with resigned Sen. Harrison Williams, D.New Jersey, of Abscam infamy. Hard-line conservatives in the capital expressed outrage that, with all the available talent around, Wilson would find it necessary to recruit an ex-Democratic staffer, But Otto Bos, Wilson's press aide, defended the choice, saying that Donno was also sought by Democratic Senator-elect Frank Lautenberg, Williams' elected successor, "The decision was made on the basis of competence, nothing else," said Bos about the outburst from right-wingers.

Donkey parade

The California Democratic Party's biennial convention in Sacramento on Jan. 14-16 will take on a national flavor 18 months before a presidential nominee is selected in July 1984. The so-called "cattle call" became an instant media event with confirmation over the weekend that former Vice President Walter Mondale, Sens. John Glenn, Gary Hart and Alan Cranston, and Rep. Morris Udall will attend. Other strong possibilities include Sen. Ernest Hollings and former Florida Gov. Reubin Askew. By contrast, the California Republican Party's convention in the capital at month's end lacks any big media pull. Outgoing state chairman Tirso del Junco of Pasadena and new party chief Ed Reinecke of Sacramento will be in Washington for the annual meeting of the Republican National Committee and

will have to jet back early from the coronation of Sen. Paul Laxalt, Reagan's pal, as the new RNC general chairman. As of now, no national GOP big names are booked, although Pete Wilson and George Deukmejian, the new party elected heavyweights, are scheduled for talks.

Sideshow

Lame-duck Rep. Pete McCloskey, R-Palo Alto, has remained a GOP maverick until the end. The unsuccessful U.S. Senate candidate who still managed to get a rather astonishing 26 percent of the June primary vote to finish ahead of another lame duck, Barry Goldwater Jr., was the only California Republican congressman to buck Reagan in the House and vote against MX missile Speaker Wille Brown surprised some by naming freshman Assemblymen Tom Hayden of West Los Angeles as vice chairman of the Revenue and Taxation Committee ... Temple Street gnomes see chief Deputy Attorney General Robert Philibosian and U.S. Attorney Stephen Trott as the two major finalists whom Los Angeles County supervisors will zero in on when a Dec. 21 vote is taken for the post of district attorney to succeed Attorney General-elect John Van de Kamp. A third Republican, former Assemblyman David Stirling, still looks like a runner-up in the morning line: . . Nearby, Sixel Street gnomes rank Ted Bruinsma, who is coordinator of Governorelect George Deukmejian's transition appointments operation, as the top choice to become Dr. William Banowsky's replacement as president of the Greater Los Angeles Chamber of Commerce. Bruinsma, former Loyola Law-School dean and an unsuccessful, but impressive, candidate for the GOP U.S. Senate nomination this year, has close ties to at least half the Chamber's directors. Despite a full court press for the powerful post, the chances of lameduck GOP Congressmann John Rousselot are rated poor . . . The two nominees that Jerry Brown may have the most trouble getting confirmed when the state Senate convenes on Dec. 20 are Don Vial, state director of Industrial Relations, and Dan Richards, the governor's deputy legal affairs secretary. The big seats they have been tapped to fill are on the Public Utilities Commission . . . Speaking of Brown, small signs about the end of his eight-year reign are beginning to appear. For example, painters started spraying the ceiling of the governor's office over the weekend to prepare it for new tenant George Deukmejian, set to move in Jan. 3 . . . Fran Tarkenton, the TV personality and former pro quarterback, allowed to owner Frank Casado at Lucy's El Adobe, the political hangout on Melrose. during a holiday party that he might run for public office in Georgia one of these years.

I've heard that the San Diego Zoo, quite rightly, has been considered as a probable visit on the Royal couple's schedule in San Diego, and I should like to recommend a client of ours, Sea World of San Diego, as another visit there for the royal couple. I don't know whether you and Ron have visited there or not, but it's truly a fascinating and most commendable institution, of which we Californians can be most proud. I feel sure that the Queen and the Duke of Edinburgh would thoroughly enjoy a visit there, not only for the vast number of marine specimens on display, but also because of the great research being conducted there for the preservation of marine life.

Sea World of San Diego is the home of an important marine research foundation, as such, show business and science serve each other in a complex but effective relationship: revenues from the park finance scientific research on a variety of marine topics, and the training procedures involved in the creation of the shows are themselves creating new understanding of marine mammals and inter-species communications.

Currently under construction in the park is a unique new facility that will be far and away the world's largest Antarctic environment, one that will be populated eventually by some 600 penguins of half a dozen species, including the magnificent Emperor Penguins. The installation caps years of research into

these birds, some of which are on the world endangered list, and Sea World is now the only place on earth in which several species of penguins are bred in captivity.

Finally, Sea World's biggest "star," Shamu the Killer Whale, is actually a whale called "Winston," brought to San Diego by airlift from Windsor Park, near London, several years ago.

I hope that you may consider adding Sea World to Her Majesty's and His Royal Highness' itinerary for San Diego. It's a remarkable, fascinating, and varied place.

The hidden power of the hereditary oligarchs

by Criton Zoakos, Editor-in-Chief

The greatest political problem of the United States today is one which most citizens hysterically refuse to admit: old Europe's British-centered oligarchy has, increasingly, been running all of our monetary and financial policies and large parts of our foreign policy. This publication's principal adopted objective is to provide American citizens with the information they need in order to reach for their pitchforks and hound these oligarchs and their American allies and in-laws out of this Republic. In a nutshell, either our project will succeed, or the United States will soon cease to exist as an organized democratic republic, to be replaced by something too hideous to contemplate.

Increasingly since the end of World War II, we have been functioning less and less as a republic because a) information necessary for policy decisions was made less and less available to our citizenry because of the oligarchy's control over the information media and b) on matters of science and technology policy, the central matter of post-World War II politics, our citizens increasingly lost the faculty of judgment, because the oligarchy controls the long term policies of our educational system.

To state the case in summary form: From the latter half of the 19th century to this day, the long-term grand strategy of Great Britain has been controlled by a continuing policy group variously identified as the Cecil Group, the Milner Kindergarten, the Cliveden Set, the Round Table organization or simply "Us." It is dedicated to the establishment of a worldwide imperial order under the general scheme of a "Commonwealth," whose unifying element will be the British world outlook and the "British way of life." The founding documents of this group are two books, Arnold J. Toynbee's Study of History and Lionel Curtis's Civitas Dei. Lionel Curtis was the founder of the Royal Institute of International Affairs, the "mother" organization of the New York Council on Foreign Relations and of the Institute of Pacific Relations (of "who lost China" fame).

Target: American System of economics

The origins of this group go back to a series of lectures delivered at Oxford



Queen Elizabeth of England, head of the most powerful of the continent's royal houses, with Royal Canadian Mounted Police escort during 1978 tour of Canada. Canada's April 1982 official proclamation of Elizabeth as Queen of Canada is leading an oligarchical effort to recolonize North America.

University's All Souls College by John Ruskin and Arnold Toynbee during the latter half of the 19th century. To this day, All Souls is the center of British grand strategy along with its sister outfits, the Royal Institute of International Affairs (Chatham House) and Princeton's Institute for Advanced Studies, also known as "All Souls West."

We can assert that most of 20th-century history of the Western world has been dominated by this group. The story will require a few volumes to adequately present all the facts. The revelation will be a bitter pill to many, but that is another story. Original documents and speeches of the Round Table founders indicate that their sole purpose in proposing this British-dominated world commonwealth was to prevent the spread in the world of the American system of economics as it had then been successfully applied in the industrialization of the United States, Germany, and Japan, and was threatening, from the 1880s onward, to be applied in Count Sergei Witte's Russia.

Throughout the 20th century, every single British cabinet was dominated by this so-called Milner Group, regardless of whether the ruling party was Tory or Labour. This group planned and launched World War I; it dominated and determined the outcome of the Versailles Peace Conference; it ran the German war reparations racket; it put Hitler in power; it launched World War II; it imposed the Cold War between the United States and the Soviet Union; it launched the antinuclear movement with Lord Bertrand Russell's Operation Dropshot; it was the brain behind the "Kim" Philby spy caper; it launched the counterculture, environmentalist, and new left movements of the 1960s; it managed the "detente" era of

the 1970s; and it is now pushing the genocidal Global 2000 policies of the 1980s.

Ordinary citizens miss the point because they do not possess the training which would inform them that grand strategy in the 20th-century is determined by one overwhelming consideration: science policy. This case became even more emphatic since the detonation of the first A-bomb in 1945. The central objective of the grand strategists at All Souls, over all these decades, has been to put the genie of science back in the bottle. American policies, especially since the assassination of President Kennedy, have been dominated by the allies of All Souls and of Chatham House.

Henry Kissinger, recruited to public life by Sir Isaiah Berlin, an old member of the Milner Group, is an agent of Chathan House, as he himself proclaimed in a speech at Chatham House this May 10. But he is merely one of the many Americans in the service of the British oligarchy and its policies.

The real problem of the American Republic is that all of the country's "old families" which were on the Tory side during the American Revolution, are now in command of most of the nation's positions of influence in banking, industry, education, and what passes for culture. The Cabots and the Lowells and the Lodges still control everything of consequence in New England, including Harvard; the Mellons control everything of note in Pennsylvania and elsewhere; the State of Texas is still controlled by the "old money" behind the Texas Railroad Commission which goes back to Prince Talleyrand de Perigord; a cursory review of the situation with Weyerhaueser, Field, Biddle-Duke, Du Pont, Harriman, Moore, Peabody, Hanna, Vanderbilt, et al., will further demonstrate the point.

The case of Morgan Guaranty

Morgan Guaranty Trust, whose Chief Executive Officer Dennis Weatherstone, a British subject, issues daily marching orders to George P. Shultz, our present Secretary of State, is a most instructive case in point. It is the only bank on Wall Street which flies the British flag at its corporate headquarters. The late Representative Wright Patman had established, in his controversial "Patman Report," that Morgan Guaranty controls the policies of all other New York banks by means of its control of virtually all "old money" trust funds which are invested in the voting shares of all other New York banks. Representative Patman made the argument that there is no such thing as 12 separate and independent New York banks, but rather an equal number of corporate subdivisions of one single corporate entity presided over by Morgan.

Morgan's policies are dictated by the Bank of England and are conduited to New York via Morgan Grenfell Ltd. The Board of Directors of the Bank of England follows the policies of the British Royal Household, as set by the Scottish Rite Grand "Mother" Lodge of London, presided over by the Duke of Kent.

Our public life is permeated by the influence of the British oligarchy's agents. For instance, how many citizens know that the founder of the CIA, Allen Dulles, was a leading member of the London Royal Institute since at least 1935, during which year he presided over the congresses and conferences of that institute? Or, how many Americans know that General of the Armies Douglas MacArthur was unceremoniously cashiered on orders from London, carried out by Averell Harriman (now married to Pamela Churchill) and Thomas Cabot of the venerable, opium-trading Tory family?

Or, how many Americans know that every single British Ambassador to Washington, from Lord Halifax during World War II to Sir Nicholas Henderson during the Falklands War were all members of the inner core of the so-called Milner Group?

The current betrayal of American interests to the Soviet Union by the British, as epitomized in the Geoffrey Prime spy scandal of late October, goes back to the origins of the Milner Group deployment into the United States. The Prime Affair is the direct continuation of the Philby Affair, which had been set up by Lord Halifax and by Sir Isaiah Berlin. In this sense, it will soon come to public light, both affairs are linked to the Kissinger affair. Back in 1945 at Oberammergau, Germany, associates of Isaiah Berlin, including Fritz Kraemer, arranged with John J. McCloy for young Henry to be a commonly shared asset of the Milner Group and Soviet intelligence.

Henry Kissinger's oligarchical script

At this time, Kissinger is following a public script written for him by Lord Home of Avon.

Henry has been reading this script to every public event since May 10. The United States must withdraw from positions of influence around the globe. Commanding no more than 24 percent of world GNP, as compared to over 52 percent in 1945, the United States no longer possesses the preconditions for playing a leading world role, Kissinger argues on advice from Lord Home. Therefore, we should revamp our foreign policy by allowing London's expert advice. As a result, U.S. influence in Latin America has been wiped out; in the Middle East it has all but disappeared; United States policy in the Pacific, beginning with the "China Card" has collapsed; Western Europe, according to the plan of Lord Carrington, is making its separate arrangements with the Soviet Union.

More ominously, since May 1982, with the constitutional change in Canada, Elizabeth II of England has become Elizabeth I of Canada, the person legally embodying the sovereignty of our northern neighbor.

This is the first time since the execution of Maximilian Hapsburg by the Mexican republicans that a monarchy has been restored in the Western Hemisphere, an act contrary to the Monroe Doctrine.

The queen and her husband, Prince Philip, are sailing to California aboard the royal yacht Britannia, on Feb. 26, for a 17-day mixture of business and pleasure.
A spokesman for the British Embassy, who did not wish to be identified, said it was likely the queen also would visit other HAL West Coast States before she leaves on March 7. White House aides have been working with British officials for weeks in an attempt to figure out which cities in Reagan's home state of California the royal couple will visit. There is a keen interest in being as gracious hosts as possible because the president and Mrs. Reagan were treated so well when they were in England 'last June, according to a U.S. official involved in planning the events. He did not wish to be further identified. Several White House officials joined British officials in a trip to four California cities earlier this month in an attempt to decide which cities the queen should visit. Because California is Ronald Reagan's home state, it was felt there were a number of things the White House could be helpful 'said the official. The trip will mark the queen's first visit to the West Coast. She visited the East Coast of the United States during the Bicentennial celebration in 1976. The tentative agenda calls for Nancy Reagan to greet the queen and prince when they arrive in 'San Diego on Feb. 26. Reagan will remain at the White House to host a dinner for the nation's governors and fly to California afterward. After Oueen Elizabeth expressed interest in visiting a soundstage, a group of community leaders decided to throw a dinner L L in her honor on a soundstage in Los Angeles on Feb. 27. On March 1, the Britannia will sail to Santa Barbara, where the Peagans are expected to greet their guests at the pier and take them to the president's 688-acre ranch in the Santa Ynez Mountains about 30 miles away. White House aides wondered whether the ranch, which has a spectacular view of the Pacific Ocean and the mountains but features only a modest house, would be suitable for the queen. But they were assured by Fritish aides that she enjoys that kind of informality. In addition to the barbecue at the ranch, Reagan and the queen ere likely to go horseback riding, as they did at Windsor Castle in Jure. The queen and her husband probably will spend the night on their yacht. The Reagans may spend a night on the ship with them. On March 3, the Fritannia arrives in San Francisco for the official White House dinner in honor of the queen at DeYoung Museum. Reagan and his wife are expected to bid farewell to the royal couple in San Francisco on March 5. From there, the Britannia sails to Canada until March 11. The queen's journey begins on Feb. 13 in Jamaica. From there, she will sail to the Cayman Islands on Feb. 16, then to Mexico on Teb. 17. AP-NY-12-17 1522EST






