It appears that favorable action by the Senate over the next two - three weeks is a distinct probability, and I would encourage a strong initiative on the part of the White House on behalf of same.

While not fail-proof, the amendment does offer us a pragmatic way of changing the Congressional value system by introducing very real political disincentives for individual members of Congress who are predisposed toward institutionalized Federal spending despite the consequences.

Moreover, the amendment is a logical, "first principle" extension of the President's efforts to reverse the bias toward runaway Federal spending. Indeed, were it presently law, we wouldn't be fighting the "wars" we are ... or, at least, the ground rules would be markedly changed in our favor.

Thanks again, Elizabeth. It's a privilege to work with your staff and you.

Statement by Dirk Van Dongen, President, National Association of Wholesaler-Distributors, following approval of the bipartisan Economic Recovery Budget by the House of Representatives:

I have not yet had a reply to my letter of May 24 in which I asked that a group of our community leaders be able to meet with you in order to explain why we need the administration's help in securing passage of anti-busing legislation and in getting the "Moots Case" before the Supreme Court. This is the case involving the court-ordered merger and cross-busing of our children in the east-suburban Pittsburgh area.

I realize you have been very busy with the European trip, so my original request for a meeting with you on May 3 or 4 may well have been impossible. Mowever, we were forced to revise our plans and will be coming to Washington this Thursday, June 17, instead. Might it be possible for you to meet with us then?

Although we are completely devoted to the anti-busing struggle, we here are not, for the most part "Moral Majority" people or even "New Right" sympathizers. We represent people from all walks of life and of all shades of political persuasion when it comes to issues in general, but we are united in abhorrence of a policy which we see as destroying our children's educations and our communities and as wasting millions of dollars of our hard-earned tax money.

do something about the forced busing issue (the anti-busing statement in the platform faced the problem clearly and succinctly), we're wondering why he has not yet zeroed in on accomplishing anything in this area.

The future of the American public education system is at stake, and there is no longer time for President Reagan to be lenient with "timid aides" (see accompanying newspaper article). We feel Attorney General William French Smith, for one, and his associates in the Justice Department could be doing much more to persuade the Supreme Court that its consideration of our Hoots Case would be of benefit to people all over the nation in clarifying the whole busing issue and hopefully in bringing relief to them from the scourge that is destroying good schools and good communities everywhere.

We feel also that there should be more Administration influence exerted on liberal Republican lawmakers like Senators Specter and Heinz to secure their support for anti-busing legislation. #### Balanced Budget

Ted Jacob believes that a balanced federal budget should be the nation's NUMBER ONE economic priority. Ted opposes new tax increases; he supports President Reagan's three-year tax cut program. Tax increases will not reduce the federal deficit; they will only lead to increased federal spending and still larger deficits. IN CONGRESS TED JACOB WILL ACCEPT NO PAY RAISES UNTIL THE FEDERAL BUDGET IS BALANCED.

#### Jobs

The Pittsburgh economy is being devastated by imported products from Japan, Western Europe and Third World nations. Business firms in America are forced to compete against subsidized foreign firms who can sell products at prices below cost. These foreign firms need not worry about making a profit. The result has been large-scale plant shutdowns and layoffs in steel, automobile and other industries. To remedy this situation, Ted Jacob proposes adoption of an "import privilege fee." Such a program could adjust prices of imported products on a cost basis, thereby providing U.S. firms with fair opportunity to compete. "Free trade" is meaningless without FAIR trade. TED JACOB INSISTS THAT IT IS TIME TO STOP IMPORTING UNEMPLOYMENT FROM ABROAD.

#### Nuclear Arms Control

Both the U.S. and the U.S.S.R. are engaged in a mindless fight for nuclear "superiority." This nuclear arms race presents an increasing threat of nuclear war by accident or intention. There will be no "winners" of a nuclear war -- millions of people will be killed and civilization as we know it today will be destroyed. TED JACOB ENDORSES A NEGOTIATED BILATERAL FREEZE ON THE BUILDUP OF NEW NUCLEAR ARMS. Such an agreement must be verifiable and it must contain a framework for equitable reductions in the existing stockpile of nuclear weapons. Until the Soviets agree to a freeze, Ted endorses continued research, development and construction of nuclear weapons. Projects such as the B-l bomber and the MX missle should continue on a stretched-out timetable until the Soviets sign an effective arms control agreement. Ted opposes unilateral arms control.

#### Compulsory Busing of Schoolchildren

Ted Jacob believes that forced busing of children for the purpose of desegregation is absolutely insane. Busing harms public schools by driving many families to private schools. Judicial busing orders remove control of local schools from parents, teachers and elected community leaders. Busing punishes families who work hard, earn a good living, and move to the suburbs for better schools. Ted does not, however, oppose voluntary busing underprivileged children to suburban schools. Each parent should have the right to send their children to their neighborhood schools.

Ted Jacob fears that unaccountable federal judges may soon require busing on a metropolitan-wide basis in Pittsburgh. Because of this fear, TED JACOB SUPPORTS STATUTORY RESTRICTIONS ON THE POWER OF COURTS TO ORDER FORCED BUSING OF SCHOOLCHILDREN. If necessary, Ted Jacob would support a constitutional amendment providing parents with the right to send their children to neighborhood schools. As alternatives to coerced busing, Ted supports "magnet" schools with voluntary busing.

Ted Jacob's research staff is currently working on other major issues such as social security reform, medical care cost control, clean air law improvements and tax reform. # Restless New-Right Leaders Drift Away From Reagan

WASHINGTON — A year and a half after its triumphant march into Washington with Ronald Reagan, the New Right is growing restless.

Sympathizers and opponents agree the New Right, which places ideology over compromise, has a major problem. Many of its goals are not politically pragmatic, or "do-able," in Washington parlance. And some doubt the coalition has the support to achieve its ends.

Frustrated New Right leaders are moving further away from Reagan, complaining timid aides have hog-tied his administration.

"The Reagan program is not the conservative program, and among New Right leaders I think that's the clear and emerging view," said Howard Phillips, director of the Conservative Caucus. "Our job is to get that message across to the voters so that someday we can have a chance to try our program."

The political professionals of the New Right caught attention in 1980 when their aggressiveness and fund raising boosted Republicans to victory. Their agenda includes opposition to abortion, busing and the Equal Rights Amendment, and calls for school prayer, private-school tax credits, a balanced budget and a hard line toward the Soviets.

Phillips and others have blasted the administration for its massive proposed deficit, its affinity for arms control and its failure to "defund the left" with more socialprogram cuts. They accuse Reagan of breaking his promises.

"The dustbin of history is piled high with political pragmatists," said John Lofton, editor of Conservative Digest. "The problem with being a slave to the (public opinion) polls is the question of, 'What about your honor?'"

The administration has tried to placate the New Right by endorsing a cautiously worded constitutional amendment to encourage school prayer and another to require a balanced budget. But there is little effort to push the measures through Congress, and meetings between New Right leaders and administration officials have been stormy.

"There are conservatives and then there are professional conservatives. A professional conservative ... has a vested interest in having targets to crank out mass mailings to," a White House aide said, referring to the New Right's use of mailings to raise money.

The aide said he believes only 5 to 8 percent of the electorate backs the New Right's stance on all issues. Asked if the administration is taking the movement seriously, he responded, "The New Right gets more from this administration than they represent in the vote."

Congress also has balked on bringing far-right legislation to the floor, mostly due to congressional preoccupation with the economy.

"Middle-of-the-road politicians are still going to get what they want," said an aide to Sen. Dan Quayle, R-Ind., a conservative elected in 1980 after the New Right's vigorous attack on his opponent, former Sen. Birch Bayh.

Marty Russo, D-Ill., said he thinks the New Right's influence has been overestimated and that it has been "repudiated" in Congress.

How much popular support the New Right can claim has never been clear. Everett Ladd, a University of Connecticut political scientist and director of the Roper Public Opinion Center, argues that the movement appeals to only a small fraction of Americans.

"What you've got is a group that's ideologically distant from the center of American opinion, generally," Ladd said, adding that there is not a "groundswell" of support for major social-policy change.

In his book "The New Right: We're Ready to Lead," direct-mail expert Richard Viguerie said the "conservative revolution" of 1980 was due largely to backlash against years of social liberalism — "socialism on the installment plan" — that brought nationwide decadence: sex on TV, legalization of abortion and decline of the family.

In light of setbacks in Congress and the White House, some conservative leaders say they are reassessing tactics. They say a broader base will have to be pieced together from more Americans who agree with them on one or two issues.

Viguerie, who works 12-hour days running his company and "strategizing" with fellow conservatives, believes the movement must become more populist and "rephrase" some of its beliefs.

"I want to plan for the future. I'm unhappy with the short range, but I'm not going to get sidetracked. There's an enormous amount of activity in the movement," he said.

Not all the New Rightists are disenchanted. Cal Thomas, a vice president of the fundamentalist Moral Majority, counsels patience.

"You don't cure a man who's on a 50-year drunk in a short time," he said. "We believe we have the best opportunity for change in a long time. Enough people in the New Right know there are times when you have to be pragmatic and sometimes you have to be idealistic."


