
Dear Ms. Turner:

In the same line, but on a different vein, I wonder if there was some way to honor these ten to fifteen person approximately who have and will continue to work on this project. During the Bi-Centennial many governors had made Proclamations to honor those who by virtue of their talents and at a great personal cost have administered. Is there a possibility that since this is a "National Event" that the Senate or Congress could through some means honor these who have given so much to honor our Nation and asked nothing in return.

My optimum goal would be to have an executive order from President Regan appointing each leader as an honorary Officer or some similar title for this event. However, I know the difficulty of this and therefore seek your counsel and advise.

I am enclosing some copies of letters that have been written to others so you may see how we are now working to broaden our current five day event into a long range and classical educational tool.

An unofficial translation

The events organized by "Together for Peace" at Castiglione delle Stiviere and at Solferino, recently came to a close with the lyrical performance at Verona in honour of Maria Callas.

The entire program was a great success and exceeded the most optimistic expectations. At the round table, discussions were held among representatives of more than 80 countries of the world and it was possible to ascertain that, happily a common language exists when speaking of peace, forgetting, indeed eliminating the barriers which a difference of races, religions and political orientations could create.

At the exhibit of the first international museum of the Red Cross, at Castiglione delle Stiviere I especially remembered the moment of our last encounter, at the ceremony of the placing of the first stone of the future monument to Ginevra.

I would not be sincere if I did not express to you my deep regret for not having been able to include you among the guests of honour present at the celebrations for peace, at which you would have made an immeasurable contribution through your personality and the prestigious weight of your position as First Lady of the most important nation of the free world.

However, I received your letter in due time and I understood the necessity of your being at the President's side during your brief vacation.

On the otherhand, I was quite surprised that the great nation, both sister and friend, America, was not represented at the level of the Red Cross nor at the Embassy in Rome.

I take this occasion with pleasure to send my warmest regards to the President and to you, also on behalf of my husband.

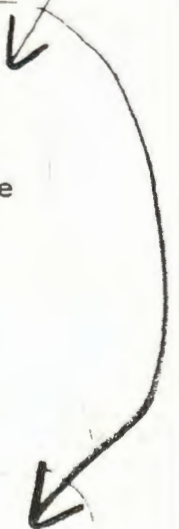





In 1958, with the conquest of infantile paralysis all but assured, the uniquely successful network of volunteers and professionals known as the March of Dimes turned its attention to the number one child health problem, which it termed birth defects.

Much in the way preventive polio vaccines have spared future generations from that dread disease, so too has the March of Dimes sought to save babies from birth defects through *prevention*—finding out causes and seeking to prevent them, whether genetic, behavioral, or environmental.

In the years since 1958, we have seen that:

Preventing birth defects saves countless babies from being born sick, damaged, or dead.

Preventing birth defects, like all preventive health care, saves millions of dollars by improving the chances for healthy births and healthy, productive lifetimes.

March of Dimes leadership has been central in the evolving and expanding fields of birth defects diagnosis, treatment, and prevention: beginning in the 1960s with evaluation and treatment centers, to explore and define the problem... through the 1970s, with expansion of genetic counseling centers and regionalized health care for pregnant women and critically ill newborns

... and into the 1980s, with expanded programs of public health and professional education for preventive health care, continuing advances in programs to prevent premature birth, to reduce the incidence of low-birthweight babies, and improve the rate of infant mortality in the United States.

The March of Dimes also has been instrumental in bringing together the specialties of pediatrics and obstetrics, to provide multidisciplinary care during the continuum from conception through the first months of life. The consequent revolution in maternal and newborn health care has had much to do with the concurrent improvement in infant survival.

Throughout this time, March of Dimes-funded research helped explore new frontiers of knowledge. Through hundreds of grants to leading institutions and medical centers, the March of Dimes has played a major role in such areas as genetics, prenatal diagnosis and therapy, and modern health education.

Prevention of birth defects can't be measured in the eradication of a single disease, as in the fight against polio. Rather, prevention is a matter of changing the statistics, of increasing the number of babies born healthy, and of providing the resources that will give each baby the best chance of a healthy start in life. This is the goal of the March of Dimes.



NEW YORK RIDING PROGRAM FOR THE HANDICAPPED

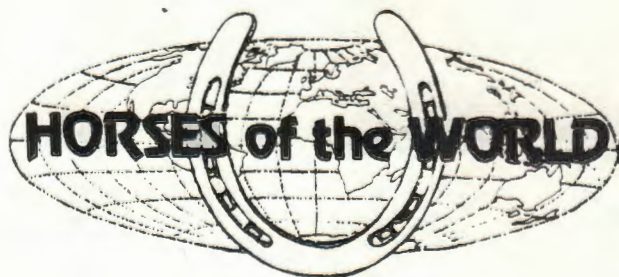


The New York Riding Program for the Handicapped is collaborating with the New York City Mounted Police and United Cerebral Palsy of New York City in the development of a therapeutic riding program for disabled adults and children living in the five boroughs of New York.

Horseback riding in rehabilitation and recreation programs for the disabled is growing rapidly throughout the country. The substantial benefits of therapeutic riding are winning widespread recognition in the rehabilitation of individuals with a broad range of physical and emotional disabilities such as cerebral palsy, muscular dystrophy, mental retardation, learning disabilities and blindness.

Despite the many benefits that the disabled derive from horseback riding, no continuous riding programs for disabled adults and children are at present available in New York City.

In order to fill this need, the New York Riding Program for the Handicapped (NY/RPH), a non-profit, tax-exempt organization, has been established. NY/RPH, in conjunction with the New York City Police Department's Mounted Unit, United Cerebral Palsy of New York City and other major rehabilitation agencies, is conducting a therapeutic riding program for disabled adults and children living in the Greater New York Metropolitan Area.

Dear Ms. Madrazo:

Thank you for your letter dated January 28, 1987, setting forth your request for a White House endorsement of a table game entitled "1600 Pennsylvania Avenue."

The description of the game set forth in your letter suggests that it is a salutary enterprise that will have value both for political education and entertainment. Nonetheless, the White House will be unable to provide an endorsement for the game. The President is following a long-standing policy of this and previous Administrations of declining permission to use the name or likeness of the President, the First Lady or the White House in advertising or commercial promotion in any way that suggests a connection between the White House and the product or the promotion. This policy is set forth in Section 236 of the Do's and Don'ts in Advertising Copy, published by the Council of Better Business Bureaus, Inc. Moreover, Section 235 of the Do's and Don'ts in Advertising Copy provides that "[n]either the name nor the photograph or likeness of the White House should be used in any advertising whatsoever." Similarly, federal law and Executive Orders prohibit the use of the Seal of the President, the Vice President or the United States except for official purposes.

For the foregoing reasons, this office has considered, and declined, similar requests to endorse, or permit the use of the Seal of the President in connection with, board games.

We appreciate very much your courtesy in writing and providing the materials you forwarded to us for our review. We hope you understand that our conclusion is required by applicable policy, law and Executive Order.



Dear Senator Masengy:

My name is Anke Michele de Madrazo, and I have just graduated from the University of Texas with a degree in political science. Among the highlights of my university career, I include being named three times to the Dean's List, and being nominated as a candidate for "Who's Who Among American College and University Students."

I would like to acquaint you with the tablegame that I have designed, "1600 Pennsylvania Avenue," which was created during the process of searching for possible ways of increasing popular interest in the political processes of this nation. It is evident that the participation of people in politics has declined gradually in the last few years. Eventually, this could spell disaster for the American democratic spirit. To reverse this trend, the first thing that we must consider is to change the attitude of the public. Somehow, the apathy that they demonstrate in elections can be reversed through the tools of education, stimulation and entertainment. By no means do I wish to imply that this project could single-handedly achieve this. However, its role, if well handled, could awaken national awareness.

It has been proven that when a game becomes popular, its influence and permeation are overwhelming and long lasting. If we could make this game popular, we would automatically eliminate some of the political apathy.

"1600 Pennsylvania Avenue" is simple, easy to understand, easy to play, entertaining, and most importantly, it transmits culture, knowledge and national principles. Unfortunately, a project of this nature has to surmount significant obstacles, the most important one is that manufacturers are not usually interested in tablegames with political themes because they assume that they cannot become popular.

At the inception of this project, the first thing that I took into consideration was to combine into one game the most attractive aspects of extremely popular games such as "Monopoly," "Life," and "Trivial Pursuit." Through the opinions of qualified people in the game industry, I have learned that my game is original, logical, well-executed and understandable. However, in order for this project to become a reality, its values and benefits must be recognized and officially endorsed by educational and political authorities.

I have approached you because of your's and the White House's respected image among the American public, and an endorsement from the White House, and/or the Director of Public Relations for the White House would improve the chances of the game's acceptance by those who could bring it to the market.

If you could envision another purpose for the game, or if you recommend that I forward a copy of the game for you or for someone else at the White House to review for endorsement, please advise me, as I am anxious to know your opinion.

S Y N O P S I S

"1600 Pennsylvania Avenue" can be played among two to six players who are thirteen years of age and up. The objective of the game is for one player to become president of the United States. He achieves this by combining luck with sufficient knowledge of the United States, United States politics, the world, and the correct spelling of english words.

The game consists of two stages. In the first stage, the players are in pursuit of gaining a tally of one million votes and fifty-one "Campaign Offices" in order to be eligible for presidential candidacy in the second stage of the game. This is accomplished by traveling along the "Campaign Trail" to every state in the Union. This is governed by lucky rolls of the dice and spins of the "Vote Score Spinning Top" which determines popular support for the "Pre-Candidate" as represented by the number of votes won or lost. Also in the first stage of the game, the players increase or decrease their vote tallies by answering questions concerning Americana ("National Interview"), United States politics ("Press Conference"), the world ("Foreign Interview"), and spelling ("Speech").

Elsewhere along the "Campaign Trail," we find squares named "Connections," "Scandal," "T.V. News," "Newspaper," "Debate," "Lucky Square," "Vote Tally," "Unpopular," "Charisma," and "Undecided Votes," which serve various purposes in the game. For instance, in today's society, to have the right connections is a powerful means to achieve the highest goals. In "1600 Pennsylvania Avenue," having "Connections" will help maintain a "Pre-Candidate's" popularity. However, if the "Pre-Candidate" has the misfortune to find his "Limousine" game token on the "Scandal" square, his secrets become public knowledge, and his popularity suffers. The "T.V. News" and "Newspaper" squares present (in the style of a television news or newspaper headline) information which either positively or negatively affects the "Pre-Candidate's" campaign. The "Debate" square involves "Pre-Candidates" in the most pressing social issues of our time; with luck on their side, the players resolve the issues and win the "Debates." As on any campaign, touring the nation is vital, which is facilitated for the "Pre-Candidates" by reaching a "Lucky Square" to receive a free ticket to visit almost any destination on the "Campaign Trail." By landing on the "Charisma" or "Unpopular" squares, the players' attempts to increase their vote tallies are aided or hindered. When a player has the good fortune to land on the "Undecided Votes" square, this automatically allows him to increase his popularity in the form of votes.

When a "Pre-Candidate" fills his "Headquarters Location Board" with the fifty-one "Campaign Office Pins," and accumulates at

least one million votes, he is eligible to become a "Presidential Candidate" and passes on to the second stage of the game, where he tries to obtain a majority of the "Electoral College Votes." The player who demonstrates superior knowledge of the United States, and thereby gains at least two hundred and seventy "Electoral College Votes," becomes "President" and thus wins the game.




