FROM: DENNIS BLAIR

SUBJECT: Call by Ambassador Petrignani

As instructed, I telephoned Petrignani to tell him that you would be unable to meet with him.

He then requested to meet with you "for 3-4 minutes" next week before he returns to Rome for consultations.

He wishes to have "your personal reaction" to two potential visits by high-level Italians this fall.

We know from other sources that he is talking about a photo opportunity with the President for Senator Fanfani in September, and a state visit by Prime Minister Spadolini in October.

I told Petrignani that it would be difficult for you to give him anything but a superficial reaction unless he gave me the information and I staffed it for you. He told me that if the ambassador from Italy wanted to meet for 3-4 minutes with the National Security Advisor, he should be able to.

Petrignani is particularly touchy these days since he found out about the Quad meeting which we were going to hold with the Brits, French and Germans.

The Italians are still carrying a lot of water for us these days, so I feel we should be responsive to Petrignani within reasonable limits. I recommend that you telephone him, tell him that you are unable to meet personally, and ask what is on his mind. A photo opportunity for Fanfani is certainly no big thing, and we can tell him we think it is a good idea. A visit by Spadolini is fine in principle, but October will be a tough month. Perhaps a working visit, which would take less of a time commitment, would be better, and the more flexibility there is on the dates, the better.

Sorry I could not turn the whole thing off.

SUBJECT: To discussion questions re Italian affairs : I am fairly sure that Petrignani wants to make a high-level pitch for the President to receive PM Spadolini and influential Christian Democrat Amintore Fanfani in October (he took Larry Eagleburger aside yesterday during a discussion about the pipeline decision to push this).

RECOMMENDATION: A tough call: the matter is highly important for Spadolini (and Petrignani), but will get us into tricky Italian politics with no clear payoff (since Spadolini may soon be a lame duck). On the other hand, we are asking the Italians to do a great deal for us (Lebanon), and on balance I believe the Judge should see him for 5 minutes, then turn him over to JR.
