2. SECRETARY'S SECOND, LONG CONVERSATION WITH COSTA MENDEZ THIS EVENING APRIL 12 YIELDED NO NEW PROPOSALS. COSTA MENDEZ INSISTED ARGENTINA RECEIVE EITHER THE GOVERNORSHIP OF THE ISLANDS -- OR A HARD COMMITMENT TO SOVEREIGNTY. SECRETARY REMINDED HIM THAT HE WOULD NOT HAVE UNDERTAKEN THE EFFORT IF THAT WAS TO BE THE CONDITION.

THE COURSE OF WHICH YOU WILL WANT TO LET THEM KNOW

4. WE WOULD PREFER THAT YOU NOT ALERT THEM TO THE ISRAELI REQUEST FOR A SIGNED DOCUMENT OR DOCUMENTS. WE DO NOT WANT TO BE CONVEYING THE ISRAELI POSITION ON ISRAELI BEHALF. MOREOVER, IT IS POSSIBLE THAT WE WILL BE ABLE TO MODIFY THIS APPROACH IN DISCUSSIONS IN ISRAEL.

5. OUR OBJECTIVE IS TO PREVENT THE EGYPTIANS AT THIS POINT FROM MAKING OR REINFORCING THE KIND OF CATEGORICAL REJECTION THAT ALI CONVEYED TO YOU WITH REGARD TO A DOCUMENT AFFIRMING THE PARTIES' COMMITMENT TO THE PEACE TREATY. CHANGES IN THE ADMINISTRATION OF THE FALKLANDS, ALONG THE LINES DESCRIBED REFTEL, WOULD, WE BELIEVE, BE IMPLEMENTED BY AN ORDER IN COUNCIL (DELEGATED LEGISLATION) AND WOULD NOT REQUIRE NEW LEGISLATION. HOWEVER, THERE MAY BE A REQUIREMENT THAT SUCH AN ORDER BE PLACED BEFORE PARLIAMENT, AND THAT COULD RESULT IN DELAY. IF AGREEABLE TO ALL CONCERNED PARTIES, USN ESCORTS WOULD BE AVAILABLE TO ESCORT COMMERCIAL CHARTERS.

IF PRACTICAL, YOU ALSO SHOULD PUT ONE OR MORE SHIPS ON NOTICE THAT WE MAY BE INTERESTED IN CHARTERING THEM IN CONNECTION WITH A PLO EVACUATION, PROVIDED THAT TO DO SO DOES NOT ENTAIL ANY FINANCIAL OBLIGATION.

5. YOU WILL NOTE FROM SEPTELS TO ATHENS AND NICOSIA (INFO LONDON) THAT WE ARE SEEKING SIMILAR INFORMATION ELSEWHERE. WE CONTINUE, HOWEVER, TO REGARD LONDON AS THE MAIN POINT OF CONTACT FOR THIS INITIAL CHARTER AND THOSE TO FOLLOW FOR FURTHER PLO EVACUATION.

6. THIS URGENT REQUEST IS FOR INFORMATION WE WILL USE IN WASHINGTON ON MORNING OF AUGUST 12 TO REVIEW SHIP CHARTER ISSUE. WE MAY AT THAT TIME DECIDE TO CHARTER SPECIFIC SHIPS AND/OR AUTHORIZE PAYMENT OF RETAINER FEE TO ENSURE THEIR AVAILABILITY. CURRENT THINKING IS THAT WE WOULD PASS OUR RECOMMENDATIONS TO ICRC WHICH

8. DEPARTMENT RECOGNIZES NEED TO REACH FIRM DECISIONS ON SHIP CHARTERS AS SOON AS POSSIBLE IN ORDER TO HAVE SHIPS ARRIVE IN BEIRUT ON/ABOUT AUGUST 20. WE WILL KEEP RELEVANT POSTS UP-TO-DATE ON STATUS OF ISSUE.
