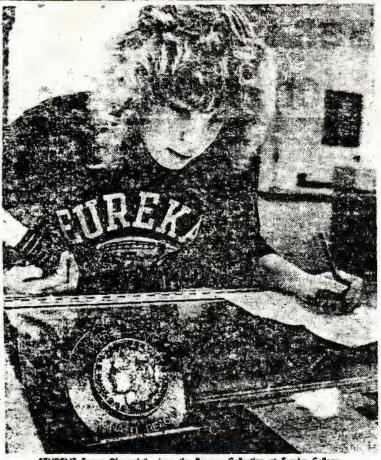

Alma mater stung by Reaganomics

EUREKA, Ill.—It's an ill wind that blows this spring on the campus of Eureka College.

Across the green lawns, through the stately trees and among the red brick and white frame campus buildings it blows, whispering as it goes of hardships present and "harderships" to come.

It comes out of the east, from Washington, D.C., where a son of Eureka College, Ronald W. Reagan, Class of 1932, sits in the White Hause.

Indeed, it was Rouald Reagan who loosed the wind, when he proposed earlier this year to reduce drastically the level of federal aid to college students—part of his over-ail effort to cut the growth of the federal budget. The proposals stirred anxiety among college officials generally, but they cast a pollover those at small, private colleges like Eureka, where any loss of students is appreciable and any appreciable loss can mean serious financial difficulty.

Nevertheless, spokesmen for Eureka are understandably reserved in their comments on the Reagan proposals, asserting that stagnant funding for the Illinois State Scholarship program may be as much a problem as reductions in federal aid.

"Schools have for a long time realized that, when the sid is available, students will make use of it," said Greg Saunders, Eureka's director of admissions. "What has hurt is just the magnitude of the mood."

8th-graders try college

Bright students like challenge of program

Twas brillig, and the aithy toves Did gyre and gimble in the wabe: Il mimsy were the borogroves. And the mome raths outgrabe.

-Prom "Jabberwocky," by Lewis Carroll

"What's the verb?" asked Professor Daniel A. Lindley Jr. after reciting the poem's opening lines.

"Gyre" and "gimble," his students shot back, seemingly surprised that they knew.

Lindley, an associate professor of English at the University of Illinois, turned to Lewis Carroll after his six students—eighth-graders from Chicago public schools—staunchly defended what they had "learned" in school about nouns and verbs.

"You knew grammar before you hit first grade," Lindley insisted. "You already had it inside of you, and don't let anyone tell you otherwise."

MEANWHILE, across the Chicago Circle campus, mathematics Professor Irwin K. Feinstein looked up from his group of eighth-graders and marveled. "They get it better than some of my college freshmen."

For 2½ hours each Wednesday, Lindley and Feinstein wear the cloak of elementary school teacher as part of a program to challenge the city school system's brightest eighth-graders.

This year, 105 eighth-graders are attending math, English and Latin classes on the campuses of the U. of I., Chicago State University and Northeastern Illinois University.

They qualified for the classes by,

all seventh-graders in the country on a standardized achievement test and, second, scoring better than the average high school junior or senior on the Scholastic Aptitude Test, which is used for college admissions.

For four years, the Illinois Board of Education has sponsored this "talent search" statewide, and eight regional centers for education of the gifted have arranged followup classes for top scorers on the SAT. The Chicago school system constitutes one center.

Feinstein lamented that fewer than half the eligible Chicago students enroll in the "college" classes, which are underwritten by the universities.

"The kids are good at almost everything they do," he explained. "Everybody wants them. Their schools want them for plays. Their communities want them for other activities."

Even so, all students who take the SAT get something out of it, said Ronald Ronvik, director of the achool system's programs for the gifted. About 650 Chicago seventh-graders have been tested in each of the last four years.

"THE REAL VALUE is that every student gets a letter explaining what his scores mean and what his ability level is, compared to older students," he explained. "It puts some responsibility onto the parents. It lets them know that, whenever their child makes a decision [about school], his level of ability should be taken into consideration."

Armed with this knowledge, many students participate in student activities sponsored by museums and other institutions, he said. The school system also organizes Saturday lectures for students—and their parents—who do not score high enough for the special

classes

After a year of fast-paced lessons and enrichment activities—logic problems, games and puzzles—more than 80 percent of Feinstein's students ear credit for freshman alpebra. About a third choose non-public high schools, he said.

In discussing mytha, spicz and legends with his students, Lindley stresses "the big ideas that have to do with life and death and the experience of what goes

"MY SENSE OF what goes on in schools—and not just Chicago schools," he said, is that the "big questions," like why certain works are assigned, never get asked. Instead, he said, teachers ask, "What happened in Chapter 37"

Anthony Hatch of Persiting School confirmed that impression. Asked how his college class differs from school, Anthony said, "At's less factual and more interpretive. Rather than reading to remember, we read to know."

"A lot of people could do better in a

"A lot of people could do better in a class like this," Anthony said, referring to its size.

Similarly, one of Feinstein's studenta, Erika Kim of Lincoln School, said, "I like the small class. Most classes at our school are really big. There's no chance to ask questions. There isn't enough time."

Feinstein and Lindley relish their time with the youngsters, calling it "fun" and "renewing."

"As people get older, the big questions are so big that they don't seem answerable," Lindley said. "In here we can took at life and death and have it be right there. Older [high school] kids have the same concerns, but they hide their concern under eight layers of cool."

the Reagan proposals, George Hearne, the dean of admissions and coilege relations, said, "It's the middle-income student who is likely to suffer most. Our student body is traditionaliy from the middle-income level. They would be impacted by whatever affects the sources of funding for that level."

Not only would they be affected, they appear aiready to have been. Never a large

school (Hearne said it never has had more than 500 full-time students in its 127 years), Eureka started the academic year in Sep-Illinois tember with only 439. That included al-

most 140 new freshmen and transfer students, about 40 fewer than the previous year, Saunders said.

Since September, 40 students have left, well over the normal 10 mid-year depar-

tures. And Saunders, while emphasizing that it is "nothing alarming," says applications for admission next fail are down and more and more prospective students are expressing concern about whether sufficient financial aid will be available throughout their college careers.

When Ronald Reagan entered Eureka Col-lege as a freshman in 1928, according to Hearne, costs were \$420 for the year-\$180 for tuition and \$240 for room and board. This year, it costs \$5,975 and next year that will

When Ronald Reagan attended Eureka, he worked his way through in part as a dining-room waiter in Lida's Wood, a sprawling, white frame building, vintage 1895, that was then and is now a women's dormitory.

College officials now are looking for ways to multiply the number of campus jobs, so more students can follow Reagan's example and make up for some of the grant or loan money they won't get from the government.

They also are calling on all the old grads-Ronald Reagan included-to take up some of the slack with an "Adopt-a-Student" gram, wherein gifts are being sought in packages of \$1,250, that being the projected average loss in grants from both the federal and state governments.

A White House spokesman said Reagan met last Tuesday evening with a group from the coilege. But no information was available on whether he had been solicited or would give to the aid campaign.

Whether private generosity can fill the gap that governmental cutbacks would leave is, at the moment, an open question.

But whether the governmental cutbacks ought to happen seems to be no question at ail in Eureka—at least not in the town, where the college, with a budget of \$3 million and a payroll of 95, is the single biggest enterprise.

Although his aims mater might end up on the altar and the town of 4,500 would bleed with it, Reagan's call for sacrifice has struck a responsive chord.

"The most frequent comment I hear Is, Give him a chance," said Joe Serangell, tilted back comfortably in his chair in the cramped mayor's office at City Hall.

A block and a half away from City Hail, at the Ben Franklin five-and-dime, Virg Chambliss can't afford to be quite so sanguine.

"We have considerable business from the students at the coilege," said Chambliss, who runs the store with his wife and son. "Eureka Coilege is part of the economic situation that provides us enough business to maintain a good store."

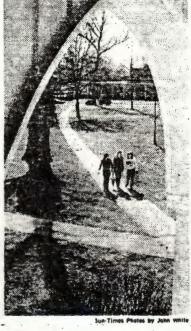
Still, he said, Reagan's policies must be given a chance. "Given another six months, if things don't improve, he's going to have to reverse himself. I think he's smart enough to

Around the corner from City Hall, Richard W. Snyder leaned on the sales counter at J. B. Snyder & Son, a lumber and hardware business that he used to own and now has turned over to his son and son-in-law.

If the college closed, Snyder said, "It would be a small disaster. It's a big employer. They spend a lot of money in town. We sell them maintenance materials—\$15,000 to \$20,000 a year. We can't afford to lose that kind of sale."

Besides the economic impact, he says, there would be the loss of amenities like the college library, which is available to the townsfolk and the programs and public lectures that the school sponsors.

Nevertheless, he said, "I think [Reagan's] programs are right, but I don't know. To a businessman, it seems right, but it's kind of



hard to swallow."

Back on Main St., at the First Bank of Eureka, president Kaywin G. McClure also levied no criticism of Reagan, although he viewed the potential loss of Eureka College as very serious matter.

The college is very important to Eureka and the economy of our area," said McClure. "it's been here 150 years, it's one of our largest employers. And the students bring quite a bit of money into our area. So any decrease in enrollment has a substantial ef-

He also noted the "immeasurable" social and cultural significance of the college.

"Eureka is and always has been a different community because of the college," he said. For example, we've always had minorities in Eureka, primarily because of the college. We just hope that Eureka College can find some way to survive."

That hope is shared fervently on the campus by students like Kelley Munyon, a 19year-old freshman from Downstate Warrensburg. What with academic scholarships, student loans, a job and some help from her parents, she figures she'll be able to meet her coilege bill.

a football scholarship to do so.

"If you want a good education," said McClain, "Eureka is the perfect place."

As an athlete at the state school, McClair said, he felt he was getting shortchanged academically. At Eureka, where he still plays football but without the benefit of a scholarship (the school gives no athletic grants), he feels himself a true student.

- o To be competent in at least one academic and/or professional field

These educational objectives are applicable to all Eureka College students. Reagan Scholars will be reviewed annually on the basis of these objectives.

Selection Process for Reagan Scholars

Candidates for the scholarships undergo a rigorous selection process.

Three general criteria guide the Selection Committee in making their decision.

The potential for effective leadership is determined on the basis of personality evaluations, the candidate's history of participation and leadership in various activities both in and out of school, recommendations and the results of personal interviews. The application and interview will attempt to uncover the quality of leadership exhibited by a candidate. Mere election to various posts does not provide adequate evidence of authentic potential for leadership. The Selection Committee places great value on the seriousness of purpose exhibited by a candidate.

commitment to service is also determined on the basis of personality evaluations, recommendations and the results of personal interviews. In assessing this quality the Selection Committee will seek evidence of authentic concern for others expressed in an ability and interest in solving practical problems which face humanity.

Academic achievement is determined by examination of a candidate's secondary school record, including: grade point average, distribution of preparatory coursework among the fundamental areas of the arts and sciences, and the results of standardized assessment tests.

The personality evaluations testing and interviews required for consideration will be conducted on a regional basis, and scheduled as conveniently as possible for the largest number of qualified candidates. Expenses associated with the travel to testing and interview sites must be assumed by the candidates.

To be eligible for consideration a candidate must:

- o Have achieved academic standing sufficiently advanced to assure graduation from an accredited secondary school or its equivalent before August 15, 1983
- Be able to communicate effectively in both oral and written English.

The Selection Committee attempts to ensure an exciting mixture of Scholars from divergent backgrounds. No candidate will be disqualified on account of race, creed, sex, marital status, national origin or handicap.

Organization of the Board of Visitors

Membership on the Board is restricted to 100 individuals. Members are appointed by the President of Eureka College for four-year terms. Members of the Board also nominate prospective members to the President for his consideration.

Currently members of the Board of Visitors serve on one of five committees:

- o Executive Committee
- o Nominating Committee
- o Committee on Selection Criteria
- o Committee on Internships and Special Programs
- o Academic Visitation Committee

All members of the Board of Visitors are expected to be generally available to interview prospective scholars who reside in their geographic region. The College anticipates that the number of prospective scholars interviewed by Board members may range between two and five.

Reports of the interviews conducted by members of the Board of Visitors are forwarded to a seven member Selection Committee which examines a variety of materials in selecting each class of Reagan Scholars.

Since its chartering, Eureka College has remained affiliated with the Christian Church (Disciples of Christ). This religious body continues to support and encourage the College, but it exercises no secterial control.

The College is committed to the development of persons who will be able to think for themselves and communicate effectively, who will be professionally competent, and who will be able to deal creatively, constructively and in an integrated way with questions of moral and religious value in their individual lives.

The achievement of the College's purpose and commitment demands an environment of educational excellence in which learning is respected and enjoyed.

The educational program is designed to help each Eureka student realize six goals:

- o To be familiar with a variety of areas of study providing some broad experience and understanding of the humanities, social sciences, natural sciences, fine and performing arts, and physical education
- To be proficient in the skills of communication including reading, writing, speaking, listening and mathematics
- To be competent in at least one academic and/or professional field
- To have experience in the process of studying basic issues and frames of reference regarding the problem of integrating knowledge
- To have participated in a community of living and learning leading toward the development of greater degrees of social awareness and responsibility
- o To have the opportunity to engage in a variety of co-curricular activities and programs for the purpose of personal enrichment; the productive use of leisure; appreciation and enjoyment; and service to the community.

These educational objectives are applicable to all Eureka College students. Reagan Scholars will be reviewed annually on the basis of these objectives. The results of this review determine whether a Reagan Scholarship is renewed for the next academic year.

Selection Process for Reagan Scholars

Candidates for the scholarships undergo a rigorous selection process.

Three general criteria guide the Selection Committee in making their decision.

The potential for effective leadership is determined on the basis of personality evaluations, the candidate's history of participation and leadership in various activities both in and out of school, recommendations and the results of personal interviews. The application and interview will attempt to uncover the quality of leadership exhibited by a candidate. Mere election to various posts does not provide adequate evidence of authentic potential for leadership.

Commitment to service is also determined on the basis of personality evaluations, recommendations and the results of personal interviews. In assessing this quality the Selection Committee will seek evidence of authentic concern for others expressed in an ability and interest in solving practical problems which face humanity.

Academic achievement is determined by examination of a candidate's secondary school record, including: grade point average, distribution of preparatory coursework among the fundamental areas of the arts and sciences, and the results of standardized assessment tests.

The personality evaluations testing and interviews required for consideration will be conducted on a regional basis, and scheduled as conveniently as possible for the largest number of qualified candidates. Expenses associated with the travel to testing and interview sites must be assumed by the candidates.

To be eligible for consideration a candidate must:

- o Have achieved academic standing sufficiently advanced to assure graduation from an accredited secondary school or its equivalent before August 15, 1983
- Be able to communicate effectively in both oral and written English.

The Selection Committee attempts to ensure an exciting mixture of Scholars from divergent backgrounds. No candidate will be disqualified on account of race, creed, sex, marital status, national origin or handicap.

Endowment Funds

Scholarships equal to the full cost of tuition at Eureka College will be provided by interest income resulting from an invested endowment created exclusively to support the Reagan Scholarships. In the 1982-83 academic year these costs total approximately \$3,350 per student.

Endowment principal of \$5 million should provide investment income sufficient to fund approximately 65 Reagan Scholars. Because tuition provides only one-half the total expense of a student at Eureka College, the scholarship fund will also direct monies equivalent to tuition scholarships into the academic program of the College. Phase I fund raising is scheduled for completion during the 1983-84 academic year.

Additional endowment funds will be necessary to extend scholarships to more than 65 students. Some annual growth in endowment principal will also be necessary to correspond with future increases in tuition at Eureka College.

Gifts Outside the Endowment

Individuals or organizations who do not prefer or who are unable to give to endowment may also participate in the Reagan Scholarship Program through the annual support fund.

Several special educational programs for the Reagan Scholars will be developed, such as foreign travel, business internships and guest lectureships. Gifts not related to endowment can be directed to these programs and expended during a specific period of time.

Some donors may also find it convenient and most meaningful to direct a one-time gift to some specific academic program at Eureka College, which will also serve in a general way to support the Reagan Scholarship Program.

Organization of Reagan Scholarship Program

The Reagan Scholarship Program is organized under the charter of Eureka College as granted by the State of Illinois in 1855. The Trustees of Eureka College, represented by the President of the College, have created three specific entities to assist in the establishment and management of the Reagan Scholarship Program. These are:

- o The Permanent Committee
- o The Reagan Scholarship Office
- o The Board of Visitors

The Permanent Committee for the Ronald W. Reagan Scholarship Program consists of no more than seventeen individuals. It is the mandate of the Permanent Committee to provide the leadership necessary to achieve required financial objectives, to advise the College on investment of funds associated with the Reagan Scholarships, . . . and to ensure that the Scholarship Program is meeting its original intent of providing special educational opportunities for young men and women with great potential for lives of leadership and service.

The Reagan Scholarship Office consists of an officer of Eureka College who is responsible for coordinating all fund raising activities, integrating the selection process for the Reagan Scholars with the ongoing admissions efforts of Eureka College, and assuring academic supervision and counsel to Reagan Scholars once they have been admitted.

The Board of Visitors is a group of no more than 100 distinguished and active business executives, political leaders, journalists, scientists,

members of the bar and others who are broadly representative of the decision makers and agents-of-change who build the future. Individual members of the Board of Visitors may advise the College on a variety of matters relating to the Reagan Scholarship Program, such as:

- o Selection criteria
- o Special educational programs
- o Career counseling for Scholars.

STATEMENT OF POLICY

RE: Additional Requirements for Reagan Scholars Date: October 15, 1982 (as revised)

Recipients of the Ronald W. Reagan Scholarships will be required to maintain the academic and disciplinary standards expected of all Eureka College students, as outlined in the catalogue and official documents of the College. In addition, Reagan Scholars will be required to meet the following standards to qualify for renewal of scholarship privileges:

- o maintain a grade point average of 3.0 or higher;
- o display to the College community the attributes of leadership, service and good citizenship which are inherent to the purpose of the Reagan Scholarships;
- o complete additional academic work and practica as outlined in this memorandum.

Standard Academic Requirements

Reagan Scholars may major in any academic program offered by Eureka College, or with institutional approval, may develop an individually designed major. A Reagan Scholar must maintain a 3.0 grade point average during each academic term. Unless medical or other extraordinary cause can be given, a Reagan Scholar must complete a minimum of 12 semester hours in a period of two terms.

Eivdence of Leadership, Service and Good Citizenship

The attributes of leadership, service and good citizenship must be assessed subjectively. Nonetheless, these qualities are at the heart of the Ronald W. Reagan Scholarship Program. Reagan Scholars will be counseled on a regular basis regarding their participation in community life and progress in meeting the expectations of leadership, service and good citizenship.

The Director of the Ronald W. Reagan Scholarship Program will have primary responsibility for this counselling. If in the judgement of the Director an individual Reagan Scholar is not meeting the expectations

of the Program, a Letter of Concern will be directed to the Scholar outlining as specifically as possible the areas in which the Director believes the Scholar is not meeting the high expectations of leadership, service and good citizenship required of Reagan Scholars. The Scholar will meet with the Director to discuss the Letter of Concern in detail, and to develop with the Director a course of action necessary to show the good faith of the Scholar in meeting the requirements of leadership, service and good citizenship.

After a reasonable period of time has elapsed following the issuance of the Letter of Concern, and the Director believes the Scholar has not shown sufficient progress in carrying out the course of action agreed upon, the Director may convene the Board of Scholarship Review. This Board will consist of the Director, President of Eureka College, Dean of the College and two members of the Eureka College faculty. The task of the Board of Scholarship Review will be to assess whether the privileges of the scholarship should be extended for another year to the student in question. The Board may direct that the scholarship should not be extended, or may take lesser action such as warning or establishing probationary measures.

Additional Academic Work

Because of the special nature of the Reagan Scholarships, and the outstanding potential of the Scholars, Eureka College has established additional graduation requirements for the Reagan Scholars. Reagan Scholars are required to satisfactorily complete 5 practica or seminars in the following areas:

- o political leadership,
- o business leadership,
- o communications and society,
- o international and multi-cultural issues,
- o problems in fulfilling human needs.

All of these topics will be offered in seminar format each May Term, a three week period following the close of the regular academic year. These requirements may also be completed as practica during the regular academic year or summer. Reagan Scholars are encouraged to work with the Director of the Reagan Scholarship Program to develop practica and internships. The

Scholarship Program especially encourages Scholars to complege the international and multi-cultural issues requirement through a directed foreign travel option. At least two of these topic areas will require completion at a time other than May Term, and may realistically call for the commitment of at least one summer to meet these additional graduation requirements.

We continue to experience widespread interest regarding the scholarships. Over 1200 young people have requested applications. Based on the personal interviews already completed we can be confident of the candidate's qualifications. Truly outstanding young men and women are interested in becoming Reagan Scholars.

The scholarship program is also having a telling impact on the regular admissions process. Our early contact with schools in Illinois and Indiana indicate the scholarships have enhanced the perception of Eureka in dozens of communities. By participating in the Reagan Scholarships many school personnel have become better acquainted with Eureka and better understand the type of student who will benefit most from our approach to undergraduate education.

Fundraising is also proceeding on schedule. We continue to be hindered, however, by the lack of strong outside leadership for the fundraising effort. Holmes Tuttle's illness has been difficult to overcome. We simply do not currently have access to anyone close to Mr. Tuttle's stature, who we could also trust to work in the President's best interest. Those people who are currently involved with us probably have too many hidden agendas for us to appoint any of them as chairman the Permanent Committee.

For our long-term success it is important we identify the chairman by the first of the year. The wait will be worth it to get the right man, but we cannot afford to wait too much longer. As you know Neil has mentioned Bill Wilson as a possibility, do you have any word on the status of his Vatican appointment?

I would appreclate the opportunity to discuss the leadership issue with you in detail quite soon.

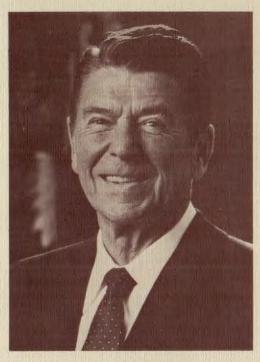

The stipend of a Reagan Scholarship consists of full tuition, approximately \$3,350 for the 1983-84 academic year. Additional financial assistance to cover room and board is available based on need.

Established in 1982, the scholarships are unique in their commitment to basing selection on evidence of leadership and an attitude of service on the part of the successful candidates. Intellectual distinction is also a necessary condition for selection, but is not a sufficient condition.

The extensive selection process is designed to identify those young men and women who have the greatest potential to advance the progress of humankind through dedicated service and leadership.

The scholarships are also unique in that Scholars will be encouraged to participate in directed learning activities during the traditional summer recess. These activities may include internships, foreign travel or individualized academic work.

Appointment to a Reagan Scholarship is made for one year. Renewal for three additional years can be expected as long as the Scholar's record at Eureka College warrants such continuation of the award.

In assessing this quality the Selection Committee will seek evidence of authentic concern for others expressed in an ability and interest in solving practical problems which face humanity.

Academic achievement is determined by examination of a candidate's secondary school record, including: grade point average, distribution of preparatory coursework among the fundamental areas of the arts and sciences, and the results of standardized assessment tests.

The personality evaluations and interviews required for consideration will be conducted on a regional basis, and scheduled as conveniently as possible for the largest number of qualified candidates. Procedure for Application

Applications from American and Canadian candidates must be completed and received by the Reagan Scholarship Office no later than December 15, 1982. Applications will be received from candidates residing outside the United States and Canada until March 1, 1983.

Prospective scholars are advised to begin preparing their applications well in advance of December 15. Some of the evidence and other materials required by the application process may take some time to gather. It is particularly important that prospective scholars notify the American College Testing Program (ACT) or the College Entrance Examination Board (SAT) that Eureka College should receive their test results. Applicants residing in the United States whose test results are not available to the College by January 21, 1983 will be at a disadvantage in comparison with other candidates.

The application will first be reviewed by the Committee on Admissions at Eureka College. If accepted for general admission, the application will be forwarded to the Reagan Scholarship Office for initial review. This office will also schedule all personality evaluations and interviews required of candidates.

The personality evaluations and some initial interviewing will be completed during January and early February. In late February the results of the evaluations and application essays will be reviewed by the Reagan Scholarship Office and

carefully selected readers. Candidates are then recommended by the readers to the Board of Visitors for personal interviews.

The Board of Visitors, a select number of national leaders, and College officials will conduct the interviews and recommend final candidates for consideration by the Selection Committee.

The Selection Committee consists of seven individuals. The identities of the Selection Committee members are kept in confidence. This committee reviews the applications, test results and reports of personal interviews in selecting up to twenty Reagan Scholars. The Selection Committee will complete its considerations in the early Spring. Selected Scholars will be notified as soon as possible thereafter.

Applicants who have been accepted for general admission are welcome to participate in other scholarship competitions at Eureka College. Finalists who are not selected as Reagan Scholars will automatically qualify for consideration for other college scholarships.
