Dear Mr. Ryan:

This is to follow up on my request for a meeting with the President on behalf of the officers of the Board of Trustees of Eureka College. Attending such a meeting would be Chairman G. Raymond Becker, Vice-Chairman John Bearce, Treasurer Burrus Dickinson, and myself.

In their spring meeting last May, the Trustees gave preliminary approval to establishing a capital campaign for Eureka College, extending over the next five years. The Executive Committee was authorized to review needs and establish goals for such a campaign. At the meeting in October, the Executive Committee reported back to the Board with a recommendation for a campaign for \$24,000,000 with the following specific ingredients:

- 1) Endowment \$10,000,000
- 2) Renovation & rehabilitation of existing facilities \$3,600,000
- 3) New facilities/improvements \$5,000,000
- 4) Annual budget support \$5,000,000
- 5) Campaign expense \$400,000

The Trustees named Messrs. Becker, Bearce, and Dickinson to serve as general Co-Chairmen of the campaign. They are now intensely involved in establishing campaign leadership, and will devote the 1988 year to personal contacts and solicitation of major gift candidates. No public announcement of the campaign is anticipated prior to February, 1989.

It is important that we have the opportunity to present this information to the President, both because of his general and continuing interest in Eureka College, and because of specific items related to him. Those items are:

Reagan Scholarship Endowment

An additional \$2.5 million in endowment to "fully" fund the Reagan Scholarship Program is being sought.

2) Reagan Museum and Conference Center

A modest but appropriate facility is planned to provide display space for materials related to President Reagan, including historical materials from his time as a student here, materials about him which he or others have sent to us through the years, and those artifacts which will be provided from his days in the White House. We do not have adequate or appropriate existing space for such a display on the campus. In planning for this, the Trustees have determined that the building should also service the general academic and programmatic needs of the College. It is planned to include a multi-purpose auditorium for general campus use, and a fully equipped conference center to attract academic, business, and other conferences or retreats to the campus, as well as service our existing programs. This building is planned at a cost of \$2.5 million.

3) Endowment to underwrite the operations of the museum and conference center

\$1.5 million in endowment is being sought, which will provide investment income to underwrite the operations of this new facility.

The Trustees have been aware throughout their planning that the President does not desire to have an expensive or elaborate museum built for him on the Eureka campus. His desires have been carefully pursued in the planning of this facility. It will be a part of the basic campus, will fit into the architecture of the campus, and will provide a badly needed asset in programmatic usage.

It is important that we have the opportunity to discuss this with him, and Chairman Becker and I appreciate the opportunity to talk with you about this in more detail. Thank you for your assistance.








## SITE PLAN EXISTING CAMPUS








SITE PLAN EXISTING ATHLETIC FIELDS








Over the past several years, you have sent memorabilia and mementos of your Administration to Eureka College.

Your guidance to them has always been that you did not want a special museum or facility built to house those items. They are currently on display in the school library and display cases on the campus.



Dear Mr. President/Ron:

In this letter I would like to update you on the capital plans of the College, and to seek your assistance on several items.

#### RE: Memorabilia Exhibit

We have accepted your counsel and have abandoned plans to construct a museum and conference center. However, there were items in that facility that are badly needed (auditorium, seminar rooms, meeting rooms). We also do need a more adequate space than exists in the library to exhibit the memorabilia which we already have and which we are now receiving from you from your days in Washington. Our answer has been to combine those elements with a second facility that was a part of our long-range plan - a campus center. This gives us one new building rather than two, and will meet many of the needs we have without the extra cost of a museum.

It is our intention to note that the "Ronald Reagan Exhibit" is housed in this new campus center, but we will make no reference to a museum, and obviously will not seek to construct an oval office, rose garden, etc.

#### RE: Washington Dinner

Eureka College would like to host a "thank you and farewell" dinner for you and Nancy in Washington this fall, with proceeds going to the Ronald Reagan Scholarship Program. Pursuant to your request, Counsel's Office has reviewed the above-referenced request for an appointment with the President. For the reasons noted below, Counsel's office recommends that Mr. Sabbagh's request to meet with the President be denied.

As you know, we are careful to limit Presidential involvement with even domestic donors to entities, such as Eureka College, with which the President is closely associated in the minds of the public -- for example, we keep the identities of those who donate money from the President. We are even more careful to limit any Presidential or White House involvement with foreign donors. Members of the public are naturally more suspicious of funding from foreign sources. Not only are they less familiar with those sources, but because they often identify foreign nationals with their governments, they have more serious concerns about the type of influence these individuals may be attempting to exert on the President. In situations like this one, these concerns are exacerbated by the absence of the more obvious motives often attributed to U.S. donors to colleges (e.g., concern for the quality of U.S. education, or gratitude for the education they or their children have received).

Please be aware that the National Security Council staff shares the view of Counsel's office that this request should be denied. In the event that a decision to allow Mr. Sabbagh to meet with the President is likely despite our advice, we strongly urge that our office and NSC staff be consulted before a decision to provide Mr. Sabbagh with such a meeting is made final.

Dear Mr. President/Ron:

Dr. Rolf Craft, Director of the Reagan Scholarship Program, has told me of his visit with you, along with some of the Reagan Scholars. I want to thank you again for your continued hospitality to the scholars, and your enthusiasm for the scholarship program and Eureka College. I know how much they appreciated the time and attention that you were able to give to them.

Dr. Craft told me of your concern about any possible reactions I, or others here, may have had to your feelings about a "museum" at Eureka. His report led me to worry that you had not seen my letter of April 14, which was submitted to you via Fred Ryan. That concerns me, because I understood through Fred's office that this had been given to you and discussed with you.

In that letter, I noted that the Trustees received with appreciation your comments regarding the proposed museum. That proposal was abandoned in accord with your request. We do need a more appropriate area to exhibit the memorabilia which you have sent and are sending, but have included that merely as one room in our plans for a Campus Center. The Center will also include badly needed space for student services, conference facilities, and an auditorium, and will free Burgess Hall for development of additional classrooms.

I totally understand your concerns about our previous plans. Both I and the Trustees appreciate your desire to focus on the museum in California, as well as your desire to retain the essential qualities of Eureka College which you have appreciated so long. The direction we are moving is appropriate for the College and is in support of your suggestions.

I watched with mixed emotions your address to the Republican Convention. The tribute was both thrilling and well deserved - for both you and Nancy. Your alma mater is extremely proud and grateful for all that you have given to your country and to the world in these past  $7\frac{1}{2}$  years - and for what you will yet accomplish before this term ends.

You have an enthusiastic invitation to return to the campus "neath the Elms" whenever that is possible. I still look forward to presenting the honorary degree to Nancy, on behalf of our faculty and Trustees.
