Dear Mr. Green:

This year the American Turkish Association of Washington D.C. will be hosting the Ninth Annual Convention of the Assembly of Turkish American Associations. Representatives from 39 local organizations will assemble in Washington, D.C. in May 1987, and as part of our program, we would like to request, once again, a White House conference or briefing to coincide with this event. Although we have had only two such meetings so far, the first one arranged by Mr. Linus Kojalis and held in May 1984, and the second arranged by you and held in May 1986, White House meetings have become the highlight of our convention program and are much appreciated by all. Further the impact of these meetings is not limited to the attendants as the information is widely disseminated throughout the Turkish American community through newsletters of various organizations as well as in Turkey as our annual convention is closely monitored by the Turkish Press.

We would appreciate it greatly if you can arrange another briefing for us on Friday, May 8, 1987 from 3-5 pm. Our members' concerns include political, economic, military, and trade relations between the United States and Turkey and any other "hot issue" on the President's desk that relates to Turkey. We had some problems at the door last year, mostly due to our inability to exclude members who had not provided proper ID information, but I can assure you we will be very efficient this year and submit all relevant information on time.

Finally, although I realize this is very unlikely, nonetheless I would like to raise the possibility of President Reagan addressing our group on May 8, 1987. I can assure you the impact of his appearance before our group will be extremely strong, with positive consequences throughout the Turkish American community in the States as well as in Turkey. I must admit that in the period I have served in my present position, I have not had an opportunity to meet with Turkish-American representatives. I would be most happy, therefore, to meet with you to learn about your community and to discuss issues of concern. Please call me at 456-2741 if you think a meeting would be useful.

Finally, I would like to thank you, on behalf of the President, for your kind words of support in light of the recent tragedy in Lebanon. Your concern is greatly appreciated.

Dear President Reagan:

I apologize for writing at a time of national tragedy and sorrow, but I would like to bring to your attention a matter which has greatly distressed the Turkish American community here.

We learned that there was not a single representative from our community in the Luncheon for Specialized Press held at the White House on October 18, 1983. We also learned that a number of questions were raised by Greek and Armenian representatives attending the luncheon regarding issues vital to Turkey and Turkish Americans.

There are over 40 local organizations in the United States representing Turkish Americans. Their umbrella organization, the Assembly of Turkish American Associations, is also located in Washington, D.C. Most of the local organizations have their regular publications, including the American Turkish Association of Washington, D.C. The national organization also publishes a regular newsletter.

The Turkish Americans in this country may not be large in number compared to other ethnic minorities, but we are a unique group. Most of us are professionals, such as physicians, scientists, engineers, architects, university professors, etc. We pay high taxes and greatly contribute to the scientific and technological advancements in this country as well as to its academic life and health care services.

We would respectfully request that we be given a chance to voice our concerns and respond to questions directly affecting us in such occasions as the Luncheon for Specialized Press held in the White House. If you need information regarding the Turkish American organizations, please contact me.

I would also like to take this opportunity to let you know that the Turkish American community here shares your grief over the tragic losses in Beirut and wish a safe and speedy solution to the problem there.
