2. SUMMARY: ALGERIAN EDITORIAL REACTION AND PRESS TREATMENT OF EVENTS IN LEBANON HAS BEEN, BY PAST STANDARDS, QUITE RESTRAINED. THE FOCUS HAS BEEN ON ISRAEL WITH LITTLE MENTION OF THE UNITED STATES. CONTRARY TO PAST PRACTICE ON SUCH OCCASIONS, WE HAVE NOT BEEN CALLED IN, AT LEAST SO FAR. END SUMMARY.

JUNE 7 ASSERTED THAT ISRAEL'S AIMS WERE TO:

(A) OCCUPY AREAS OF SOUTH LEBANON AND THEN WITHDRAW AFTER IMPOSING CONDITIONS,

(B) WEAKEN THE PLO TO PAVE THE WAY FOR THE SECOND PHASE OF CAMP DAVID,

(C) ISOLATE THE PALESTINIANS FROM THE LEBANESE NATIONALISTS,

(D) CREATE A FAIT ACCOMPLI BEFORE THE ARRIVAL OF HABIB IN ISRAEL.

4. A LENGTHY EDITORIAL IN THE JUNE 7 FRENCH LANGUAGE DAILY EL MOUDJAHID DEcriED THE FURTHER WARFARE IN LEBANON AND CLAIMED THE ISRAELI ATTACK WAS INTENDED TO COMPENSATE ISRAEL FOR ITS APRIL 25 WITHDRAWAL FROM THE SINAI. THE UNSC WAS BLAMED FOR NOT PROVIDING UNIFIL WITH HEAVIER ARMS CAPABLE OF PERMITTING THAT FORCE TO COMBAT ISRAELI AGGRESSION. THIS EDITORIAL ASSERTED THAT THE PALESTINIAN AND PROGRESSIVE FORCES WERE GIVING A GOOD ACCOUNT OF THEMSELVES AND THE ISRAELIS WERE NOT HAVING AN EASY TIME OF IT. THIS ITEM ALSO SPECULATED THAT HABIB WOULD ARRANGE ANOTHER CEASE-FIRE.

5. PRESS TREATMENT JUNE 7 AND 8 HAS FOCUSSED ON THE ALLEGED RELATIVE SUCCESS OF THE PALESTINIANS AND THEIR LEBANESE ALLIES IN STANDING UP TO ISRAELI FORCES. THE U.S. HAS BEEN LITTLE MENTIONED EXCEPT ON JUNE 7 WHEN MEDIA HERE CITED THE MIDDLE EAST PORTION OF THE NACB COMMUNIQUE WHICH STATED THAT U.S. SUPPORT WAS A DECISIVE FACTOR IN ISRAELI AGGRESSION.

6. COMMENT: WE FIND THE ALGERIAN REACTION RESTRAINED OVERALL, AND ESPECIALLY NOTEWORTHY FOR THE LITTLE MENTION MADE OF ALLEGED U.S. RESPONSIBILITY FOR ISRAELI ACTION. SO FAR, AT LEAST, WE HAVE NOT BEEN CALLED IN TO THE MFA, WHICH CONTRASTS WITH INVARIABLE PAST PRACTICE WHEN SIMILAR EVENTS OCCURRED. LONG-TIME WESTERN OBSERVERS HERE SHARE OUR JUDGMENT THAT THE REACTION HAS BEEN MODERATE.
