2. FOLLOWING PRIME MINISTER BEGIN'S PUBLIC APPEAL
LAST NIGHT, JUNE 8, FROM THE KNESSET TO SYRIAN
PRESIDENT ASSAD (REF A), ISRAELI MEDIA AND PUBLIC
DISCUSSION THIS MORNING ARE DOMINATED BY QUESTIONS
OF POSSIBLE SYRIAN INVOLVEMENT WITH IDF FORCES IN
LEBANON. THE ISSUE OF SYRIAN INVOLVEMENT SEIZES
ALL OF ISRAEL'S MAJOR NEWSPAPERS AND EVEN

EASILY WIPE OUT THESE GAINS. WAR WITH SYRIA, COMMENTATORS ARE SAYING, WILL LIKELY INVOLVE THE GOLAN HEIGHTS, THE GALILEE AND POSSIBLY BRING IN JORDAN -- ACTIONS WHICH WOULD THREATEN ISRAEL'S PEACE WITH EGYPT. CERTAINLY, COLUMNISTS ASSERT, A SETTLEMENT OF LEBANON'S PROBLEMS WILL BE EASIER WITHOUT A WAR WITH THE SYRIANS.

--
4. AT THIS STAGE OF MEDIA COMMENTARY AND PUBLIC REACTION THERE IS VERY LITTLE PUBLIC DISCUSSION CONCERNING THE POSSIBILITY THAT BASHIR GEMAYEL'S CHRISTIAN MILITIA MIGHT ACTIVELY SEEK TO LINK UP WITH IDF FORCES. SO FAR THE MEDIA ARE EMPHASIZING THAT THE GOVERNMENT'S GOALS IN LEBANON ARE LIMITED AND AIMED AT THE TERRORISTS. THERE IS CONCERN BELOW THE SURFACE, HOWEVER, THAT THE GOVERNMENT'S AIMS MAY BE BROADENED IN THE WAKE OF A RELATIVELY EASY VICTORY OVER THE TERRORISTS AND A FEELING THAT ISRAEL OUGHT TO EXPAND ITS ACTION WITH A VIEW TOWARDS REDRAWING THE POLITICAL MAP OF LEBANON. AT THE SAME TIME, HADASH KNESSET MEMBER MEIR WILNER (FROM ISRAEL'S COMMUNIST PARTY) BRIEFLY TOUCHED ON THE BASHIR QUESTION IN HIS KNESSET SPEECH YESTERDAY BUT HE DID NOT ELABORATE. HE REFERRED TO A MEDIA ANALYSIS SOME MONTHS AGO SPECULATING THAT THE IDF MIGHT SEEK TO LINK UP WITH BASHIR AS PART OF AN EFFORT TO REUNIFY THE COUNTRY.

5. THE MOOD IN ISRAEL CONTINUES TO BE TENSE WITH EVERYONE'S DAILY LIVES OVERSHADOWED BY DISCUSSION OF THE SITUATION IN LEBANON. RELATIVES NERVOUSLY AWAIT NEWS OF CASUALTIES AND THE ENTIRE COUNTRY VIRTUALLY STOPS EVERY HOUR TO LISTEN TO SKETCHY REPORTS BASED MOSTLY ON FOREIGN NEWS REPORTING OF THE IDF'S ACTION. SO FAR CASUALTIES ARE RELATIVELY LIGHT. PUBLIC DISCUSSION ABOUT THE PRICE ISRAEL IS PAYING FOR THE ACTION IS NOT EVIDENT. THE COUNTRY HAS PULLED TOGETHER AND ISRAELI CITIZENS FROM ALL WALKS OF LIFE ARE VOICING STRONG SUPPORT FOR THE GOVERNMENT.

THE SAUDI MEDIA WED JUNE 9 (AND THE EVENING BEFORE) CONTINUE TO GIVE EXTENSIVE PLAY TO BATTLEFRONT REPORTS ON THE ISRAELI INVASION OF LEBANON AND REPORTS ON INTERNATIONAL AND ARAB REACTION AND ACTIVITIES. NEWS OF THE LATEST U.S. VETO AT THE U.N. SECURITY COUNCIL CAME TOO LATE TO MAKE THE JUNE 9 PAPERS. SEVERAL PAPERS CARRY WIRE SERVICE ACCOUNTS OF REMARKS MADE BY PRESIDENT REAGAN AND SECSTATE HAIG IN CONNECTION WITH THE LEVANESE SITUATION. TWO PAPERS CITE NEWS AGENCY DISPATCHES FROM WASHINGTON THAT THE WHITE HOUSE AND CONGRESS DISCUSSED THE POSSIBILITY OF SANCTIONS AGAINST ISRAEL IF IT FAILS TO PULL OUT OF LEBANON QUICKLY. THE SAUDI PRESS COVERAGE, HOWEVER, FOCUSES ON BATTLEFRONT REPORTS AND ARAB AND INTERNATIONAL CONDEMNATIONS OF THE ISRAELI INVATIONS, WITH SPECIAL EMPHASIS GIVEN TO KING KHALID'S MESSAGE OF SUPPORT TO LEBANESE PRESIDENT SARKIS.

A. SAUDI EDITORIALISTS AND COMMENTATORS JUNE 9 EXTEND THEIR CRITICISM OF THE UNITED STATES TO INCLUDE THE SOVIET UNION. AL-MADINA EDITORIAL: " THE LATEST ISRAELI AGGRESSION AGAINST SOUTH LEBANON DID NOT COME AS A SURPRISE TO THE (PALESTINAIN) RESISTANCE MOVEMENT OR TO WORLD EXPECTATIONS...THE OVERRUNNING OF SOUTH LEBANON HAS NOTHING TO DO WITH THE ASSASSINATION ATTEMPT AGAINST THE ISRAELI AMBASSADOR IN LONDON. IT WARNED WASHINGTON ABOUT AN ISRAELI AGGRESSION AGAINST SOUTH LEBANON, SAYING IN A MEMORANDUM THAT THE SOVIET UNION WILL FIND ITSELF COMPELLED IN THE EVENT OF AN ISRAELI ATTACK ON LEBANON TO FULFILL ITS COMMITMENTS TO THE PALESTINAIN RESISTANCE MOVEMENT AND SYRIA.
