REAL GROWTH IN U.S. DEFENSE BUDGET

Background

As a candidate, President Reagan pledged to restore the defense capabilities of the United States. An essential element of this strategy was his proposal for a substantial real increase in defense spending.

In recent weeks, some confusion has arisen in the press about the degree to which the President's defense budget represents an increase in funding over the previous administration's proposed outlays. This <u>Issue Alert</u> seeks to clear up this confusion.

Analysis

- o Two major points:
 - -- Defense programs typically have long lead times, and thus defense outlays often lag total obligational authority (TOA) by one, two, or even more years. Therefore:
 - * Most of the FY 1981 and FY 1982 defense outlays were locked in place by prior obligations made under Carter; little of value could have been done to increase these outlay levels beyond what President Reagan secured.
 - * Much of the <u>outlay increase</u> under President Reagan will occur in the 1983-1986 period and beyond, at which time the earlier increases in TOA will be spent out.
 - -- The Carter budget projected higher inflation rates, and thus higher defense spending than what would have occurred under current inflation assumptions.

- * Using current inflation assumptions, the Carter defense budget TOA for 1982-1986 would have been \$61.2 billion below the level projected in his final budget, and his defense budget outlays would have been \$48.2 billion less.
- * Current inflation assumptions are more relevant than those in the Carter budget, and are used in all following comparisons.
- o In any case, the Reagan defense budget is significantly larger.
 - -- For 1982:
 - * TOA is \$19.5 billion greater.
 - * Outlays are \$2.8 billion greater.
 - -- For 1983 (with reduced Congressional budget resolution ceiling):
 - * TOA is \$29.9 billion greater.
 - * Outlays are \$6.3 billion greater.
 - -- For 1982-1986:
 - * TOA is \$231.3 billion greater.
 - * Outlays are \$122.4 billion greater.
- o Reagan defense budget growth rates are higher:
 - -- Carter budget TOA grows average of 5% per year (real terms).
 - -- Reagan budget TOA grows slightly more than 8% per year (real terms).
- o Reagan initiatives not in final Carter plan:
 - -- B-1 bomber.
 - -- AV-8B aircraft for the Marine Corps.
 - -- Two new nuclear-powered aircraft carriers.
- o Reagan program expansions:
 - -- Navy Shipbuilding Reagan plan for 1982-86 includes 112 new ships. Last Carter plan included only 80 new ships.
 - -- Air Force Tactical Fighters Reagan plan for 1982-86 includes over 500 more tactical fighter aircraft than the last Carter plan.

- -- Navy Aircraft Reagan plan for 1982-86 includes nearly 700 more aircraft than last Carter plan.
- -- Army Systems Reagan plan for 1982-86 accelerated procurement of both the new attack helicopter (AH-64) and the M-1 tank.
- o Year-by-year comparisons are given in the attachment.

No way any staffer can hand the Boss anything! It has to go through channels. A couple of very good guys recently came very close to being fired for circumventing procedures.

The two best ways to get it through are:

- 2. Sometimes guests here or V.I.P.'s meeting him elsewhere hand things over. Secret Service attempts to intercept such things and at least examine to see that there is no physical danger involved before it gets to the Boss's hands.

A couple of weeks ago, for instance, the Boss made personal calls to Paul Weyrich and Richard Viguerie. He recently popped into a meeting of pro-life activists I set up in Jim Baker's office.
