Thank you for your letter of May 17, 1983, informing me of your concerns about the President's Private Sector Survey on Cost Controls (PPSSCC) manner of conducting its task force review of the Veterans Administration and the Federal Hospital Management reports.

I share your concern on how these reports and their recommendations are being received by veterans groups and the general public. This Administration is committed to improving services for all veterans and the Veterans Administration, with its comprehensive benefits and medical care programs, is essential to achieving this goal. There is no plan to eliminate or otherwise reduce the effectiveness of the Veterans Administration with its tradition of service to our Nation's veterans.

As you may know, there are 36 task forces studying a wide range of issues to improve the efficiency and effectiveness of operations without adversely affecting services. The magnitude and interrelationship of the issues studied resulted in serious logistical problems such as those you cited. I apologize for the lack of availability of reports and the short timeframe in which to respond to specific reports. You should also know that every effort is being made to be responsive to your constructive criticism and that the PPSSCC has been made aware of your concerns.

I want to assure you that the task force reports on the Veterans Administration will in no way impair the operation of that Agency nor diminish the provision of benefits and services to veterans. This Administration has gone on record many times in the past as being a strong advocate of veterans affairs and will continue to ensure that the Veterans Administration provides the level and quality of service that veterans organizations and the American people have come to expect.

Please contact me if I can be of assistance to you in resolving future problems that may occur. I appreciate your concerns and look forward to working with the AMVETS to strengthen veterans programs.

Editorial

In the conduct of foreign policy, a nation can be guided by moral obligation or undiluted self-interest. With regard to Central America, both interests strongly compel the United States to take a much more supportive role.

It is suggested by some that the U.S. should adopt a "hands off" approach and allow the people of El Salvador and the rest of region to determine their own destiny. In the reality of the day, that is impossible. The cold reality of our time is that there are two powers in the world, each of which could impose its will anywhere on the globe if the other did not exist. The wishes and ideals of lesser countries have meaning only in relation to that fact. The destiny of Central America will be decided by the Soviet Union if the United States does nothing.

The Soviet Union, with the benefit of its Cuban, Nicaraguan, and other proxies, is actively seeking to conquer El Salvador and has promised to dispatch Guatemala, Honduras, Costa Rica and Mexico in succession. The only nation in the world that plausibly can prevent this is the United States.

Currently, the people of El Salvador are under attack by the troops of a foreign nation that is ruled by a nine member military junta. They braved the attacks from these terrorists in order to elect their current government. For their feeble effort at self-determination they have been rewarded with ceaseless sabotage of their economic structure and the terrorizing of their daily lives. The five million people of El Salvador cannot withstand the sustained onslaught of the Soviet-supported military machine. The United States can.

We presently have 55 advisors in El Salvador training the Salvadorans to fight against the 10,000 Sandinistan guerillas operating in that tiny country. Nicaragua has built an army of 75,000 men--thus outnumbering the combined forces of all the other Central American countries. Those 55 U.S. advisors, dedicated though they may be, are a small token of support from a nation that once inspired the hopes of millions of people; from a nation that, at one time, held true to the cherished Monroe Doctrine.

If the United States does not consider the Soviet agression in Central America to be a matter for serious concern, that aggression will be successful. The result will be all too familiar. As happened in Southeast Asia, and as is happening this very moment in Cuba and Nicaragua, there will be arrests and unjustified imprisonments. There will be censorship of media and speech, forced relocation, confiscation, "re-education camps," and perhaps some innovations in repression not yet conceived. We are morally obligated to provide the support necessary to prevent these injustices.

It has become fashionable among a people who no longer seem to appreciate their heritage to scoff at any notion of moral obligation. And, many conservatives hold that the only valid considerations in foreign policy are those of the interests of the nation. Yet, even if we cast

aside our moral obligation to prevent the subjugation of a helpless people, we cannot escape our own interest in the outcome of the events in Central America.

We need look no further than to our own desire for material and physical comfort to realize that these are threatened by communist aggression in our own neighborhood. The devastated economies, hostile neighbors and unsafe shipping lanes that are resulting from Soviet harassment will make life less comfortable in every state in the union. More importantly, it will make life less secure.

The strife in Central America is not, and cannot, be limited to the boundaries of the countries involved. The problem is hemispheric in scope and effect. What happens in South or Central America ultimately affects us, and with greater speed than a conflict in Asia or Europe. We are talking abour a war, an extremely volatile situation, right on our own continent. Most of these areas are closer to Washington D.C. and Philadelphia than Los Angeles or Phoenix are. As one Arizonan commented, "This will be the first war that I can drive to in my pickup."

Already the Southern states and major U.S. cities are feeling the effects of this conflict. With 10% of El Salvador's population already having taken refuge in the United States, problems are arising concerning employment, housing, food, and health care. As the conflict heats up and spreads to other countries, refugees will come by the millions. The burden of controlling crime and feeding the hungry refugees will not make life more comfortable for any American. The only prevention of this bleak prospect is immediate and substantial support for those fighting for their freedoms.

When the principle leader of the Sandinistas, Cayetano Carpio, claims that, "The revolutionary process of Central America is a single process. The triumphs of one are the triumphs of another...Guatemala will have its hour. Honduras its...Costa Rica, too, will have its hour of glory. The first note was heard in Nicaragua," can the United States safely stand by and watch? Can we repeat the cry, "No more Vietnams," with our heads in the sand while "Vietnam" grows closer to our borders? What of the equally important cry, "No more Cubas?" What of the Monroe Doctrine, or the American motto, "Don't tread on me?"

It may be unfortunate, but we have no options in this matter. We cannot allow the result to be determined for us as we stand powerless in our backyard. Whether we choose to be moral and compassionate, or selfish in pursuing our own benefit, the conclusion is the same: We must help defeat the Soviet aggression in Central America for our own sake and that of millions of our neighbors to the south.

Reagan Supports Parents Against Judges' Tyranny

WASHINGTON, D.C. In discussing the decisions to block parental notification by court tyrants Henry Werker and Thomas Flannery, President Ronald Reagan summed the matter up for some high school students recently.

"What about government interjecting itself into the family between parent and child?" he asked, according to the New York Times. "And saying, 'We, the government, reserve the right to do something of this kind in collusion with your children and we're not going to let you know about it'?"

He added that government had no right "to stick its nose into the family and tell parents what they can or cannot know about their children."

It's Not Just Us— Whole Earth Is Bloody

WASHINGTON, D.C. Census Bureau statistics reveal that communist countries are killing their unborn at a higher rate than the United States.

Here, one child is murdered for every three allowed to live—a 25 percent death rate. In Bulgaria, the rate is 45 percent murdered. In Hungary, the rates were nearly that high in 1970 but they have been cut in half thanks to a more restrictive law passed that year.

The lowest rates of the 22 nations examined were in Hong Kong and India, where only one

Compiled by Christopher Di-Sales and American Life Lobby staff. woman in a thousand consents to murder her own offspring. The American rate is 22 times more bloodthirsty and brutal.

The statistics were based on U.S., U.N., private and other government sources.

Despite Arrests, Scorn, Chicago 4 Saves Lives

CHICAGO. Joe Scheidler and three other pro-life activists have been acquitted of disorderly conduct charges stemming from their January 29 sidewalk counseling outside an abortion chamber.

In addition to Scheidler, director of the Pro-Life Action League, the activists are Jerry McCarthy, also of the league; Greg Morrow of Help for Women; and Andrew Scholberg, associate editor of *Primum Non Nocere*.

The four defenders of life immediately returned to the same abortuary after their acquittal and demonstrated that they had not been intimidated by the arrest or the harassment that went with it.

The operators of the clinic responded by locking their doors! The siege mentality ruled the day, as women seeking abortions could not get in, and women inside the abortuary were not, at least for a time, allowed to leave.

Undoubtedly lives were saved by this disruption of normal slaughter house activity—a victory far outshining the earlier legal triumph.

The January arrests were unusual for the intemperate actions of the police officers involved, one of whom admitted at the scene he had some sort of personal ax to grind:

"I'm a crazy man. I am a mad man. If my wife needed an abortion, I'd get her one here in a minute . . . ," he reportedly announced.

In between such outbursts, he observed the pro-lifers wantonly jaywalking and summoned 12 squad cars and a paddy wagon to help deal with this civic enormity.

Despite these and other such foolish actions and emotional remarks, the officer was described later by the judge as an exemplary policeman.

Sex Ed Texts Support Homosexuality, Abortion

MECHANICSBURG, PA. Texts used in sex instruction in your public schools may be worse than you fear, selling more than libertine sexual values and antifamily ideas.

According to A.L.L. correspondent Carl J. Jarboe, such texts in his southern Pennsylvania location teach students to view homosexual relationships and marriages as rights to be protected. Abortion is promoted by focusing on the mother's supposed concerns; the foul deed comes across as an obvious good that anyone should desire.

Rights Chairman Reveals Persecution of Familles

NEW YORK. Over 59 percent of New York City's landlords refuse to rent to families with small children, says Isaiah Robinson, chairman of the city's Commission on Human Rights. The penalty for this at present is a small fine.

Brennan Weds Secretary

WASHINGTON, D.C. Justice William Brennan, 76, one of the seven Supreme Court justices directly responsible for the deaths of millions, recently married his secretary a few weeks after the death of his first wife.

Kentucky Court Decides Murder Isn't Murder

FRANKFORT, KY. The Kentucky Supreme Court overruled a Court of Appeals decision that accused Robert Lee Hollis of murder by killing the child in his wife's womb with his hand.

Justice Charles Liebson defended the 5-2 overrule on the grounds that when "life begins is not the question."

In dissenting, Justice Donald Wintershiemer noted the testimony of the doctor who tried to save the child, who said "it was a living person."

"Stripped of its rhetoric," Wintershiemer said, "this matter is simply a brutal murder committed on a defenseless, innocent victim." The mother was in her seventh month of pregnancy.

Only Two Problems: Already Born, No Doctor

EBENSBURG, PA. "I only wanted to prevent future Justins," Cambria County coroner John Barron said.

Barron spoke of the conviction of William and Linda Barnhart on charges of involuntary manslaughter and endangering the welfare of a child, which stemmed from the death of their son, Justin, of stomach cancer in 1981.

Prevention, indeed, has been the lot of many infants since restrictions on abortion were wished away by the Supreme Court in 1973. A baby in serious trouble or even in good health

may be killed—if he has not yet been born, and if any state or local health standards are followed in carrying out the execution—such is the state of our nation's laws.

In the Justin Barnhart case, his parents denied him medical treatment after his cancer was diagnosed. Although the tumor was thought to be operable, Justin died at age 2.

The Barnharts believe that the Bible prohibits human medical treatment in favor of faith in God's healing. The prosecution argued (successfully) that the Barnharts' beliefs could not serve as a defense for abandoning the legal duty parents have to care for their children. Naturally, no parallel was drawn to the millions dying because of their parents' allegiance to the lifestyle ethic.

Over the Edge— Fornication Ed in Ontario

TORONTO. A law requiring sex instruction (under the guise of family planning) was passed by the provincial parliament of Ontario recently.

Pro-lifers opposed the bill,

but had a small last-minute victory of sorts when Ontario Premier Bill Davis modified it to allow Catholic and other private schools to set up their own instruction. These, however, must have the approval of a regional medical health officer.

If these schools don't come up with their own program, they will be forced to use the state instructions, which were developed by Ontario Planned Parenthood with, of course, favorable provisions about abortion and contraception.

Hypnotized as by a Snake, America Watches TV

A Lichter-Rothman study of TV's elite shows that two thirds of the 104 surveyed believe TV should be a major force for social reform.

Of the group, 59 percent were brought up Jewish, 25 percent Protestant, and 12 percent Catholic. Only 38 percent still call themselves Jews, 12 percent Protestant and 5 percent Catholic. Only four of the 104 attend church regularly.

Unsurprisingly, given these orientations, 97 percent believe
