

Dear Senator Lautenberg:

In response to your recent letter, we're writing to you today to reaffirm our support for Senate Joint Resolution 73.

You stated in your correspondence that you felt that there should be a separation between church and state. I thoroughly agree with you. This is the way our Constitution was set up and we both understand the necessity of this separation.

I fail to see, however, how this prayer resolution would alter the separation that currently exists. How can children's prayers of thanksgiving before eating, or prayers for comfort with friends do anything but strengthen the individuals who make up our public schools? And as you know, no one will be forced to pray and our public schools will not be allowed to read or have children recite state determined prayers. People will just be allowed to retain their basic freedom to talk to their Creator when they have the need.

Our magnificent country was established with a focus on God---and even our congressmen convene with prayer. (Will we soon consider this, too, a combining of church and state?)

Have we as Americans lost sight of the fact that prayer is the means by which things of magnitude get accomplished? Have the prayers of our leaders become just rituals instead of a true seeking of wisdom from God to lead, guide and protect us as a country?

If our legislators don't recognize the importance of prayer, how can our country maintain its position of strength and leadership?

God made you. God made us. And God made our precious children. He made us so that we can know Him and receive His guidance and comfort as we seek Him. Would you deny our children the right to His support and help throughout their day?

God has promised to pour out wisdom to anyone who asks (James 1:5). Since you, too, believe in prayer (as you expressed in your letter), I urge you now to allow God to establish your thoughts on this issue.

We pledge allegiance to our country "under God with liberty...for all". Our money proclaims our trust in God. We must keep this a reality in our country.

May you have peace of mind on this issue as you act as not only the servant of the people (73% of whom favor this amendment), but more importantly (and as all our elected officials should act), as a servant of God.

Your job is not easy. We understand that. You have been given special talents that allow you to function in your position. Our responsibility is to pray for you. Rest assured we will.

# 'Stay the Course' Now Applies in Lebanon

Now, in the wake of the murder of some 200 Marines in Lebanon, comes the time of testing for Ronald Reagan, first of all, as President; but it is also a time of testing for Congress.

We grieve for the families of those Marines who have been killed. We have known death from war in our own family. But no one ever guaranteed those Marines, their families, or the American public, that our presence in Lebanon would be without risk. No war ever is, and we are in the midst of a war in which the peacemaker suffers along with the antagonists. Our grief should not blind us to the realities of the world situation which has made our presence there necessary, and which has not changed because of their tragic deaths.

There will be three choices, all of them hard, facing the President and Congress:

1. **Withdraw the Marines.** The voice of the wimps is already being heard proposing this "solution." Such a course plays into the hands of the Syrians and their Soviet arms suppliers. Should the President choose this seemingly easy move, the following consequences would occur: Lebanon would fall and be swallowed up by Greater Syria. To forestall this, the Israelis, already beset with economic difficulties and a war-weary fallout from last year's incursion into Lebanon, would have two choices: 1. Invade Lebanon and complete the job left unfinished last year. 2. Cut a deal with the Russians. Unthinkable? Itzak Shamir, the new Prime

Minister, has already made overtures to the Soviets to renew diplomatic relations. Should the Israelis believe it necessary to invade again, a predictable result could be World War III. Withdrawal, then, is not a viable option for the United States.

2. **Retaliate.** The Marines are superbly equipped for offensive operations against an enemy. But who is the enemy in Lebanon? The Maronite Christians, the Druzes, the Syrians, the PLO, the Iranians? All are on the scene, shooting at each other and at our men. The situation is much like that in Algeria in the 1950's, where the French could not tell friend from foe. The difference is that we are not trying to impose America on the Lebanese — that is, if there is such a thing as a Lebanese. The objective of terrorism, ever since the days when the British installed the Grand Mufti in Jerusalem in 1920, is to kill off all the moderates on both sides. It is a tactic often successful, extremely difficult to defeat. No, blind retaliation is not the answer.

3. **Stay the Course.** We are in Lebanon — along with the Italian and French peace-keeping forces — for the following reasons: A. To prevent Syrian — and hence, Soviet — domination of the Mediterranean littoral. B. To safeguard Israel, whose people have been through one Auschwitz in this century already, and who would face another if overrun. C. To show that we have not utterly wasted the \$30 billion we have poured into Israel — exclusive of private Jewish donations from America — since 1948. D. To prevent Egypt from falling back into the

Soviet orbit. D. To keep the other Moslem nations from cutting a deal with the Soviet Union if it is perceived to control the Middle East. This would result in complete chaos in oil distribution, which would affect Europe and Third World nations far more than us. E. To prevent the Moslem majority in Lebanon from slaughtering the Christians — or vice-versa. The post-World War II compact is, if not dead, at least moribund.

These are powerful, compelling, necessary reasons for staying the course in Lebanon. They constitute the foundation of our presence there. The overriding need to persuade the world that, after a decade of retreat and humiliations which has put millions of people under the Red heel, the United States has returned to the world arena, fully armed in spirit and body, to prevent any more of it from slipping into the murderous grasp of the Masters of the Gulag. Lebanon is a rallying point where we declare: "No more Afghans! No more Cambodias!" (Just as is our thoroughly justifiable presence in Central America.) We are, under this President, informing the world that the tide has turned, that "the irrevocable correlation of forces" in favor of the Soviet Union's program of world takeover, of which Leonid Brezhnev bragged — and because of which he brandished his missiles and invaded other lands with impunity — is finished. Like it or not, the United States is — and must be — back in the onerous, dangerous game of saving the free world from dissolution, because there is none other to do so. We must, therefore,

"Stay the Course."

We think the President will choose to take the third option, to do the right thing. But he will have to deal with a more than wimpy Congress — as the chorus of defeatists already shows — which shifts and sways with every nuance of leftist propaganda from our increasingly surrender-prone media.

Should Congress order an end to the peace-keeping force in Lebanon, it will cause a Constitutional crisis in which the President, for the sake of world peace and, ultimately, our own survival, must — and probably will — defy Congress in the end.

The people of this nation, if properly informed of the true, vital stakes in the Great Game for the control of the world — which is precisely what the Soviet Union has made of it — will back the President in a firm but prudent course: Hang in There! Why? Because those who would destabilize the Middle East seek, through terror tactics, to force our withdrawal.

Stay the course, Mr. President! In an earlier age, Admiral Farragut said, "Damn the torpedoes; full speed ahead!" You are faced with a similar situation today. Only a strong and courageous response — the maintenance of our presence in the Middle East, will keep alive the slim chance of bringing peace to that beleaguered area. Failure to do so will bring a bloodbath, followed by our isolation from the entire world.

Stay the Course! There is no other!



# 'The Right Thing'

If a squadron of Soviet Backfire bombers were suddenly to appear on a newly-built airstrip in the Caribbean, directly athwart the sea-lanes through which most of our imported oil comes, the reaction in Congress, the media and the public would be immediate: "Mr. President! Why didn't you prevent it from happening?"

If 1,000 Americans were suddenly taken hostage — as in Iran — following the bombing murders of the Marines in Beirut, the same glib chorus would arise: "Mr. President. Why didn't you prevent it?"

Well, the President has done just that in authorizing the invasion of Grenada. The reasons he has given for this invasion are absolutely valid, but underlying them is the strategic imperative that the United States cannot afford to have another major Soviet base in this hemisphere which could directly interdict our supply lines, either in the event of a war or another OPEC cutoff of oil.

The chorus of opposition was totally predictable. Our "Establishment" media and leftist politicians would rather see the entire Caribbean basin and Central America go Communist, rather than for the United States to protect its own vital interests, as well as those of the other small nations in the area which are threatened by Cuban/Marxist subversion.

When the elected government of Grenada was overthrown by the Marxist Maurice Bishop four years ago, he immediately began installing a dictatorship on the island which was turning it into another Cuban Gulag, complete with 'revolutionary block commit-

tees' and arming children. Last week he was ousted by an even further-left group, which promptly proceeded to murder him.

To his credit, Mr. Reagan seized the opportunity to restore democratic government to this small land — at the urgent request of other small island nations in the region who felt the hot breath of Fidel Castro on their necks. But the overriding issue is strategic: Shall the Soviet Union have another major base in the Caribbean. Not so? Then why, for months, has a top Soviet general, identified as being a member of the Soviet high command — right under Defense Minister Dmitri Ustinov — been based on this tiny isle of no alleged strategic significance?

Mr. Reagan, to his great credit, bit the bullet despite the predictable howls of outrage from 400 North Broad street and all those other way stations to Dzerzhinsky Square. In doing the right thing, he demonstrated the "right stuff," so much in the news these days.

It will not be easy for Grenadians to restore peace and democracy. But at least, thanks to Ronald Reagan, they now have the opportunity to do so. By his swift and vigorous action he has restored the credibility of the United States as a guarantor of freedom in the Western Hemisphere, so blithely and self-righteously thrown away by former President Carter. Surely even a dumb, blind, wimpy Congress can see that this President has sent a message to the Kremlin: "As long as I am in office, the American retreat has ended."

Bravo, Mr. President! At last, we have a man in the White House!



# The Education of 'Tip' O'Neill

House Speaker 'Tip' O'Neill, in his inimitable fashion, last week said that he would oppose the Administration's continuing aid to freedom-fighters — he calls them rebels — seeking to oust the now-openly-Communist regime in Nicaragua. Mr. O'Neill later backed up his words by leading a successful vote against Nicaraguan covert action in the House. On the other hand, Mr. O'Neill has supported our involvement in sustaining the shadow government that rules only Greater Beirut. (The valid reasons for being in Lebanon are listed above.)

Who is Mr. O'Neill kidding? Surely not the realists in his own party; nor the President; nor anyone who thinks seriously about foreign affairs. Of course, this is the same Speaker O'Neill who came back from a trip to Red China burbling about how they had "educated" him on foreign policy.

"I believe there is a sharp difference between what the administration is doing in Lebanon and what it is trying to do in Nicaragua," pontificates Speaker O'Neill. Indeed there is: In Lebanon we are shoring up Israel, on the one hand; on the other we are positioning ourselves to maintain our oil interests in the Persian gulf. The survival of Lebanon itself is peripheral, and not in itself vital to the United States.

In Nicaragua, however, the situation is totally different. We are confronted with an admittedly Communist government whose

national anthem is a "Hate America" paean, whose rulers boast of a "revolution without borders" as they seek to extend Marxism to El Salvador and the rest of Central America who torture and jail their citizens in manner far worse than any conceived of by Anastasio Somoza; who are supplied by Russia, Cuba and the entire Soviet bloc for their adventures and who, if successful, will destabilize Mexico and send millions of refugees over our borders.

Presidential Advisor Faith Ryan Whitlesey, speaking to the Main Line Chamber of Commerce last week, laid out the Administration's case for defending Central America from Communist subversion. She is persuasive; it's too bad that "Tip" O'Neill wasn't there to hear her because he just might — as he did on returning from Red China — intone: "She educated me." He needs it.

In the aftermath of the KAL 007 shootdown six weeks ago, it was hoped that a number of Representatives in both parties, previously cool to aid to the freedom fighters in Central America, would change their minds and refuse to back Mr. O'Neill in a showdown on funds. That hope was in vain, as last week's House vote showed. But then, that latest Soviet atrocity is already "yesterday's news," which is down the "memory hole" of "unfortunate incidents" to be consigned to

oblivion.

And all the time the Communists are showing their true face, not only in Central America but in Afghanistan, where the slaughter of patriotic Afghans continues without mercy.

It is no wonder our foreign policy is a shambles, with "Tip" O'Neill and his like-minded cohorts obstructing the United States in its efforts to restore national integrity and preserve the freedom of this hemisphere.

Unless and until we have a Congress which supports a President determined to defend America's true interests, we will have a continuation of the growth of the Soviet Empire in the Western Hemisphere, until its agents are on our borders demanding our surrender. It is likely, now that the economy is flopping for the Democrats as an issue, the 1984 election campaign will be fought out on the twin issues of foreign-defense policies. On that campaign will depend our future survival.

Just when will Mr. O'Neill's education be complete: when he's up against the wall?



As requested at the August 24, 1983 meeting of the Subcommittee, I am submitting these views on H.R. 3231 and S. 979.

During the past days, Americans have been confronted with yet another illustration of the nature of the conflict between East and West in the world today -- the Soviet downing of the passenger airliner near Japan. This murderous, intentional act of the Soviet Union resulted in the assassination of Congressman Larry McDonald, called by many the "leading anti-communist in Congress," and the death of 268 others.

This virtual act of war must once again and for all time show the Soviet Union as the totalitarian, expansionist enemy of freedom that it is.

There can not be "business as usual" with the Soviet Union or its client states, now established not just in Eastern Europe, but around the world.

Congressman Larry McDonald was a strong exponent of tough and effective controls on the export of goods and technology to those who would use them against us. In my view, neither of the bills now pending in the House or Senate, provides adequate safeguards to control these exports, and especially now, the liberalization of controls on exports to the Soviet Union would make a mockery of the 269 lives taken by the military weaponry of the Soviet Union.

In response to the murder of these Americans and other innocent persons from around the world, President Reagan needs broad powers to respond, including both military and nonmilitary options. The statement by Tom Christiansen to the Subcommittee calls the provisions in H.R. 3231 and S. 979 which would limit the President's ability to impose foreign policy controls "beneficial". In my view these proposed shackles on the President's power being promoted by Mr. Christiansen are not "beneficial" but destructive in the extreme of America's national interests.

The President must have the power to impose these controls at his discretion, as envisioned by Article II of the United States Constitution. The President must be able to act boldly in response to the war-like acts for which the Soviets have become well known. The 535 members of the United States Congress must not be asked to make our nation's foreign policy on a day-to-day basis, or the very survival of our country in the perilous times which lie ahead will be jeopardized.



Weakening our President's ability to impose foreign policy controls endangers peace in the world. I, for one, do not want to see our President forced to choose between the limited choices of hot war or acquiescence in Soviet aggression. A wide range of nonmilitary sanctions must be available to enable him to act on behalf of the vital national interests of the United States.

Further, the provisions of both the Senate and House bills would elevate the importance of the foreign availability of goods to a nonsensical level. These provisions would weaken our government's ability to impose controls when even a single allied nation chooses to export to the East similar commodities to those being controlled by the United States.

We cannot lead the Alliance while being governed by this "lowest common denominator" approach. Our foreign policy cannot be absolutely limited by the foreign policy decisions of other countries, or our sovereignty in these matters would be handed over to others and our position of leadership in the world would crumble.

A fatal flaw present in both bills is their rejection of the creation of an Office of Strategic Trade, as envisioned in Senator Garn's initial Export Administration legislation. I still believe that this is the single most important reform which should be implemented in order to insure that our national interests are given preeminence in vital export control decisions of our government.

I strongly urge that the Subcommittee recommend to the President's Export Council that it endorse Senator Garn's initial Export Administration legislation and reject H.R. 3231 and S. 979 because they contain provisions which would dangerously weaken our nation's export controls at a time when America cannot afford to be weak.







As an applicant for the position of Assistant Director for Energy, Agriculture and Natural Resources, I would like to bring to your attention some information that does not appear in biographies or resume's that illustrate an awareness, or perhaps even an expertise, of the constituencies and issues affected by this position.

As a Secretarial appointee at the department of energy, I developed program strategies and implementations to bring the conservation and renewable energy office into compliance with Administration policies.

Raised on a farm, I had no difficulty communicating with the agricultural community and its leadership as a congressional nominee. During the 1980 campaign, I assembled a number of these leaders, including several serving in statewide and national leadership positions, to draft a position paper that was presented to the Republican Platform Committee. Senator Dole was so impressed that he asked me to remain for the mark-up of the agriculture plank. Senators Dole and Helms were two of my sponsors when seeking a position in the Administration.

My experience in environmental matters is limited to that of a conscientious hunter, fisherman, sportsman, outdoorsman and designer of buildings with minimal disruption to the environment. I have been a member of both the National Rifle Association and the National Wildlife Federation. I served as a Director of the Sportsmen's Alliance of Michigan, and my wife was an assistant naturalist with Seven Ponds Nature Center, an Audubon affiliate. 

SUBJECT: Regional Outreach Briefings on Central America

On Friday afternoon, December 2, I met with Otto Reich and others of his State Department colleagues regarding our planning for White House outreach briefings in selected major United States' cities. We left in agreement on the following points:

1. The State Department Public Affairs Office would arrange for co-sponsorship in each city. Co-sponsors would be groups such as the World Affairs Council, the Chamber of Commerce, Kiwanis, Rotary, etc. The idea is to find sponsors that would not be identified with either end of the political spectrum but towards the center.
2. The invitations would be from the White House and, depending upon the speakers, would read something like: "The White House Office of Public Liaison, the U.S. Department of State, the U.S. Department of Defense and the Agency for International Development, in cooperation with the Pittsburgh World Affairs Council and the Greater Pittsburgh Chamber of Commerce cordially invite you to attend a briefing on United States policy in Central America."

*would invite its usual list of invitees. In addition, the White House would issue invitations*

3. ~~The list of invitees would be initially provided by the local sponsoring organization. The list would be submitted to the White House to make~~ sure that the major opinion leaders in each locality are included. This would include the prominent educators, clergy, union leaders, business leaders, and local editors, publishers, and broadcasters. The idea here is for the invitation list to reach out beyond those normally invited to foreign policy briefings.



4. Target cities. We plan eventually to cover all twenty-four of the cities we have been discussing for some time, but we will start with one pair of cities. Either Philadelphia and Pittsburgh, or Cincinnati and St. Louis, depending upon the availability of appropriate sponsors.
5. Sponsors. For the first pair of cities, we will not shoot for "superstars" such as Secretary of State Shultz, or Secretary of Defense Weinberger, but will go for a reasonably balanced team of three sponsors, one each from the defense area, the diplomacy area and the development area.
6. Funding for the hall will be provided by the local sponsoring organization. Each agency will fund the travel expenses of its personnel. ~~The invitations will be issued by the White House.~~ *(delete; previously covered in paras 2 & 3)*
7. Scheduling. Otto Reich's office will coordinate this with the State Department Bureau of Public Affairs, in consultation with the White House Office of Public Liaison and other appropriate offices. It was agreed that we would not schedule any cities in the month immediately prior to each respective state's Presidential primary. The first pair of cities would be covered in mid-January, after which we would evaluate this pilot and make appropriate changes in procedures.

All in all, it was a very successful meeting. I expect that we will, by the end of next week, have obtained sponsors, sites, and speakers for the first two cities Outreach Briefing.



The Inter-American Savings and Loan Union, a trade organization for savings and loan associations in all of Latin America and the United States, is extending an invitation to you to be the principal speaker at its annual meeting which, this year, will be held in Miami, May 7-10. Your special interest in Latin America, in home ownership, and the high priority you are giving to the Western Hemisphere in your present foreign policy are special reasons that would favor your acceptance of such an invitation, and the Union would be greatly pleased at your favorable response.

The Union meets annually in various countries, usually in Latin America, and it is customary that the President or Prime Minister of the host country address the Assembly. Last year, the meeting was held in Spain, (the only time outside of the Western Hemisphere), and there was a reception hosted by the King of Spain, Juan Carlos. The year prior to this, the annual conference was held in Lima, Peru, and was addressed at its opening session by President Fernando Belaunde Terry. The Board of Directors of the Union met in Bogota, Columbia, several months ago, and President Belisario Betancur met with our group for over an hour. A meeting of the Executive Committee was held in Tegucigalpa, Honduras, also during the past year, and President Policarpo Paz Garcia and a number of the members of the Honduran Congress met with the group there.

The Union has not met in the United States in the last ten years, and the conference this year in Miami is a very special event for the Union and for the housing industry. Your appointee, Chairman of the Federal Home Loan Bank Board, Ed Gray, will be one of the official hosts at the conference, along with the housing industry trade associations.

In my capacity as United States representative on the Executive Committee for the Inter-American Savings and Loan Union, I urge that you join us in Miami next May.
