I would like to get a GED so that I may someday do more than live from day to day on the money that I make.

Problem:

I am working at the Seattle Indian Center as building security. My position is funded through CETA, Title III, Section 302 -- that your Administration is cutting. This has been a useful experience for me; this program should be kept up so that others like me can have a learning experience that will be of value to them in their lifetime. I understand that a new program being dreamt of will be directed to mostly the young, what will happen to people like myself who did not have the opportunity years back to get a good education?

Summary:

Is it your goal to chase the 'Indians' back to their reservations where there are no jobs, housing, schools, food? It would seem that this is where you are turning us. There are many, many of my people living off our reservations trying to scratch a living out anywhere we can.

Please consider 'cutting us a little slack', instead of cutting us from every program we need to survive.

Dear President Reagan:

The time is now for you to make a firm policy statement against federal court ordered forced racialbusing of school children. The public is well aware that Congresshas the constitutional authority to strike down forced racialbusing as a "tool" to remedy federal court ordered desegregation. The proper and acceptable constitutional remedy is open school enrollment.

The short time that the Federal Judge "Ayatollah" Battisti and the NAACP have taken over the Cleveland School System with their forced racial busing and other desegregation programs, the Cleveland School System went broke spending some two million per month for a total of eighty-five million dollars to-date.

In 1977 the Judge "Ayatollah" Battisti publicly berated the Cleveland School Board for projecting exorbitant cost for his desegregation remedy. He also be-littled them for claiming there would be massive "white flight" if his forced busing remedy were enacted. The Judge "Ayatollah" Battisti claimed that his studies found no evidence of "white flight" to the suburbs because of forced busing.

To-day----the Cleveland School System has lost 50% of its enrollment. Half of the school buildings are empty, boarded-up, and for sale. The black enrollment is now 80%. The daily absentee rate for Junior-Senior High Schools is 30 to 35%. 70% of the pupils drop out of school befor reaching grade twelve.

In Cleveland the local PBS-25 TV station had a morning program requesting the viewers to call in their vote on Forced Busing. 5,000. black families call into the station and 65% were against forced schoolbusing. 17,000 white families called, and 95% were against forced busing.

The is the opportune time for you to state publicly: No one has the right to force you to segregate, or force you to integrate. Any federal employee practising forced integration or segragation will be removed from office. This statement now will curtain the use of race as a political ploy, and activate Congress to pass the pending anti-busing measures to liberate the public schools from federal intrusion.

Psychologists' Massive 10-Year Study Reveals . . .

Forced school busing failed to meet its goals in a school system that's actually a model of its kind for the nation.

And if it didn't work there, it's unlikely to work anywhere in the .U.S. where approximately 14 million stu-

dents are bused to school.

That's the startling conclusion reached by two top psychologists who spearheaded a team of nearly 100 researchers in a massive 10-year, \$1 million study they originally thought would demonstrate the effectiveness of school integration in Riverside, Calif.

"It's a failure," concluded Dr. Nor-man Miller, professor of social psychology at the University of Southern California. "The busing program did not accomplish its aims of improving minority academic performance - or most of its other educational goals.

"And if it didn't work in Riverside, then it's unlikely it could work in other

cities."

Dr. Harold Gerard, co-director of the project and professor of social psychology at the University of California at Los Angeles, agreed.

"The Riverside program had a lot going for it," he said. "It had considerable community support. So if busing didn't pan out there, it ought to fare worse in most other cities."
Added Dr. Miller: "Busing will not

work - in some ways by itself it's

harmful.

From the National Enquirer - July, 1976

"We found minority children were happier before busing than when they were being bused. They didn't adjust well emotionally and suffered from anxiety, tension and stress. Plus, the increased competition from whites made it harder, not easier, for minority children to get good grades."

In their just-released book, "School Desegregation," which summarizes their findings, the two psychologists

also report that:

 Minority children don't become better achievers or show increased academić performance when integrated with whites.

They weren't motivated to try

· Both minority and white pupils tend to racially isolate themselves and minority children suffer increased tension, anxiety and lessened selfesteem.

The professors' government-backed investigation focused on 1,750 children half of them black and Mexican-American and the other half white. Since Riverside was a "model" busing program with little racial antagonism, both professors candidly admit they had hoped to demonstrate busing was a good thing.

But we found just the reverse -

the basic goals which school busing were supposed to achieve just haven't been met," Dr. Miller told The EN-QUIRER.

"We were very surprised to find things didn't work out as we expected they would," added Dr. Gerard.

"Educators thought minority children would be motivated to do better and that they'd perform better academically," Dr. Miller recalled. "Instead, we found the busing program had no effect. Even after several years of desegregation the achievement gaps remained.

There have been numerous riots, beatings and stabbings on these public vehicles, not to mention the abuse that the regular passengers are subject to. (All of this goes unreported)

In the schools also, there is this terrible misconduct. It seems the students are running the school, not the administration. Incidents such as racial riots, rapes and beatings also go unreported.

The news media will not print or report anything regarding busing. Just what has happened to Freedom Of The Press?

Many parents, like myself, are devastated every morning that their children leave for school. We actually fear for their well-being. The children themselves do not like to go to school anymore. This is not a healthy attitude for the future leaders of our country.

I feel that my rights as a parent have been taken from me.

The parents hate it, the students hate it, so why must we be forced to accept busing?

It is in lieu of this letter that I truly hope you support the Hatch Bill S-1760, the East Bill S-1647 and the Mottl Amendment HJR-56.

Dear President Reagan:

We are an affiliate of the National Association for Neighborhood Schools (NANS) We have received a warning from our national office that the Department of Justice is coming up with its own "anti-busing" legislation to be presented to Congress for consideration. Further warning is that this legislation is likely to be a re-hash of the 1974 Equal Educational Opportunities Act, which listed a "priority of remedies" federal courts were asked to consider before deciding on forced busing as a remedy. Thus, forced busing would remain as an "alternative" the courts could use.

This approach would do nothing for existing orders and only promises a slowing down at best of future orders. And it even naively assumes that future Justice Departments will take an "anti-busing" position before the courts. The approach is nothing more than an attempt to defuse the push for stronger legislation in the Congress.

No, we want legislation that will totally stop this tyranny...and that will stop it in cities where it already exists.

"THE HATCH LEGISLATION HAS GREAT ANTI-BUSING LANGUAGE UNTIL THE END." D'ONOFRIO MAINTAINS S. 1760 "GUTS ITSELF AS CONCERNS ITS EFFECT ON EXISTING BUSING ORDERS" SPECIFICALLY, THE POSITION OF NAMS IS THAT EVEN THOUGH IT LIMITS LOWER FEDERAL COURT JURISDICTION, S. 1760 ALLOWS TOO MUCH LEEWAY FOR FEDERAL JUDGES TO CONTINUE TO ORDER FORCED BUSING AS A REMEDY FOR PAST DISCRIMINATION IN DISTRICTS ALREADY UNDER BUSING ORDERS.

THE SECOND ANTI-BUSING PROPOSAL IS S. 1647. SPONSORED BY SENATOR JOHN EAST (R-NC). EAST GOES FURTHER THAN HATCH IN THAT SECTION 3 OF S. 1647 REMOVES THE JURISDICTION OF LOWER FEDERAL COURTS TO ORDER ASSIGNMENT OF TRANSPORTATION OF A PUBLIC SCHOOL STUDENT "FOR THE PURPOSE OF ALTERING THE RACIAL OR ETHNIC COMPOSITION OF THE STUDENT BODY ... OR FOR ANY OTHER PURPOSE."

AT THIS TIME NANS LEANS TOWARD SUPPORT OF THE EAST PROPOSAL BECAUSE ALL AFFILIATES NATIONALLY STAND FIRM THAT NAMS CANNOT ENDORSE LEGISLATION UNLESS IT BAILS OUT THE 300-PLUS SCHOOL DISTRICTS NOW UNDER COURT-ORDERED FORCED BUSING. HOWEVER NANS IS NOT COMPLETELY SATISFIED WITH EITHER BILL. NEITHER TAKES THE STEP OF REMOVING APPELLATE JURISDICTION OF THE SUPREME COURT OF THE U.S. ON THE MATTER OF FORCED BUSING AND THUS BOTH BILLS NEGLECT THE CLEAR POWER OF CONGRESS TO DO SO UNDER ARTICLE III, SECTION 2, CLAUSE 2 OF THE CONSTITUTION.

AT THE MOMENT, IT APPEARS LIKELY THE FULL JUDICIARY COMMITTEE WILL BEGIN TO HEAR THE PROPOSALS IN EARLY FEBRUARY.

IN THE HOUSE, HJR 56, THE ANTI-BUSING CONSTITUTIONAL AMENDMENT SPONSORED BY CONGRESSMAN RON MOTTL (D-OH), WHICH IS HELD HOSTAGE IN COMMITTEE, HAS 203 SIGNATURES ON A DISCHARGE PETITION TO FORCE IT ON THE FLOOR. 218 SIGNATURES ARE NEEDED.

Our children have to get up at 6 a.m. to go stand on a dark corner at 7 a.m. to get a I hour bus ride across town and then in the afternoon spend I hour to get home. They will be doing these for 7 of the years they attend school. How has the 2 or 3 hours each day on the bus helped their education when their former schools were only 5 minutes away.

HOW HAS THE LAW OF THE LAND COME TO MEAN THAT A CHILD MUST BE REF-USED ADMISSION TO A SCHOOL SOLELY BECAUSE OF HIS RACE.

Dear Mr. President,

This is the fourth time I have written you. I received a reply from the first letter but it came from the Dept. of Justice. I feel sure that the other letters have been sent to them for an answer. I am writing to share my concerns with the President of the United States and not merely to have my letter wind up on the desks of those in your Adminstration who either oppose or are lukewarm to Congressional efforts to stop forced busing.

One of the reasons that you were elected President of the United States is because the people believed what you were saying. You stated your opposition to forced busing. The Republican platform has a plank that opposes forced busing. Yet, your pept. of Justice is continuing to seek system wide busing in Lubbock, Texas. Why is this being pushed along with cities such as St. Louis, Chicago, and many other cities across the nation? Today you said that "social issues" would be handled as soon as you have something on your desk to sign. Congress has shown it's lack of action on this issue in the past. When you want something passed, you go to the people. Now thw people are coming to you. We see your aides saying that you will not lobby Congress for anti-busing legislation. Max Friedersdorf was quoted in Time magazine as saying this. This is only a few examples of the things that your top aides and your Justice Dept. are doing to prevent the passage of legislation that would stop forced busing. A list of others are enclosed.

You have met with such proponents of forced busing such as the NAACP and the Urban League. You met with the " gay rights" people and militant feminist movements but you refuse to meet with the leaders of NANS, the foremost national anti-busing organization in the nation. Why do you refuse to meet with the leaders of an organization that represent the views of 81% of the American people? It is noy enough, Mr. President, to say that you are "opposed" to forced busing. I want to know what

Examples of the things the President's aides and the Justice Dept. are doing to prevent the passage of anti-busing legislation.

1. Edwin Meese III stated on national television that your Adminstration "is not looking favorably" at attempts to strip the courts of the authority to order busing.

2.Assistant Attorney General William Bradford Reynolds, Head of the Civil Rights Division, stated at his confirmation hearings that he opposed

stripping the courts of jurisdiction to order busing.

 The Department of Justice prepared a memorandum opposins legislation aimed at stripping the courts of jusisdiction to order busing.

4. The Department of Justice issued a position paper opposing congressional efforts to prevent the department from using its apportations to advocate and pursue busing orders in court.

5. Robert Mc Connell, the Justice Department's chief lobbyist, reportedly had to be restrained from lobbying the Congress in favor of racial

balance busing.

The Constitution, under Article III, clearly provides that the Congress may make exceptions and regulations concerning federal court jurisdiction on matters such as forced busing. The Supreme Court has upheld that power of Congress when used on other constitutional questions in the past. The Justice Dept. is working to keep Congress from using the powers given to them to stop forced busing.
