Dear Mr. President:

We sincerely hope that you will find time in your busy schedule to read our letter and perhaps even send us your answer.

Very briefly about our family - we moved to the United States about 12 years ago from a Communist/Socialist country. We consider ourselves very lucky to be able to live and work in the United States which we feel is the best country in the world.

Upon our arrival our total wealth was about 98 dollars. Both of us worked hard and, in our opinion, achieved a lot. We have achieved so much because we had the greatest incentive - freedom of choice. We have chosen to make our home in St. Louis County for many reasons, of which quality of education in the local school district was one of the most important.

We are gladly paying very high school taxes for this district, and we wish to continue to do so, as well as we wish for our daughters to get their education right here in our neighborhood where they feel happy and comfortable. We will not allow for them to be bussed daily for many miles into unfamiliar surroundings and deteriorated schools with inferior education.

We feel that a great deal of effort and money is spent on a totally wrong solution for the school desegregation problem. The situation is now getting out of control as the threat of forced bussing is becoming more and more a reality. After months of trying unsuccessfully to involve all the St. Louis metropolitan school districts in a voluntary bussing issue, the Federal Judge William Hungate has now ordered a mandatory desegregation program which will result in bussing of 75,000 students.

We understand the complexity of the whole question, and the need for every child to get a proper education, but the result of forced bussing is simply reversed discrimination. We are sure that this is not the first letter by concerned parents . sent to you, but we felt that we should let you know our opinion as well.

Last election we voted for you. Besides many other views that we agreed with you, you also stated that you oppose forced bussing.

As it seems right now, there is a great need for you to reaffirm your position on this issue. We are aware that the decision on bussing at this moment is left up to each state, but it seems that the federal judicial system is used to change the decision of the people and curb our freedom of choice as to where our children will be going to school.

If and when the forced bussing effects our family, we will under no circumštances agree to it.

Last but not least, we feel that we should not be deprived of the greatest tool of democracy - voting on the important issues that will decide our own future and the future of our children, because without that, democracy will be no more.

We thank you for your time in reading this letter and we hope you will pardon its length.

We petition you to sign <u>House Discharge Petitions</u> for House Joint Resolution 234 (Mottl, D. Cleveland) and for H.R. 4479 (Mc Donald, D. GA) to prohibit federal judges from ordering students to leave their friends and attend public schools outside their own neighborhood. Forced Busing for "racial balance" violates the 9th, 10th and 14th Amendments of the U.S. Constitution. It violates the Supreme Court's 1954 decision in "Brown vs. Board of Education" which reversed 50 years of public school policy of "separate but equal." 90% of the American People oppose this discrimination against children because they are "black" or "white." Justice is blind as to race.

House Discharge Petition # 1 has already been signed by 197 Representatives. 21 more are needed. <u>H.J. Res. 234</u> provides the following Amendment to the Constitution: "Section 1. No student shall be compelled to attend a public school other than the one nearest his residence. Sec. 2. The Congress shall have the power to enforce by appropriate legislation the provisions of this article; and to insure equal education. opportunities for all students wherever located." <u>HR 4479</u> will insure the equal protection of the laws and protect the liberty of citizens as guaranteed under the 14th Amendment by eliminating Federal Court jurisdiction over forced school attendance: "Pursuant to article III, sections 1 and 2, of the United States Constitution, no court of the United States shall have the jurisdiction to make any decision, or issue any order, which would have the effect of requiring any individual to attend any particular school."

Racism is a crude form of collectivism. Its most pernicious aspect is the effect on the children who are caught up in it. It consists of treating people as members of racial groups instead of as individuals based on their own talents and abilities. Busing increases racial tensions. If we wish to attack racism, we must eliminate race as a standard for determining anything. This means we must eliminate Government-imposed quotas and "affirmative action." The first to go should be the most insidious: Assignment of children to public schools on the basis of their race.

Discriminating against today's school children in no way corrects past discrimination. No one would advocate that a man's son pay for a crime committed by his father; yet in regard to racial discrimination, a militant few believe that guilt is collective and is passed on from one generation to the next. This policy of Court ordered "race conscious" school assignment to remedy past discrimination is illegal. Equal Protection of the Law is not afforded to those children forced to attend a particular school because of their race. In fact this is precisely what the Supreme Court held in the Brown case when it out-lawed racial discrimination and ordered admission to the public schools on a nonracial basis. Congress agreed when it passed the <u>Civil Rights Act of 1964</u> defining "desegregation" as "The assignment of students to public schools and within such schools without regard to their race, color, religion, or national origin; but 'desegregation' shall not mean the assignment of students to public schools in order to overcome racial imbalance."

Battisti jails school board officials

By Annette V. Tucker U.S. District Judge Frank J. Battisti ordered Cleveland school board President John E. Gallagher Jr. and Treasurer Paul Yacobian jailed by federal marshals yesterday until paychecks for 31 desegregation employes were released to desegregation officials. Battisti found Gallagher and

Yacobian in contempt of court for

Battisti ruled yesterday, "There is no doubt, so long as (Waldrip) stays within budget, that the administrator's authority to hire includes the authority to set salaries.... The defendants once again have insisted on reading this court's orders in the most convoluted and distorted fashion possible."

Throughout the two-hour hearing, a visibly agitated Battisti

Battisti said, "If the court allows such a latitude to the board they could set standards that could actually and thoroughly frustrate desegregation."

Mark O'Neill, lawyer from the State Board of Education, argued the board had a right to question the reasoning behind Waldrip's fiscal policies. He said failure of the board to abide by Waldrip's orders was not failure to abide by court orders.

Battisti responded, "I didn't appoint an administrator then add a paragraph saying, 'Now all of you may nitpick this man to

failing to approve about \$127,000 in personnel costs and \$16,000 in consultant fees sought by desegregation administrator Donald R. Waldrip.

Battisti immediately ordered a red-faced Gallagher and Yacobian taken into custody by three marshals, who were waiting in the back of his courtroom. The two school officials were handcuffed

interrupted and questioned each speaker.

Battisti called the school system fiscally irresponsible and said its administrators had a commitment to failure of desegregation.

When Teresa Demchak, a lawver for the NAACP, argued that Waldrip's budget should be more carefully monitored by the board.

In his decision finding Gallagher and Yacobian in contempt, Battisti promised to review at another time the administratordirected pay raises.

Gallagher and Yacobian were released shortly after 1 p.m., when the paychecks in question had been delivered to Waldrip's lawyer, Richard L. Boylani

Outside the Old Federal Building, Gallagher sputtered angrily, "The reason we were thrown in jail, present this contain crimi-nals, in house Frank Battisti's Montana fishing buddy was not granted the pay increase that Waldrip Ordered

and led to a holding cell, where they were held for about 25 minutes.

Lawyers for Gallagher and Yacobian, who endorse paychecks to school system employes, had argued in the hearing that Battisti's June 19 ruling, guaranteeing Waldrip's right to hire per sonnel without board approval, did not grant authority to grant pay raises or promotions.

Gallagher was referring to Robert Cope, a consultant to the schools' athletic program, who met Battisti during one of the judge's fishing trips to Montana several years ago. Cope stands to gain \$11,000 a year from Waldrip's pay hikes.

The June 19 order has been appealed to U.S. Court of Appeals 6th Circuit.

School board lawyer George Meisel filed an appeal of yesterday's decision minutes after it was rendered.

Dear President Reagan:

I am just starting a fifth year in which I am paying nearly \$1,000 to keep our child in private school rather than endanger her life on a wild ride on a school bus on Cleveland freeways to a school miles away where she can no longer get an education because our schools have been destroyed. The teachers cannot, dare not, discipline, and our money for books, equipment and personnel has been thrown away on the whims of dictators - a school in which she would not be safe because of the lack of discipline.

I just read where a federal judge in St. Louis ordered 18 county school districts to be involved in St. Louis busing by naming them defendants, without ever a day in court. The same thing happened several years ago in Wilmington, Delaware. I just read that the courtappointed desegregation dictator in Cleveland ordered pay raises, for his people and that the school treasurer and school board members have been summoned to court for possible contempt-of-court charges for rebelling against our tax money being spent this way without school board authorization. (He hired these people without school-board authorization too, and the federal judge here ruled he had the authority to hire without board approval.)

It goes on and on and on. For all these years I have been unable to buy the necessary things for our household...because I have spent the extra money on tuition and helping to support the National Association for Neighborhood Schools (NANS) - trying to stop dictatorship trying to get those we elect to do their jobs.

The news media refuses to admit we exist. We have to spend money to be our own news media with flyers, a recorded phone message, etc. We have to spend our days and nights passing out flyers and working on fund raisers to support what we do.

People have told me they will not write to their senators and congressmen because they are afraid of the government. Teachers sneak us a dollar or two and tell us they are afraid to even write a check to us for fear of their jobs. We sold candy to raise money, and people were afraid to fill out an order for the candy. A local grocery chain offers "benefit days" to organizations and gives 5% of one's grocery order to that organization. The customer presents an authorization slip which he must sign. A teacher told me yesterday she couldn't do it because she had to sign this slip - and whispered to me, "I work for the school board." Priests and pastors say to us, "We agree with you, but we can't say anything, you know." We hear, "I wish I could help, but I am afraid of my job." We hear, "It won't do any good. Politicians do what they want." We try to get people to register to vote. Many refuse because they are afraid. That is true, Mr. Reagan.

Why won't you meet with NANS officers and help us plan how we can end this disaster immediate You have met with our enemy. Why worry about the economy and the federal budget if we allow our nation to fall to dictatorship and our schools, containing the future of this nation, to be taken over and used for purposes that are un-American. Why worry about protecting our shores with military might and allow us to fall within. How can you allow a situation in which Americans are afraid to even work for what should be their rights?

Please give this issue priority attention. Please meet with NANS officials. This is a personal letter, but I am enclosing a sheet of our letterhead.

Dear President Reagan:

We take due note of the fact that you traveled half-way across the nation to speak to the NAACP Convention, only to receive jeers and boos. Since NANS has been unsuccessful in getting just 10 minutes of your time in the Oval Office, the least we can expect is that this letter be read in its entirety.

We don't mean to be discourteous or disrespectful, Mr. President, but the time has come for some plain talk. And we can't make it any plainer than this: we've just about had it with the Reagan Administration.

After nearly a decade of federal court and Justice Department wreaking havoc with the St. Louis city's educational system, last year the court mandated forced-busing within that city's 61 square miles. That court order also contained the threat of expanding forcedbusing to include THREE huge counties west of the city for a total of 1,786 square miles. Why, that's just shy of the size of the whole state of Delaware - and once and one-half the size of Rhode Island!

About the same time last year, the Republican Party passed a strong platform plank, with YOUR fervent blessing, against forced-busing. We KNOW that plank caused the vast majority of citizens in the St. Louis metro area to cast their ballots for YOU and other Republicans in our state (Governor, Attorney-General, and TWO NEW Republican Congressmen). Indeed, while pro-busing Senator Eagleton would be loathe to admit it, the anti-busing stand taken by his relatively unknown Republican opponent, Gene nearly cost him his Senate seat. NCPAC agrees.

So, you were elected. And before you took office, Carter vetoed the Justice Department appropriations bill because of the Helms antibusing amendment to it. YOU announced YOU WOULD HAVE SIGNED IT. We took HIGH HOPES from that.

We were expecting some prompt action in Congress. But instead, Senator Baker asked that we "please, be patient" — the budget cut legislation was of paramount importance. The "social issues" (that's busing, according to Baker) would be put on the back burner a while.

O.K. We kept up our fund-raising activities (profits sent to NANS lobbying fund), letter writing campaigns to Congress, petition signing (nearly 100,000 signatures obtained during 4 winter months. Ask Danforth).

The budget legislation passed with a whopping majority. Now, on to the social issues, right??? Wrong.

You were laid now with an assassin's bullet in your chest. And while you were away from the White House (while the cat's away, the mice will play), those good ole' boys in the Justice Department came up with a "free" (costing millions to our state's taxpayers, however) college tuition incentive (bribe) plan as their input to the St. Louis case. That plan got such bad press across the nation you hardly hear of it anymore. Good thing for you, too, because it was labeled the "Reagan Administration Plan." We have serious doubts that you even knew what was in the works; we can't imagine that YOU would lend YOUR NAME to such a plan to plunder our state's treasury.

Upon your recovery, we once again were asked to be patient. The tax cut legislation is of paramount importance, and the "social" issues were kept on the back burner. The tax cut package, like the budget cut bills, passed with an overwhelming majority. And you left D.C. on a well deserved vacation. . And while you were out on your ranch, we were here on ours, telling people the Reagan Administration wouldn't let us down, quoting comments by Attorney-General William French Smith, leading Republicans in the House and Senate. And on Friday, August 14, came our favorite quote from the St. Louis Post Dispatch, "President Reagan has taken a personal interest in the St. Louis public schools desegregation case, presidential counselor Edwin Meese III says."

But wait, while you were away from the White House, the Justice Department mice were at play again.

Front page, St. Louis Globe Democrat, August 18, "THE REAGAN ADMINISTRATION, rejecting pleas from Missouri officials, urged the U.S. Supreme Court NOT to hear an appeal of court-ordered desegregation of St. Louis schools." This urging, according to the Globe, comes from Assistant U.S. Attorney-General William Bradford Reynolds.

WHAT'S GOING ON??? Who is this guy, Reynolds??? Is he on your team or not??? What is the Justice Department afraid of??? Are they afraid to have the Supreme Court take a good, close look at our state's case??? That's how it appears to us.

We just can't believe that the REAGAN ADMINISTRATION would seek to deny our state its day before the Supreme Court, OR OPPOSE OUR STATE IN THE SUPREME COURT IF THE CASE IS HEARD. Is your administration out to do something FOR US or TO US???

From all outward appearances, you seem to have a better handle on Congress than you do on your own Cabinet.

As far as Reynolds is concerned, he's been making comments about legislation to outlaw forced-busing which are in direct conflict with your own personal statements and position, not to mention your platform. He should be (if not fired) at least taken behind the woodshed and set straight. We gave you a new broom, but a few corners appear to remain unswept.

We're beginning to feel the aftermath (nausea) of all these roller-coaster rides we've been treated to these past months and our patience is diminishing rapidly.

The threat of expanding mandatory busing draws closer with each day; forced busing of children in 41 school districts. We haven't even had our day in the lower federal courts yet, and the way Reynolds is acting, YOUR Justice Department might make moves to prevent even that.

We're not the only American community suffering the onslaughts of the federal courts and the Justice Depart. Americans across this nation are waiting for YOU to take some action to restore their freedom to send their children to neighborhod schools.

Here in the St. Louis metro area, we've raised over \$10,000 in 8 short months to pay lobbying costs in D.C. to help YOU fulfill YOUR platform promise. And in return, we've received nothing but lip service from a few in your administration, and a knife in the back from YOUR Justice Department.

WE BEG YOU not to leave D.C. again, not even for Thanksgiving or Christmas. Lord knows what YOUR Justice Department would do to us and you in your absence.
