SUBJECT: Presidential Determination for Afghan Refugee Resettlement

Issue

Whether to sign the determination at Tab A designating Afghan returning refugees as eligible for assistance under section 2(b)(2) of the Migration and Refugee Assistance Act (MRAA).

Facts

Section 2(b)(2) of the MRAA provides authority to contribute to Afghan refugee assistance inside Afghanistan provided that you designate such refugees as appropriate for assistance and determine that assistance to them will contribute to the foreign policy interests of the United States (Tab B).

Discussion

On January 28, 1980, President Carter determined that Afghan refugees in Pakistan are eligible for assistance and that assistance to them contributes to the foreign policy interests of the United States. The United States has made direct contributions to various programs and also provided \$16.1 million through voluntary organizations.

We anticipate that nearly one-third of the 3 million Afghans who are refugees in Iran and Pakistan will begin returning to Afghanistan in 1989. The current authorization is applicable only to assistance to Afghans resident in Pakistan. Contributions to voluntary organizations, who will play an important role along with UNHCR, cannot be made without your determination that such assistance can also be extended to Afghans resettling inside Afghanistan.



In accordance with NSDD 766, Nicholas Rostow, Legal Advisor to the National Security Council, has coordinated this determination with A. B. Culvahouse prior to its submission to you.

United Nations High Commissioner for Refugees

The United States at private voluntary organizations will play an important role in the repatriation of Afghan refugees. We can provide direct contributions to voluntary organizations if under Section 2(b)(2) of the Migration and Refugee Assistance Act that assistance to Afghan refugees returning to Afghanistan and to internally displaced persons will contribute to the foreign policy interests of the United States. At present, we have such authority only to assist in Pakistan.

PRESIDENT: I am pleased by the upturn in our relations. Even though I recognize that areas of difference remain between us, I believe we have learned to manage those differences in such a way as to prevent damaging the overall relationship. Progress has been particularly heartening in economic and defense areas. I understand the Cray supercomputer will come on line soon. I hope its use will make us better prepared to meet natural disasters, such as the flooding we are now witnessing in northeast India. The United States will continue to seek ways to improve our growing defense relationship.

I am pleased that my Science Advisor, Bill Graham, will be in Delhi on October 3 to finalize the Science and Technology Initiative.

We believe India has acted with wisdom during the weeks following the death of President Zia, and we hope India will continue on this course with specific agreement on confidence building measures with Pakistan. I believe that President Zia genuinely sought improved Indo-Pakistani ties. I am hopeful that Prime Minister Gandhi will be able to continue the dialogue with President Zia's successor to lessen tensions in South Asia. I want to assure you that our aid to Pakistan is not intended against India, and that the United States remains committed to improved Indo-U.S. relations.

We understand India's concern about a possible fundamentalist regime in Afghanistan. However, we do not believe that the present government legitimately represents the Afghan people as a whole and do not foresee it lasting much beyond the Soviet withdrawal.

I have appreciated Prime Minister Gandhi's support on the INF Treaty. As the Prime Minister knows, I have made major efforts to reverse the arms race culminating in our agreement with the Soviets to eliminate our land-based INF missiles, and in progress toward 50% reduction of strategic weapons. We believe that the presence of nuclear weapons in South Asia would not serve the security interests of either India or Pakistan. We urge both countries to find ways to prevent the introduction of such weapons.

RAO: Thank you for finding time to see me. I heard your UNGA speech and thought it very good. I appreciated greatly the points you made.

I am grateful to you for initiating the process of improving our bilateral relations. The process started with Mrs. Gandhi and has continued after her. Bilateral trade figures are encouraging as is high technology trade. The Prime Minister is very satisfied. With regard to outstanding matters, we hope to resolve these over time. You have started a process which will help us resolve problems. We are very happy regarding the new atmosphere in U.S.-India relations and the personal rapport.

We are cooperating in stopping drug trafficking - India serves as a conduit for drugs and millions of dollars worth are moved annually. The PM has stated his appreciation for your efforts in initiating a new process. India and the U.S. stand for something today - freedom and democracy. We have so much to work on jointly.

PRESIDENT: Our Coast Guard is interdicting more drugs than in the past. We are launching a campaign to educate users. There are 12,000 "Just Say No" clubs in schools in the United States.

RAO: On Indo-Pakistan relations, you are for better understanding between India and Pakistan. I do not see a single reason why we should have poor ties. There are bound to be some differences but the common areas are so many. We have the South Asian Association for Regional Cooperation which has made remarkable progress in four years. Looking forward to this year's summit in Pakistan and to moving in new directions. There is a great opportunity and a challenge. We want to leave an atmosphere of better relations for future generations.

PRESIDENT: Let me reiterate how saddened I was at the death of my good friend President Zia ul-Huq. He was a leader of exceptional talent and a statesman of historic stature.

We are impressed with President Ishaq and the smoothness of the transition as it continues to move the country toward the elections called by President Zia.

We are pleased with President Ishaq's commitment to continuity in Pakistan's foreign policy, including the determination to continue to support the Afghan resistance in its fight for independence and self determination. We want to continue working with you in this effort, including securing a strong UNGA resolution on Afghanistan.

Aerial attacks from Afghanistan on Pakistan are part of a desperate Soviet campaign aimed at intimidating you and lessening your support for the Afghan Freedom Fighters. As you know, we have deplored these attacks publicly and expressed our serious concerns to the Soviets repeatedly at high levels. We have reaffirmed to the Soviets our commitment to Pakistan's security and made clear that such attempts to intimidate you will not succeed. We also have rejected Soviet allegations that Pakistan and the U.S. are violating the Geneva accord on Afghanistan.

Let me assure you that the U.S. remains fully committed to helping Pakistan strengthen its economy and modernize its defense forces.

However, Pakistan's adherence to the agreed nuclear restrictions and red lines will be critical in the months and years ahead so that the U.S. can proceed with necessary assistance. I will be required to certify to Congress shortly that Pakistan does not possess nuclear weapons.

I was pleased that the Government of India responded correctly to the tragedy of President Zia. I hope that Prime Minister Gandhi and President Ishaq can move toward improved relations. I will be giving the same message to the Indian Foreign Minister.

YAOUB: I am honored to be the last high ranking Pakistani official to meet with you. Pakistan and President Zia - who held you in high esteem - have deep gratitude for your policies of the last 8 years toward Pakistan and beyond. These will go down in history. Your UNGA speech will echo in that hall for many years to come.

President Ishaq appreciated receiving your two helpful, supportive letters. The delegation led by the Secretary of State to the Zia funeral was warmly received and was a tribute to a man who was close to your country and worked for achievement of a relationship of which we can all be proud.

Afghanistan has a global impact beyond Pakistan. Geneva is a benchmark in international relations in recent times. President Ishaq's reply, which I am carrying, contains gratitude for assurance of U.S. support for Pakistan's independence and territorial integrity, which enables us to pursue a policy that is in the interest of peace in region. The Soviets cannot believe the security of Pakistan can be threatened with impunity and U.S. demarches have a good effect. The letter mentions that the Soviets are trying to intimidate Pakistan. They are on a losing streak and making daily air raids hoping they will shatter our resolve. I will be seeing Mr. Shevardnadze on Thursday and will be proposing an outline with a suggestion of a broad based government in Kabul. Our purpose is not to humiliate the Soviets but also not to allow them to win the victory through negotiations that they did not win on the battlefield. We will recommend that Najib be replaced by a neutral figure. The Alliance leadership of Mujahidin will then select the Prime Minister. The PDPA will not participate in the government as a party but individuals from the group could be in the government. An election commission will oversee elections following Soviet troop withdrawal.

SHULTZ: What is reaction of the Peshawar Alliance?

YAOUB: The GOP has not formally put the question to the Alliance. We shall do so if the Soviets approve the proposal. In the meantime, the 38 F-16s in Pakistan's Air Force have orders to stand up to Soviet air raids and are fully deployed on missions to guard the frontier. The GOP is requesting 11 more F-16s as part of FMS with expedited delivery to relieve the strain of border duty. The AIM-9Ls have run into infrared countermeasures. The GOP is requesting 40-50 AIM-9Ms for increased effectiveness against raids. The AWACS request is there but we know we must go to the new Administration and the request will take time.

We are hoping for a Consensus Resolution on Afghanistan in UNGA. The Soviets have agreed but we are working on specific language. The GOP is hoping to move toward a comprehensive settlement in Afghanistan post-Soviet troop withdrawal.

On the nuclear issue which you have raised, I want to let you know that right up to the end (I was with President Zia talking about the issue the night before the fatal crash) President Zia wanted to reassure the U.S. that Pakistan would not do anything to embarrass the U.S. or the President who has done so much for Pakistan. This is a friendship which has stood the test of time and Pakistan's stand on the nuclear issue will not change, irrespective of which government follows President Zia.

On India, we shall continue to try to improve relations. The GOI sent an impressive delegation to the funeral. I'm hopeful that despite a stormy path we will have positive results. It is in our interest and the GOP will launch a peace offensive with India.

We see signs that Iran wishes to enter the mainstream of international life. Pakistan will work to help normalize Iran's relations with countries of the Gulf. The signs are propitious for improved Iranian relations with the West.

In closing, let me thank you for receiving me and convey my condolences on the death of Ambassador Raphel which is deeply grieved in Pakistan. He was a personal friend whose loss I deeply mourn. Ambassador Oakley is greatly welcomed in Pakistan and doing fine work and no one has been better received by my Government.


