2. REFTEL DESCRIBES ISRAELI BOMBARDMENT OF BEIRUT LAST NIGHT, JULY 28. I ASKED THAT IT BE BROUGHT TO YOUR PERSONAL ATTENTION. LAST NIGHT'S ISRAELI ACTIONS DEMONSTRATED GRAPHICALLY THAT QUESTIONS OF "CEASEFIRE VIOLATIONS" ARE IRRELEVANT. AS I AM SURE YOU UNDERSTAND THIS IS ISRAELI "PRESSURE" ON BEIRUT. THE WORD PRESSURE IS, HOWEVER, A EUPHEMISM FOR MASSIVE PHYSICAL DESTRUCTION AND FAIRLY INDISCRIMINATE KILLING AND MAIMING OF HUMAN BEINGS, BOTH LEBANESE AND PALESTINIAN. AS REFTEL MAKES CLEAR, THE ISRAELIS DELIBERATELY DELAYED A CEASEFIRE BECAUSE THEY SAID IT COULD NOT BE ARRANGED BY 2100 HOURS AND THEN ESCALATED THEIR BOMBARDMENT. I BELIEVE THAT IT IS IMPORTANT THE UNITED STATES MAKES IT ABSOLUTELY CLEAR, BOTH FOR THE BENEFIT OF ISRAEL AND THE ARABS, THAT WE UNDERSTAND WHAT IS HAPPENING AND THAT WE ARE NOT PARTY TO THE CYNICAL USE OF VIOLENCE (WITH U.S. -SUPPLIED WEAPONS) WITH ABSOLUTELY NO REGARD FOR THE HUMAN COST. NO ONE SHOULD BE UNDER ANY ILLUSION. OUR OWN REPUTATION IS AT STAKE AND IT HAS ALREADY BEEN BADLY DAMAGED.

1430 GMT TODAY IN THE PORT OF JOUNIEH, WHERE IT ARRIVED
THIS MORNING.

- ONE MEMBER OF THE CREW WAS KILLED AND SEVERAL OTHERS
WOUNDED. THE INJURED WERE IMMEDIATELY TRANSFERRED TO THE
NORTRE-DAME HOSPITAL AT JOUNEIH.

- THIS SERIOUS INCIDENT OCCURED AFTER THE ICRC HAD
UNLOADED 83 TONS OF MEDICAL SUPPLIES, VACCINE AND PLASMA,
AS WELL AS A FIELD HOSPITAL INTENDED FOR THE VICTIMS OF
THE CONFLICT.

- EXTREMELY SHOCKED BY THIS ASSULT ON THE PROTECTIVE
EMBLEM OF THE RED CROSS, THE ICRC REMINDS ALL PARTIES TO
THE CONFLICT OF THEIR OBLIGATION TO RESPECT MEDICAL
INSTALLATIONS AND PERSONNEL THAT ARE DULY MARKED AND TO
SPARE THE CIVILIAN POPULATION NOT TAKING PART IN THE
