DEAR MR. PRIME MINISTER:

SALLIE AND I WANT TO EXTEND TO YOU A WARM AND AFFECTIONATE MAZELTOV AS YOU CELEBRATE YOUR 69TH BIRTHDAY WITH YOUR FAMILY AND OLD COMRADES. WE KNOW IT WILL BE A JOYFUL OCCASION. THOUGH I AM FAR FROM JERUSALEM THIS YEAR ON YOUR BIRTHDAY, IN WASHINGTON GETTING READY FOR THE FOREIGN MINISTER'S VISIT, I SHALL RAISE MY GLASS TO YOU TONIGHT AND SAY, TOGETHER WITH COUNTLESS OTHERS OF YOUR FRIENDS: "TIL 1205"

AROUND WEST BEIRUT. ACCORDING TO EMBASSY BEIRUT, AT APPROXIMATELY 1630 LOCAL, ISRAELI FORCES BEGAN INTENSIVE AIR, LAND, AND NAVAL BOMBARDMENT AGAINST PLO TARGETS ALONG THE SOUTHERN AND WESTERN PERIMETERS OF THE CAPITAL AND IN AREAS OF WEST BEIRUT. AN IDF SPOKESMAN IN TEL AVYRUSAID THAT ISRAEL HAD RESUMED ITS BOMBARDMENT OF WEST BEIRUT BECAUSE OF ALLEGED PLO VIOLATIONS OF THE CEASEFIRE JULY 29. THE SPOKESMAN SAID THAT THE IDF DID NOT SEE ITSELF AS QUOTE OBLIGED UNQUOTE TO CONTINUE A UNILATERAL CEASEFIRE WHILE PLO FORCES DIRECTED ARTILLERY AND SMALL ARMS FIRE AT ISRAELI POSITIONS NEARBY. RADIO LEBANON SAID THAT TODAY'S BOMBING CENTERED UPON THE CITE SPORTIVE AREA IN SOUTH BEIRUT; RAMLAT AL-BAYDAH WAS ALSO REPORTED TO BE A TARGET OF IDF NAVAL BOMBARDMENT, AS WERE OTHER AREAS ALONG THE COAST. MEANWHILE, A SMALL NUMBER

OF ICRC TRUCKS LOADED WITH FLOUR HAVE BEEN ALLOWED TO ENTER WEST BEIRUT; HOWEVER THE GDI HAS REFUSED TO ALLOW WATER OR ELECTRICITY TO BE RESTORED TO THE CITY.

3. DIPLOMATIC DEVELOPMENTS: NEGOTIATIONS AMONG U.S. AND GOL OFFICIALS CONTINUE AMID GROWING SPECULATION IN THE PRESS THAT PROGRESS HAS BEEN ACHIEVED IN THE ONGOING EFFORTS TO SECURE A PEACEFUL WITHDRAWAL OF PLO FORCES FROM WEST BEIRUT. MEANWHILE, IN TEL AVIV PRIME MINISTER BEGIN ASSURED MEMBERS OF THE KNESSET THAT THE SITUATION IN BEIRUT WOULD BE SOLVED WITHIN QUOTE A SHORT TIME UNQUOTE. BEGIN COMMENTED THAT ALTHOUGH A POLITICAL SOLUTION IS PREFERRED, A NUMBER OF OPTIONS ARE CURRENTLY UNDER CONSIDERATION. ACCORDING TO UNCONFIRMED PRESS REPORTS, ISRAELI OFFICIALS HAVE EXPRESSED DISSATISFACTION WITH THE PLO'S LATEST SIX-POINT PROPOSAL FOR THEIR DEPARTURE FROM WEST BEIRUT, AND ARE STILL SEEKING FURTHER ASSURANCES THAT THE PLO IS PREPARED TO LEAVE THE CITY.

4. EGYPTIAN FOREIGN MINISTER ALI MET PRESIDENT REAGAN AND SECRETARY OF STATE SHULTZ TO DISCUSS EGYPTIAN PROPOSALS FOR A COMPREHENSIVE SETTLEMENT OF THE PALESTINIAN QUESTION. ACCORDING TO MEDIA REPORTS, THE PRESIDENT AND ALI HAVE AGREED TO QUOTE REDOUBLE EFFORTS IN THE NEAR FUTURE TO MOVE THE PEACE PROCESS FORWARD UNQUOTE.

2. RADIO REPORTS FROM ISRAEL CONCERNING YESTERDAY'S BOMBING AND SHELLING OF WEST BEIRUT ARE SAYING ONCE AGAIN THAT TARGETS WERE EXCLUSIVELY MILITARY. AS WE HAVE BEEN REPORTING, THIS SIMPLY IS NOT THE CASE. THE AIR AND ARTILLERY ATTACK OF JULY 27 MARKED A NEW PHASE IN ISRAELI MILITARY "PRESSURE" AGAINST WEST BEIRUT: THE IDF HAS APPARENTLY OPTED FOR A POLICY OF SATURATION BOMBING THAT INEVITABLY HITS CIVILIAN AREAS.

3. ICRC HAS GIVEN US ONE SMALL EXAMPLE OF WHAT IS HAPPENING IN THE CITY. AT 1740 LOCAL YESTERDAY, A SHELL FIRED FROM THE SEA HIT THE ROOF OF THE ICRC HEADQUARTERS ON HAMRA STREET, ABOUT THREE FEET FROM THE LARGE RED CROSS PAINTED ON THE BUILDING, AND EXPLODED IN THE ELEVATOR SHAFT. MIRACULOUSLY, THERE WERE NO CASUALTIES. THE ICRC DELEGATE BELIEVED THAT IF THE SHELL HAD DETONATED ON IMPACT, THE UPPER FLOOR OF THE BUILDING WOULD HAVE BEEN DEMOLISHED. 5. CASUALTY ESTIMATES FOR YESTERDAY ARE 20 KILLED AND 50 WOUNDED. ONE MASSIVE SALVO SENT SOME 60 ROCKETS INTO AN AREA STRETCHING FROM AWZA'I NORTH TO RAOUCHE. IT MAY BE, AS THE ISRAELIS CLAIM, THAT THE PLO BROKE THE CEASEFIRE -- WE SAW A NUMBER OF IMPACTS AROUND 1715 IN THE ISRAELI-CONTROLLED AREA NEAR KHALDE. HOWEVER, ISRAELI RESPONSE IS NOT ONLY COMPLETELY OUT OF PROPORTION TO THE PROVOCATION, IT IS ALSO INCREASINGLY UNSELECTIVE. THE EXTENSIVE USE OF GUN BOATS IS AN EXAMPLE. NAVAL FIRE CANNOT BE COMPLETELY ACCURATE BECAUSE OF THE UNSTABLE PLATFORM. NEVERTHELESS, THESE BOATS ARE BEING USED TO FIRE INTO THE DENSELY POPULATED AREAS OF RAS BEIRUT. THE GROWING IMPRESSION HERE IS THAT, BEGINNING ON JULY 27, THE ISRAELIS OPTED FOR A WAR AGAINST CIVILIAN BEIRUT AS WELL AS THE PALESTINIAN ARMED PRESENCE IN THE CITY.
