SUBJ: PALESTINIAN DEMONSTRATION AT EMBASSY DAMASCUS

1. EMBASSY INFORMALLY ADVISED BY SYRIAN SECURITY ELEMENTS AT 0830 LOCAL AUGUST 9 THAT THERE WOULD BE DEMONSTRATION AT EMBASSY AT UNSPECIFIED TIME. INFORMATION PROVIDED WAS IMPRECISE AND VARIES FROM REPORT THAT DEMONSTRATION WILL BE BY "PALESTINIAN COMMANDOES" TO THAT IT WILL INVOLVE A "SITDOWN" IN FRONT OF EMBASSY.
2. NUMBERS OF SECURITY PLAINCLOTHESMEN HAVE SHOWN UP AT EMBASSY AND, UPON EMBASSY'S REQUEST, THESE HAVE BEEN AUGMENTED BY UNIFORMED SECURITY PERSONNEL.
3. WE HAVE BEEN IN TOUCH WITH THE FOREIGN MINISTRY REQUESTING INFORMATION ABOUT DEMONSTRATION AND REQUESTED SUFFICIENT SECURITY PROTECTION.
4. WE HAVE TAKEN APPROPRIATE INTERNAL SECURITY PRECAUTIONS AND WILL REPORT FURTHER DEVELOPMENTS AS THEY OCCUR.
5. AFTER ABOVE DRAFTED, FOREIGN MINISTRY CALLED TO INFORM US THAT DEMONSTRATION WOULD BE TRADE UNIONISTS, INCLUDING PALESTINIANS AND OTHERS BUT NOT REPEAT NOT COMMANDOES. MFA ASSURED US THAT DEMONSTRATION WOULD BE PEACEFUL AND THAT ADEQUATE SECURITY PROTECTION WOULD BE PROVIDED.

1. (S-ENTIRE TEXT)

2. THIS IS A FULLER REPORT OF THE THREE HOUR AND 20 MINUTE MEETING WE HAD WITH SHARON AND HIS COLLEAGUES ON SUNDAY AFTERNOON, AUGUST 8 (SEE SEPTEL FOR SUMMARY REPORT).

3. I REVIEWED FULLY WHERE WE NOW STOOD:

--WE HAD RECEIVED FROM THE PLO THROUGH OUR LAF INTERMEDIARIES FURTHER PROPOSALS AS REGARDS SCHEDULING, THE NUMBER OF EVACUEES TO VARIOUS COUNTRIES, ALL TO BE CARRIED OUT WITHIN A 14 DAY PERIOD. WE SOUGHT TODAY ABSOLUTE PLO CONFIRMATION THAT THE NUMBERS GIVEN WOULD TAKE CARE OF ALL "ARMED PERSONNEL", THE PROFESSIONALS AS THE ISRAELIS HAD DESCRIBED THEM, AS WELL AS THE LEADERS AND THE PEOPLE WHO OPERATED THE OFFICES.

--THE PLO WAS MORE EAGER THAN EVER TO LEAVE, AND HAD INDICATED IT WOULD WILLINGLY DEPART WITHIN THE NEXT FEW DAYS.

--THE PROSPECTS WERE BETTER THAT A HIGHER PROPORTION OF THE VACUEES WOULD GO BY SEA RATHER THAN LAND, AND I WAS HOPEFUL THAT PERHAPS ALL COULD BE INDUCED IN THE END TO GO THIS ROUTE.

--THE PLO HAD MADE MAJOR CONCESSIONS, INCLUDING GIVING UP THE NEED FOR IDF "ADJUSTMENTS" IN THEIR LINES.

--WE ARE STILL SEEKING ASSURANCES FROM EGYPT THAT IT

WOULD TAKE A SUBSTANTIAL NUMBER.

--THE HEAVY AND SPARE WEAPONRY WOULD BE TURNED OVER TO THE LAF WITHIN THE TWO WEEK EVACUATION PERIOD.

--THE ONE MAJOR DIFFERENCE WE HAVE WITH THE ISRAELIS WAS OVER THE TIMETABLE FOR THE MNF. THE CHANGE WAS IN THE OPINION OF MY COLLEAGUES AND OF THE GOL ABSOLUTELY ESSENTIAL IN ORDER TO PROVIDE NOT ONLY THE PLO BUT THE MUSLIM INHABITANTS OF WEST BEIRUT WITH THE FINAL ASSURANCES THEY FELT THEY NEEDED.

--I HAD SOUGHT DETAILED ROSTERS, WITH NAMES AND IDENTIFICATION, FOR THE EVACUEES, ALTHOUGH I SUSPECTED THE LISTS WOULD BE HARD IN COMING IN PART BECAUSE OF PLO DISORGANIZATION AND THE LOSS OF FILES THROUGH THE WAR.

--UNDER THE PLO-PROPOSED SCHEDULE, SOME 2,600 PEOPLE WOULD BE EVACUATED IN THE FIRST THREE DAYS. I WAS, OF COURSE, INSISTING THAT THERE BE STEADY MOVEMENT THROUGHOUT THE 14 DAY PERIOD, NOT 100 ON THE FIRST DAY AND 2,000 ON THE FINAL DAY.

4. I THEN STRESSED THAT THE GOL ALSO HAD THE STRONGEST POSSIBLE INTEREST IN AVOIDING THE RISK OF PLO NON-COOPERATION. IN THE PROPOSED EXCHANGE OF NOTES WE HAD HELPED DEVELOP WITH THE GOL FOR USE WITH CONTRIBUTING MNF STATES, PHRASES HAD BEEN INSERTED TO THE EFFECT THAT THE MANDATE OF THE MNF WOULD BE "TERMINATED" IMMEDIATELY IN THE EVENT OF PLO NON-COOPERATION OR FAILURE TO LIVE UP TO PREDETERMINED DEPARTURE SCHEDULES. I SHOWED THE GROUP THE ACTUAL DRAFT LANGUAGE WE WERE CONSIDERING.

5. KIMCHE AND OTHERS THERE WERE CLEARLY IMPRESSED WITH THIS NEW DEVELOPMENT. SHARON SAID AT THIS JUNCTURE THAT THE CABINET THAT DAY HAD MADE CLEAR THAT THE MNF WOULD NOT BE ALLOWED BY ISRAEL TO ENTER BEIRUT UNTIL ALL THE TERRORISTS HAD LEFT BEIRUT. I REJOINED THAT THE REQUEST FOR THE MNF HAD BEEN MADE BY THE GOL, AND THAT SARKIS HAD ENDORSED THE EARLY ENTRY OF ELEMENTS OF THE FRENCH FORCE.
