3. COMMENTING ON THE IMPORTANCE OF U.S. ISRAEL RELATIONS DURING THE WEEKLY ISRAEL TV INTERVIEW PROGRAM "MOKED", ISRAEL'S DEPUTY PRIME MINISTER DAVID LEVI SAID:

"I ATTRIBUTE GREAT SIGNIFICANCE, MAJOR IMPORTANCE PERHAPS, TO OUR RELATIONS WITH THE U.S., TO HAVING AN UNDERSTANDING WITH IT, A COORDINATION OF POSITIONS... UNDER NO CIRCUMSTANCES - WHEN ISSUES AT HAND DO NOT PERTAIN TO OUR SUPREME INTERESTS - SHOULD A CRISIS WITH THE UNITED STATES BE CREATED, BECAUSE AFTER BEIRUT OTHER PROBLEMS WILL FOLLOW, AND WITHIN THE MIDEAST WE MUST KEEP STRONG ALLIES."

DEPUTY PREMIER LEVI SAID IN REPLY TO A QUESTION THAT "AT CERTAIN POINTS THE CABINET GAVE CLEAR INSTRUCTIONS THAT WHEN OUR SOLDIERS' LIVES ARE IN DANGER WE SHOULD REACT AND DEFEND THEM. WHEN A MINISTER FEELS THAT A CERTAIN ACTION GOES BEYOND THIS INSTRUCTION AND MAY, GOD FORBID, DUE TO ITS INTENSITY AND SCOPE, JEOPARDIZE THE CHANCES OF A POLITICAL ACHIEVEMENT WELL UNDER WAY, AND THEN JEOPARDIZE RELATIONS WITH THE UNITED STATES... IT IS THE DUTY OF A CABINET MEMBER TO INSIST ON THE ADHERENCE TO BOTH THE LETTER AND SPIRIT OF THAT INSTRUCTION. THAT IS WHAT I DID."

4. REAGAN TO ANNOUNCE LANDING OF MARINES PROBABLY NEXT THURSDAY.

HAARETZ WASHINGTON CORRESPONDENT GIDEON SAMET HAS LEARNED THAT THE U.S. IS MEANWHILE, WAITING FOR A GOI DECISION WHICH WOULD GIVE THE OFFICIAL SEAL TO THE PLU EVACUATION PLAN. THE ADMINISTRATION IS CONCURRENTLY WAITING FOR THE LEBANESE REQUEST FOR THE DESPATCH OF AN AMERICAN FORCE. THAT, SAYS SAMET, WILL COMPLETE ALL THE DETAILS OF THE EVACUATION AGREEMENT.

ACCORDING TO SAMET THE STATE DEPARTMENT SAID (AUG.18) THAT PRESIDENT REAGAN'S PLANS FOR HIS REPRESENTATIVE PHILIP HABIB IN THE NEXT PHASE OF THE LEBANESE SETTLEMENT ARE NOT YET KNOWN. THE WHITE HOUSE SPOKESMAN SAID THAT THE PRESIDENT WOULD MAKE A STATEMENT WHEN THE SETTLEMENT EFFORTS ARE ACCOMPLISHED, SAMET WRITES.

5. GOI ACCEPTS PLO EVACUATION PLAN:

CABINET SECRETARY DAN MERIDOR ANNOUNCED THIS MORN (COVERED LIVE BY ISRAEL RADIO) THAT THE GOVERNMENT OF ISRAEL ACCEPTS THE PLAN FOR THE EVACUATION OF THE PLO FROM BEIRUT.
