IF ASKED OUR VIEWS ON HIS ELECTION, YOU SHOULD NOTE THAT LEBANESE PARLIAMENT SELECTED HIM IN ACCORDANCE WITH CONSTITUTIONAL PROCEDURES. THE 65TH BDE'S PEACETIME GARRISON, NEAR HILLE, HAS CONTAINED APPROX FIVE T-62 TANKS NEAR ITS TANK FIRING RANGE (ACROSS FROM MAIN ENTRANCE) FOR SOME TIME.
