I THINK THE PROPER CONDITIONS ARE THAT A GOVERNMENT OF LEBANON CONSTRUCT ITSELF AND BE IN CONTROL OF ITS COUNTRY AND BE A GOVERNMENT THAT IS REPRESENTING THE PEOPLE OF LEBANON, AND UNDER THOSE CIRCUMSTANCES DECIDE THAT A PEACE TREATY IS IN THE INTERESTS OF LEBANON AND GOES FORWARD TO DEVELOP ONE.

THAT'S A REAL PEACE TREATY, AND I THINK IT'S HIGHLY DESIRABLE--NOT ONLY A PEACE TREATY WITH ISRAEL AND LEBANON BUT THE OTHER STATES THAT BORDER ISRAEL. THAT'S THE BASIS OF THE PRESIDENT'S PLAN.

I THINK A PEACE TREATY THAT IS SIGNED AT THE POINT OF A GUN IS NOT IN THE END A LONG-LASTING PEACE TREATY.
