ONCE AGAIN CRITICISM, COMING MAINLY FROM THE COMMUNISTS AND SOCIALISTS, FOCUSED ON ITALIAN "SOFTNESS" VIS-A-VIS THE BEGIN GOVERNMENT AND THE VIEW THAT ITALY HAD NOT DONE ENOUGH TO EMPHASIZE ITS DISPLEASURE WITH ISRAEL OVER THE LATTER'S ALLEGED ROLE IN THE RECENT REFUGEE CAMP MASSACRES.

2. (U) COLUMBO'S RESPONSES ESSENTIALLY PARALLELED THOSE GIVEN IN THE SENATE THE DAY BEFORE (REFTEL). THE DEPUTIES PRESENT WERE NEARLY UNANIMOUS IN THEIR SUPPORT FOR THE SENDING OF ITALIAN TROOPS TO BEIRUT. ON THE OTHER HAND, SUCH STAUNCH FRIENDS OF ISRAEL AS ZANONE, SECRETARY OF THE LIBERAL PARTY, STRONGLY CRITICIZED "ISRAELI AGGRESSION AND EXPANSIONISM." WE HAVE RECEIVED SOME LETTERS AT THE EMBASSY ANONYMOUSLY SIGNED BY ITALIAN "ARYAN AND CATHOLIC DEMOCRATS, THAT IS TO SAY NON-JEWS". A FESTIVAL OF AMERICAN JEWISH FILMS THAT WAS TO TAKE PLACE IN OCTOBER AND NOVEMBER IN VENICE AND MODENA HAS BEEN INDEFINITELY POSTPONED; WORKS WITH THE MARX BROTHERS, DANNY KAYE AND WOODY ALLEN, AMONG OTHERS, WILL NOT BE SHOWN. SOME MEDIA HAVE BEGUN TO EXPRESS CONCERN OVER THESE INCREASING EXAMPLES OF ANTI-SEMITISM.

5. (U) FINALLY, A NUMBER OF PAPERS HAVE PICKED UP KING HUSSEIN'S REPORTED STATEMENT TO THE WASHINGTON POST THAT HE WILL NOT DEAL WITH BEGIN, "A MASTER OF TERRORISM". SOME OBSERVERS HAVE NOTED THAT THIS COULD CONSTITUTE A SETBACK TO PRESIDENT REAGAN'S PEACE PLAN FOR THE MIDDLE EAST.
