MEMORANDUM FOR THE PRESIDENT

Subject: Meeting Between You and Chinese Finance Minister
Wang Bingqian

Chinese Finance Minister Wang Bingqian will lead a delegation to Washington next month for the third session of the U.S.-China Joint Economic Committee (JEC), December 13-15. I recommend that you meet with him briefly during that time.

George Shultz sees such a meeting as an excellent opportunity to launch a series of high level exchanges with the Chinese in the next six months and strongly supports this recommendation.

Moreover, I feel that a meeting between you and Finance Minister Wang would highlight the importance we attach to fostering the development of our economic relationship with China. In addition, such a meeting would reciprocate the appointments I had in Beijing last year with China's two most senior leaders, Premier Zhao Ziyang and Vice Chairman Deng Xiaoping.

SUBJECT: Recall of White House Memorandum

On December 27, 1982, a copy of an internal White House memorandum on the subject, "Asylum for PRC Tennis Star, Hu Na," was sent to Clay McManaway with a covering note from John Poindexter which stated that Judge Clark and Secretary Shultz had discussed the matter enroute to California and that Secretary Shultz had asked that a copy of the memo be passed to Ken Dam.
