STATE OPS CTR ADVISED THAT, ACCORDING TO PRESS, A MASSIVE CAR BOMB WENT OFF NEAR THE U.S. EMBASSY ANNEX IN EAST BEIRUT.

SAYS SOME GUARDS WERE KILLED, BUT DOES NOT KNOW IF THEY WERE MARINE GUARDS. CNN SAYS A SUICIDE BOMBER WAS MET BY A HAIL OF BULLETS AND RASHED INTO CONCRETE BARRIERS. DAY: 20 TIME: 0602 MCF CALLED FOR AN UPDATE: ONLY OTHER INFO AVAILABLE WAS A VOICE OF LEBANON REPORT THAT THERE ARE MANY KILLED AND WOUNDED AND RESCUE CREWS ARE ON THE SCENE. MCF CONCURRED THAT THE VP NOT BE INFORMED UNTIL 0630.
