

Dear Mr. Newell:

I was a friend of the late John Wayne and was making for him this bronze bust protraying him as Rooster Cogburn of the movie "True Grit", but Mr. Wayne died before I finished the bust. Mr. Wayne, before his death, requested that his friends would refrain from using his name for monetary gain. In honoring this request I tried to do with the bust what I thought Mr. Wayne would have wanted. If you have noticed, every time we get a Republican President, not long after he takes office, he becomes the target of all the liberal Democrats, the Socialists, the A.C.L.U. and all of the other left wing elements. I think the True Grit atmosphere is appropriate for President Reagan, don't you?

I sent the bronze bust of Mr. Wayne to The Regan-Bush Transition Team in November of 1980 to be presented to the President when he took over his office. While we waited patiently, nothing happened and now it sits at 15 M Street N.W., 5th Floor, Washington. When I inquired about the bust, it was told to me that they are busy and don't have time for such things. TRANIAN-BORN ARTIST Joseph A. Ar-I jang, an American citizen who came to Houston in 1971, sculpted a head of President Reagan and sent the bronze to the White House as an inauguration present.

The chief executive, obviously pleased with the gift, has advised the talented award-winning sculptor that it will be "a fine addition to our future presidential collection."

"I wanted to do something for my president," said Arjang, 40, after he completed the head early in the year, sent it to the foundry for bronzing and then on to the White House.

During the months following the busy inaugural days and later the tragic ones surrounding the assassination attempt, word came back to Houston that the president's staff was pleased with the sculpture. Then last week arrived the personally signed letter from President Rea-

Arjang was born in Tehran, the son of a

sculptor and a Russian-born concert pianist. He studied at the school of Fine Arts in Rome and designed statuary for a Federico Fellini film while a student there in 1963. Following graduation he was appointed professor of sculpture at the University of Tehran.

He won national recognition in Iran in the 1960s for monuments created, but probably now destroyed at Ahwaz, which now is in the Iran-Iraq war zone.

He also created art work for intercontinental hotels in Shiraz and Persipolis and won top prizes in competitions in Iran, Italy and Switzerland.

Upon arriving in Houston he converted the den of the home of Nairer and Kirk Glenn into a Persian garden scene. His sculpture and painting works were commissioned by First National Bank, Kanab Services and Daniel Industries. In this country his work also is in collections in San Francisco, Los Angeles, Miami and Washington. He soon will establish a studio in Seattle. - BETTY EWING




