### GENERAL

The greatest care will be exercised by all concerned in the preparation of this form to obviate the necessity for returning it for correction. It will be carefully scrutinized after completion for errors and omissions and compared with the prescribed entries made from it on the service record, which will be opened before the enlistment record is forwarded. The following instructions governing the preparation of this form will be carefully studied. This form will be used for enlistments in the Enlisted Reserve Corps only.

### PREPARATION OF THE ENLISTMENT RECORD

- 1. One original record only will be made in the case of an applicant for enlistment or reenlistment. Retained copies of enlistment record, when required to be made under regulations and instructions of the War Department, will be marked "Copy" at the top of the first page.
- 2. The period of enlistment shall be three (3) years, except in the case of persons who served honorably for at least four months in the Army, Navy, or Marine Corps between April 6, 1917, and November 11, 1918, who may be enlisted for one (1) year.
- 3. Enlistment will be made for service in a particular section of the Enlisted Reserve Corps, the section for which enlistment is to be made to be determined in accordance with paragraph 3, AR 150-5. The enlisting officer will note on the enlistment record the section for which enlisted.
- 4. The name, race, home address, last service in the Army, and declaration of the applicant will be filled out at the place where the applicant is accepted for enlistment or at place of enlistment if directly enlisted. The physical examination at place of acceptance will be filled out only when enlistment is delayed under paragraph 10, AR 150-5. The remainder of the record will be filled out at the place of enlistment. Particular care will be taken to determine the bona fide home address.
- 5. The correct name of the applicant will be ascertained and it will be written and signed exactly as indicated in each case. A trial signature will be required before signature is made on the enlistment record.
- 6. Service in the Army includes service in the Regular Army, National Guard, called or drafted into Federal service, National Army, Enlisted Reserve Corps, or Regular Army Reserve.
- 7. Race will be indicated as white, colored, Indian (referring to American Indian only), Puerto Rican, Cuban, Mexican, Hawaiian, Filipino, Japanese, Chinese, East Indian, etc. As here employed, "colored" will include the American negro, mulattoes, and others of negroid race, or extraction. For mixed races, except mulattoes, the nationality will be considered as synonymous with the race; for example: Mexican, Filipino, etc. Asiatics, other than members of the white or Caucasian race, will as a rule be indicated by nationality; for example: Japanese, Chinese, East Indian, etc.
- 8. The declaration of the applicant will be taken before he has been stripped, and any statement indicating a possible cause for rejection will be followed up by searching inquiry and examination and the result noted on the record:
- 9. The physical examination will conform to the provisions of AR 40-105. Deviations from normal, though not a cause for rejection, will be noted under the proper headings.
- 10. Under the heading "Remarks" (page 2) will be noted any authorized special assignment or waiver of defects, the nature of the authority being stated. The space under "Remarks" will also be used for continuation of a statement for which the allotted space is insufficient and for any further statement that the examining officer may desire to make.

### DISPOSITION OF THE ENLISTMENT RECORD

- 11. The completed enlistment record will be forwarded to the corps area or department headquarters to be filed until the reservist is ordered to active duty for mobilization in the event of an emergency.
- 12. When a reservist is ordered to active duty for mobilization in event of an emergency, this form will be forwarded to the commanding officer of the organization, post, camp, or station to which the reservist has been ordered to report. The record will not be so forwarded when the reservist is ordered to active duty for training or instruction or to other active duty in time of peace.
- ' 13. Upon receipt of the enlistment record by the commanding officer of the organization, post, camp, or station to which the reservist has been ordered to report, the indorsement to The Adjutant General will be completed and the record forwarded with the initial return and roster or the first return and roster rendered after the reservist reports.
- 14. When the reservist fails to report within a reasonable time after ordered to active duty, the enlistment record will be returned by indorsement to the corps area or department commander. In such case the indorsement to The Adjutant General will not be made out until the reservist has reported under the order.
- 15. When the applicant is rejected the record will be marked "Rejected" at the top of the first page and forwarded to the corps area or department headquarters to be filed.





Permanent address includes forwarding address—the address to which mail sent will eventually reach the officer concerned.
- 5. The report should be mailed in the addressed penalty envelope which accompanies this blank. When no addressed penalty envelope is available, the report will be mailed directly to the corps area or department commander concerned.

## Extracts from paragraph 118, AR 140-5

### INSTRUCTIONS

In entering the required information on the forms you will be guided by the following considerations:

- Item 1. Enter here your full name; initials will not be used.
- Item 2. Enter here your Army serial number.
- Item 3. Enter here the section of the Officers' Reserve Corps in which you are commissioned.
- Item 4. Indicate here your present grade in the appropriate square by the letter "x."
- Item 5. Indicate here your marital status by the letter "x" in the appropriate square.
- Item 6. Enter here the group to which you are now assigned; i. e., the corps area assignment group, the arm and service assignment group, the general assignment group, or the War Department Reserve pool.
  - Item 7. Enter here the unit or installation to which you are now assigned for training.
  - Item 8. Enter here the date, country, and place of your birth.
  - Item 9. Indicate here your race, i. e., white or colored.
  - Item 10. Enter here the country of birth of your father and mother.
- Item 11. Enter here the desired data in the order in which you have had the most experience, and not necessarily in the chronological order in which you engaged in these occupations. Do not attempt to evaluate the military value of your civilian experience in arriving at the order in which entries should appear. On the third line enter the date (in years) during which you engaged in this occupation. Example: 1928-1932.
- Item 12. List here any other work done by you that has given you experience in management or the handling of men. Such work may be entirely aside from your business or profession. Each entry should be clear but concise, and contain sufficient information as to the nature and duration of the work to indicate proficiency attained.
  - Item 13. List here those hobbies you may have engaged in, outside your business or profession reported above.
  - Item 14. In the same way as was done under item 13, enter here any experience you have had in theatrical or other form of entertainment.
- Item 15. If you have at any time acted as an instructor, either in a military or civilian capacity, enter the information giving the nature of the work and the years engaged in it.
  - Item 16. If you are proficient in one or more athletic sports, enter them here. Experience as an athletic coach should be entered under item 15.
- Item 17. Enter here the schools attended, the number of years, and whether or not you graduated. Under the heading "Major field" enter the subject you majored in at college or while taking a post-graduate course. If you have attended other courses given at night school or the like, report them on the last line.
- Item 18. Enter here any membership you now hold or have held in recognized professional societies. Care should be used in differentiating between the terms "associate member," "member," and "fellow," or like terms.
- Item 19. This entry is supposed to represent your proficiency in one or more foreign languages. The entries should represent the degree, and the words "fluently," "slightly," or "poorly" should be used.
  - Item 20. Enter here the name and relationship of the person to be notified in an emergency.
- Item 21. It is desired that all entries under this item be frank statements of fact as known by the reporting officer. If there are any reasons, due to your employment in key positions in essential industries, or because of dependents, or otherwise, why you should be placed in a deferred category for mobilization, give full details. The last item represents the time desired to arrange your affairs before reporting for duty.
  - 1tem 22. Enter here the State and county of your permanent residence.
  - Item 23. Enter here the address of your permanent residence and present business address including name of firm, type of business, and position held.
- Item 24. The term "dependent" as used herein is construed to include only the lawful wife, unmarried children under 21 years of age, and the mother of the officer provided she is in fact dependent on him for her chief support. The term "children" is held to include legitimate children, stepchildren, or adopted children who are in fact dependent upon the officer for their support.
- Item 25. Where the space provided is found insufficient or where it is desired to report information for which space is not provided, use will be made of the space under the heading "Remarks." All such entries will be numbered consecutively, and where entry refers to information called for in the Questionnaire, the fact will be noted by entering the paragraph number, under "Remarks," enclosed in a circle in the proper line to which reference is made, with a cross reference to the numbered line, in parentheses, in the Questionnaire immediately following the paragraph number. For example, if it is desired to record additional information pertaining to item 11 under "Civilian occupations in order of experience" and this entry appears as line 1 under "Remarks," number this entry 1 (11) and in item 11 enter the symbol ①. Officers of the Air Corps Reserve will report the total number of flying hours attained in commercial aircraft (other than Army, Navy, or Marine Corps) grouped as follows:
  - (1) Under 100 HP.
  - (2) 100-300 HP.
  - (3) 300 and over single motor.
  - (4) Multimotor

Officers of the Medical Reserve will enter all pertinent information regarding specialties practiced or subjects in which research has been done. The special form of supplementary Questionnaire for Medical Department Reserve Officers (W. D., A. G. O. Form No. 178-2) will be used for this purpose.
