### SUBJECT: Transfer of 2nd Lieut. Ronald Reagan to Army Air Forces.

TO:

The Commanding General, Port of Embarkation Fort Mason, San Francisco, California

1. Attached hereto is a letter to the undersigned from Mr. Wm. L. Guthrie, Location Manager of Marner Brothers Motion Picture Studios, in reference to the transfer of Lieutenant Ronald Reagan, Cavalry, to the "rmy Mair Forces. It is understood that Lieutenant Reagan is now on duty at your station.

2. It will be noted that General Arnold is very desirous that Lieutenant Reagan be transferred to the Air Forces, or if this is impracticable, that he be assigned to duty with the Air Forces.





2. 3.
