SEQUENCE OF EVENTS FOR STATE DINNER IN HONOR OF CHANCELLOR SCHMIDT
OF THE FEDERAL REPUBLIC OF GERMANY -- MAY 21, 1981

FROM: Muffie Brandon

7:00 p.m. Dinner guests arrive at the Diplomatic Reception Room. Those with special cards are lead through the West Garden Room and into the Rose Garden. These will be the alternate dinner guests.

7:10 p.m. The regular dinner guests begin to be escorted by Social Aides to the East Room where they are announced. (A Social Aide will also announce each guest to the press pool in the ground floor cross hall). Escort cards will indicate by small "r" in upper right corner those to be received in reduced receiving line. All other guests will be escorted to the Blue Room.

(Harpist is in the Diplomatic Reception Room.)

7:15 p.m. Official party departs Blair House.

Official Party arrives White House at the North Portico and proceeds to the Red Room to wait for Mrs. Annenberg to escort them to the Yellow Oval Room.

Those who proceed to Yellow Oval Room:

- Secretary of State and Mrs. Haig
- Ambassador Annenberg
- Foreign Ambassador and Mrs. Peter Hermes

The remainder of the Official Party waits in the Red Room where a Social Aide, with the help of a Protocol Officer, will give out seating cards. Three additional Social Aides will then escort the Party one by one into the East Room.

7:28 p.m. The Chancellor departs Blair House (Military Cordon will line the driveway).

7:29 p.m. THE PRESIDENT AND MRS. REAGAN depart the living quarters by elevator and proceed to the North Portico.

(U.S.M.C. Orchestra in Main Foyer)

The Chief of Protocol will serve as hostess pro-tem for THE PRESIDENT AND MRS. REAGAN as they greet the Chancellor at the North Portico.

7:31 p.m. The Chancellor and his wife are greeted by THE PRESIDENT AND MRS. REAGAN; pause for press photo (outside: open press) session; proceed to Yellow Oval Room via the elevator.

7:35 p.m. The remainder of the Official Party in the Red Room is escorted to the East Room and announced.

Color Team proceeds up Grand Staircase to Hallway outside Yellow Oval Room.

7:40 p.m. Guests (save PRINCIPALS) depart Yellow Oval Room via elevator for East Room and are announced.

OIC requests permission to secure the Colors. THE PRESIDENT responds, "Permission granted." Color Team proceeds to secure the Colors and proceeds out of Yellow Oval Room down the Grand Staircase, led by OIC.

At foot of staircase, Color Team divides.

(Ten pool photographers in black tie in Grand Foyer for 15 seconds for photograph of PRINCIPALS at the foot of the staircase.)

7:45 p.m. THE PRINCIPALS arrive on the State Floor via the Grand Staircase, pause at the foot of the Stairs for press photo session, and proceed directly to the East Room, led by the Color Team for Full Honors and the Receiving Line.

As the Color Team halts outside the East Room, announcement of the PRINCIPALS is made. The Color Team remains divided in the Cross Hall, and the PRINCIPALS, led by THE PRESIDENT, enter and form a receiving line which faces south and will be between two trees. The order of the line is as follows: THE PRESIDENT, THE CHANCELLOR, MRS. REAGAN, MRS. SCHMIDT.

7:45 p.m.
(cont'd.) The Chief of Protocol stands to the President's left with a Social Aide on her left to make introductions to THE PRESIDENT.

The Official Party will be taken to the Red Room to wait for approximately four minutes while other guests have a chance to enter the State Dining Room. All guests in the Blue Room will immediately be led to the State Dining Room after the Official Party is in the Red Room. Those in the Red Room will then be led into the State Dining Room.

At the termination of the Receiving Line, PRINCIPALS should hold in the East Room until all guests are in the State Dining Room, then proceed down the Cross Hall to the State Dining Room.

(Appropriate music should be played.)

8:10 p.m. Guests in the Rose Garden should be led into the West Garden Room to be seated for dinner.

8:15 p.m. Dinner is served in the State Dining Room and the West Garden Room.

(The Staff Mess will be used for dinner for attending Aides who will not be seated in the State Dining Room.)

9:00 p.m. Dessert is served accompanied by the Strolling Strings.

9:15 p.m. Toasts:

THE PRESIDENT

THE CHANCELLOR

(The press pool will cover the toasts from the doorway of the State Dining Room and then depart immediately.)

9:30 p.m. Following the toasts, THE PRESIDENT AND MRS. REAGAN and Mr. and Mrs. Michael Deaver will be escorted into the Blue Room. The Chancellor and Mrs. Schmidt, the Vice President and Mrs. Bush, the Secretary of State and Mrs. Haig, and Ambassador and Mr. Annenberg are escorted to the Green Room. All dinner guests are encouraged by Social Aides to enter the Blue Room and the Green Room to meet all PRINCIPALS.

9:30 p.m.
(cont'd.)

The after-dinner guests arrive in the Diplomatic Reception Room and are escorted with the guests from the West Garden Room immediately by Social Aides to the Color Rooms for coffee and liqueurs with other guests.

(Harpist will play in the Diplomatic Reception Room.)

10:05 p.m.

All guests, but PRINCIPALS will proceed to the East Room for seating.

The Chancellor and Mrs. Schmidt will be escorted from the Green Room to the Blue Room to join THE PRESIDENT AND MRS. REAGAN.

10:10 p.m.

PRINCIPALS enter the East Room and are seated for entertainment on specially allocated chairs.

10:15 p.m.

The entertainment begins.

10:45 p.m.

Conclusion of the entertainment.

10:45 p.m.

THE PRESIDENT makes brief remarks to the guests and mounts the stage to be photographed with the entertainers.

10:50 p.m.

THE CHANCELLOR and his wife are escorted to the North Portico by THE PRESIDENT AND MRS. REAGAN for departure.

11:00 p.m.

THE PRESIDENT AND MRS. REAGAN return to the Main Foyer to begin the dancing.

Guests are served champagne and petit-fours and join in dancing.

11:30 p.m.

All guests depart the Residence.



ARRIVAL REMARKS BY THE PRESIDENT

ARRIVAL CEREMONY FOR FRG CHANCELLOR HELMUT SCHMIDT

10:00 a.m., May 21, 1981

Chancellor Schmidt, Mrs. Schmidt,

On behalf of the American people, Nancy and I extend to you a very warm welcome to the United States. Our personal friendship goes back several years, and I remember with great pleasure our meeting in Bonn in 1978. Your visit here continues our talks of last November and follows a period of intensive consultations between senior officials of our two governments. This is as it should be. My Administration is totally committed to the closest possible consultations with our European allies.

Our meeting today in Washington also symbolizes the renewed and deepening of the friendship between our two peoples. The Federal Republic of Germany and the United States share a common heritage, common values, and common goals. We are bound together by far more than our formal alliance. We are bound together by our shared beliefs and the innumerable ties between our two peoples, including the millions of Americans whose ancestry goes back to Germany. Most importantly, in terms of our meetings here, we are bound together by a common responsibility -- the responsibility to defend the freedom that we share.

This is not an easy time to be entrusted with such responsibilities. For my part, I am heartened by the fact that, in these difficult times, I can look to you, Mr. Chancellor, for support and friendship. We both recognize the challenges posed to our security by those who do not share our beliefs and objectives, and we are working together to counter those dangers. We also recognize, however, that the world will be a less dangerous place if the West maintains the moral and physical strength and the unity required for peace. The problems we face are soluble because we work together.

When we look back on our shared history, to the early post-War period, to the Berlin airlift, to the time of the formation of the Federal Republic, to the Federal Republic's entry into NATO, we are reminded that we have faced serious challenges before. We knew then, as we know today, that only through a strong defense can we ensure that those antagonistic to our way of life will not be tempted, based on a false perception of weakness and disarray, to seek to harm our interests. I ^{Am}~~can~~ confident that the West will do whatever is necessary to safeguard its security. We know that those measures are the essential precondition if our efforts for equitable arms control are to be successful.

We have already begun, through the visits of Foreign Minister Genscher, Defense Minister Apel and Economics Minister Lambsdorff to Washington and Secretaries Haig and

Weinberger to Bonn, to strengthen further our close relationship. That relationship, based on the Atlantic alliance, must not neglect the challenges we must jointly face outside of the Atlantic area. Americans remember well that when the world was outraged over the Soviet invasion of Afghanistan, that when the United States needed support in returning the American prisoners from Iran, and that when the West had to take a clear stance against outside intervention in Poland, the Federal Republic stood with us. We have come to rely on one another in times of calm and in times of crisis as the closest of allies. It is in that spirit that we will address the challenges of the present as we strengthen the ties and commitment between our two countries.

On behalf of all Americans, I welcome you and Mrs. Schmidt to the United States.

PRESIDENT'S TOAST

DINNER HOSTED BY THE CHANCELLOR

Mr. Chancellor:

Mr. Allen has reviewed the State proposed joint press statement to be released following the President's talks with FRG Chancellor Schmidt and recommends that the revised version (attached) be used with the Germans. We understand that the German side wants to propose additional changes in the earlier State version and that both sides will further negotiate a mutually acceptable release tomorrow (May 20).

JOINT PRESS STATEMENT

President Reagan and the Chancellor of the Federal Republic of Germany, Helmut Schmidt, held extensive talks in Washington, May 21, during the Chancellor and Mrs. Schmidt's official visit to the United States, May 20 through 23. The visit reaffirmed the close ties between the United States and the Federal Republic and provided the occasion to renew the friendship between the President and the Chancellor since their last meeting in November. The President and Mrs. Reagan hosted an official dinner at the White House for the Chancellor and Mrs. Schmidt on May 21 in which several senior officials also participated. A wide range of political, security and economic issues of mutual interest were discussed by the President and the Chancellor. They agreed on the necessity of continuing these close consultations to assure full coordination of the foreign policies of the two countries on major international issues, noting in that regard the high level of agreement demonstrated by the visit of Foreign Minister Genscher to Washington in March. In their conversations the President and the Chancellor agreed on their continued commitment to a close bilateral relationship and the solidarity of their commitment to the Alliance.

They also agreed on the necessity of meeting the challenges posed by the Warsaw Pact by working closely together and with the Allies to build a stronger defense posture. The President and the Chancellor renewed their commitment to the dual NATO decision in 1979 relating to long-range theater nuclear weapons, recently reaffirmed by the North Atlantic Council meeting in Rome.

Among the subjects discussed by the President and the Chancellor were recent developments in the Middle East, southern Africa, and Latin America. They stressed the urgent need for progress toward a comprehensive peace in the Middle East, the need to deal with Soviet direct and indirect intervention in developing countries and the desire of the developing countries for economic progress. They underscored their common determination that Poland must be allowed to determine its own destiny, free from outside interference. President Reagan reaffirmed the unshakable American commitment to the City of Berlin.

The Chancellor and Secretary Haig also held separate meetings during the visit. Secretary and Mrs. Haig also hosted a luncheon for the Chancellor and Mrs. Schmidt on May 21 at the State Department.


