CHANCELLOR SCHMIDT & I HAVE JUST
CONCLUDED ANOTHER OF OUR MEETINGS AT A
CRITICAL MOMENT IN WORLD AFFAIRS. THE
PRIMARY TOPIC ON OUR MINDS, OF COURSE,
WAS POLAND & THE IMPOSITION OF MARTIAL LAW
IN THAT UNHAPPY LAND. WE THOROUGHLY
DISCUSSED THE EXTENT OF SOVIET INVOLVEMENT
IN THE REPRESSION BEING WAGED AGAINST
THE POLISH PEOPLE & THE NEED FOR FORCEFUL
WESTERN MEASURES TO INDUCE BOTH THE

I EMPHASIZED MY BELIEF THAT A TANGIBLE ALLIANCE RESPONSE TO THE POLISH CRISIS MUST BE MADE NOW, SHOULD WE FAIL TO INSIST THAT THE SOVIET UNION STOP PRESSURING POLAND DIRECTLY & INDIRECTLY, THE GRAVEST CONSEQUENCES FOR INTERNATIONAL RELATIONS COULD ENSUE.

OUR CONVERSATIONS TODAY COVERED A WIDE RANGE OF RELATED POLITICAL, SECURITY, & ECONOMIC ISSUES. FOR EXAMPLE, WE DISCUSSED THE IMPORTANCE OF THE NEGOTIATIONS ON INTERMEDIATE NUCLEAR FORCES IN GENEVA WHICH BEGAN ON NOVEMBER 30, & OUR HOPE THAT THE SOVIET UNION WILL AVOID STERILE PROPAGANDA & RESPOND CONSTRUCTIVELY TO OUR ZERO-LEVEL PROPOSAL FOR GENUINE REDUCTION OF NUCLEAR ARMS.

ABOVE ALL, WE AGREED ON THE IMPORTANCE OF THE U.S.-GERMAN PARTNERSHIP AND THE NEED FOR CONTINUED CLOSE CONSULTATIONS. WE HOPE TO BROADEN & DEEPEN THESE CONTACTS. WE WILL ALSO MAKE CLEAR TO PUBLIC OPINION IN BOTH COUNTRIES, ESPECIALLY THE YOUNGER GENERATION, THE RESPONSIBILITY WE ALL SHARE OF MAINTAINING BOTH OUR FRIENDSHIP & OUR COMMITMENT TO THE ONE INSTRUMENT WHICH HAS KEPT THE PEACE FOR OVER 30 YEARS, THE NORTH ATLANTIC ALLIANCE.

OTHER INTERNATIONAL ISSUES ON OUR AGENDA INCLUDED THE PROSPECTS FOR STRATEGIC ARMS REDUCTIONS TALKS -- WHAT WE CALL "START" -- THE SITUATION IN CENTRAL AMERICA, IN THE MIDDLE EAST, & IN SOUTHERN AFRICA; AND THE STATUS OF THE "CSCE" PROCESS, PARTICULARLY IN LIGHT OF THE POLISH CRISIS.

WE ALSO REITERATED THE CONCERN WE BOTH FEEL OVER THE CONTINUED SOVIET OCCUPATION OF AFGHANISTAN, AND OUR SUPPORT FOR INITIATIVES BY THE EUROPEAN PARLIAMENT AND THE U.S. CONGRESS TO ESTABLISH MARCH 21 AS AFGHANISTAN DAY.

FOR ITS PART, THE U.S., THROUGH THE U.S.I.C.A., IS TODAY RELEASING, FOR OVERSEAS DISTRIBUTION, A BOOK WHICH ELOQUENTLY DOCUMENTS THE HUMAN FACE OF THE AFGHAN STRUGGLE AGAINST SOVIET INVASION FORCES.

RECOMMENDED PRESS STATEMENT FOR PRESIDENT TO MAKE ON CONCLUSION
OF JANUARY 5 MEETING WITH FRG CHANCELLOR HELMUT SCHMIDT

Chancellor Schmidt and I have just concluded another of our meetings at a critical moment in world affairs. The primary topic on our minds, of course, was Poland and the imposition of martial law in that unhappy land. We thoroughly discussed the extent of Soviet involvement in the repression being waged against the Polish people and the need for forceful Western measures to induce both the Polish and Soviet authorities to lift the martial law and permit resumption of a national dialogue leading to genuine reform.

In that connection, I reviewed with the Chancellor the series of steps I had announced in my Christmas message and on December 29. I emphasized my belief that a tangible response to the Polish crisis must be made now. Should we fail to insist that the Soviet Union stop pressuring Poland directly and indirectly, the gravest consequences for international relations could ensue.

Our conversations today covered a wide range of related political, security, and economic issues. For example, we discussed the importance of the negotiations on Intermediate Nuclear Forces in Geneva which began on November 30, and our hope that the Soviet Union will avoid sterile propaganda and respond constructively to our zero-level proposal for genuine reduction of nuclear arms.

Other international issues on our agenda included the prospects for Strategic Arms Reductions Talks - what we call START; the situation in Central America, in the Middle East, and in Southern Africa; and the status of the CSCE process, particularly in light of the Polish crisis.

We also reiterated the concern we both feel over the continued Soviet occupation of Afghanistan, and our support for initiatives by the European Parliament and the U.S. Congress to establish March 21 as Afghanistan Day. For its part, the U.S. is releasing today a book which eloquently documents the human face of the Afghan struggle against Soviet invasion forces.

Above all, we agreed on the importance of the U.S.-German partnership and the need for continued close consultations. We hope to broaden and deepen these contacts. We will also make clear to public opinion in both countries, especially the younger generation, the responsibility we all share of maintaining both our friendship and our commitment to the one instrument which has kept the peace for over 30 years, the North Atlantic Alliance.

Mrs. Hannelore Schmidt will be visiting Washington with her husband, Chancellor Helmut Schmidt, from January 4 until January 8, 1982. Mrs. Schmidt, who also will be accompanied by her daughter, Dr. Susanne Schmidt, a business graduate presently working for a German bank in London, will arrive in Washington following their vacation in Florida at Sanibel Island. Mrs. Schmidt's last visit to Washington was in May, 1981 during the Chancellor's official visit.

Sanibel Island, where the Schmidts have spent the holidays, is located on the Gulf Coast of Southern Florida near the city of Ft. Myers. The island is famed for its great variety of birds and seashells found along its beaches. Mrs. Schmidt, an avid bird watcher, will probably have visited the Ding Darling National Wildlife Refuge where self-guided tours give visitors an opportunity to view the semi-tropical birds and other wildlife of South Florida's Mangrove Forest. Water in this preserve is regulated by a series of dikes along the coast to permit both salt and fresh water aquatic life to thrive. At this time of year shore birds, such as herons, ibises, and roseate spoonbills, are to be found in the Sanibel area. The Schmidts may have also taken the opportunity to go sailing in the waters around Sanibel Island during their visit.

During their stay in Washington, Mrs. Schmidt intends to visit the National Gallery of Art. During Mrs. Schmidt's visit the Museum will be featuring special exhibits--on Rodin, the largest show of the sculptor's work since the turn of the century, which features a new casting of Rodin's "Gates of Hell"; American Perspective, an exhibit of the Gantz family collection of 19th Century American art; and, an exhibit of pre-Columbian art from Costa Rica.

In keeping with her love for wildlife and concern for conservation, Mrs. Schmidt also intends to visit the National Zoo.

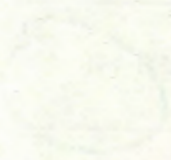

There is no doubt, as FEMA Director Louis Giuffrida notes in his memo to Ed Meese (Tab A), that FRG CDU Deputy Chairman Lothar Spaeth is a solid pro-American politician and one whose outlook very much comports with many of the Administration's own foreign policy views. However, I do not feel that he is of sufficient stature or experience to warrant Presidential time, particularly since the President has already met with Spaeth's CDU boss, Helmut Kohl - a view reflected in the suggested response you may wish to send Ed Meese at Tab I.

NB. I checked with State, which concurs with the above and notes that Spaeth will most likely be received at the Stoessel level over there.

This note is out of my normal area of involvement, but I offer some thoughts for your consideration.

I refer to the Deputy Chairman of the Christian Democratic Party (CDU) of West Germany, Lothar Spaeth. He is also Ministerpresident (Governor) of the State of Baden-wurttemberg.

If the CDU defeats the Social Democrats (SPD) in the 1984 election, Mr. Spaeth could become the Chancellor of Germany, the Deputy Chancellor, or Foreign Minister because of his position as Deputy Chairman of the CDU Party.

He will be in the United States from February 2-9. He will be attending the National Prayer Breakfast at which President Reagan will speak here in Washington on February 4. He would like very much to have a private meeting with President Reagan on either the 3rd or 4th of February; however, he would, of course, change his plans and be available on the 5th through 9th as well.

He is a real supporter of the United States and President Reagan's policy. He truly feels it would be helpful not only to himself but to President Reagan if they met and got to know one another at this stage in anticipation of the CDU coming to power in 1984-1985.

If you feel the idea has merit, I can provide additional data.

SUBJECT: Your Meeting with Manfred Lahnstein, Jan 4

During your meeting next week with Federal Chancellery State Secretary Manfred Lahnstein, you may wish to make the following points:

- The President considers his Tuesday meeting with the Chancellor to be among the most important Allied conversations he is likely to have in his entire Administration;
- From our point of view, there is really only one agenda item: Poland;
- We hold the Soviets responsible for the imposition of martial law and are convinced beyond any doubt of their complicity in the repressive measures now in progress;
- What we do - or don't do - in response to these Soviet actions, which violate every norm of international behavior, will directly affect Western influence in the world;
- As a matter of strongly held principle - and a determination to deal with the realities of the Polish situation - the President has taken the steps with which you are familiar;
- While we would like Allied support, and specifically German support for those steps, we are prepared to act alone;
- We seek a high-level dialogue with the Soviets, and we are especially anxious to achieve progress in the INF talks in Geneva; but the quality of that dialogue now depends on Soviet actions;
- For our own part, we simply will not acquiesce in the present repressive situation in Poland; to do so would signal not prudence, but impotence.

You might also wish to alert Lahnstein that the President is interested in greater defense contributions to NATO from all the Allies, and that we thought it unfortunate that official German spokesmen publicly boasted of "defeating" the U.S. in its attempt at the NATO Ministerial meetings in Brussels last month to induce greater Allied defense efforts. Time permitting, you might also want to lay down a marker with Lahnstein concerning the displeasure we feel over the German performance in the UN last month when they voted with the likes of Angola, Ethiopia, Cuba, and the Soviet Union on a demagogic El Salvador resolution; we did not - and do not - consider such performance compatible with the precepts of Allied cooperation and understanding.

SUBJECT: U.S. Government Aircraft for Chancellor *Helmut* Schmidt

State's memo (Tab A) requests airlift support for FRG Chancellor Helmut Schmidt and his party during the latter's January visit to the U.S. for a meeting with the President.

The NSC backs State's recommendation for the support in question and believes that the courtesy is not only compatible with the importance of the U.S.-German bilateral relationship but will also contribute to the positive atmosphere of the Chancellor's meeting with the President.

So far as the question of funding is concerned, we have no strong feelings concerning which department should be the lead. However, given the initiative which State has taken in the visit and the importance it properly attaches to the diplomatic aspects of the occasion, we believe that State itself might appropriately be asked to bear these costs.

RECOMMENDATION:

That you respond favorably to State's request for courtesy aircraft support on behalf of Chancellor Schmidt as specified in the attached memo and have State agree to bear the costs (the contact point is Marty Coyne 632-1277).

Subject: U.S. Government Aircraft for Chancellor Helmut Schmidt

The President has invited FRG Chancellor Helmut Schmidt to a meeting and working luncheon at the White House on January 5. The Chancellor will be on vacation in Florida both prior to and following his meeting with the President.

The Chancellor's office has asked our embassy in Bonn whether it might be possible to provide the Chancellor with U.S. transportation from Fort Myers in Florida to Washington on January 4 and from Washington back to Florida on January 6. The Chancellor will be accompanied by his wife, Loki; their daughter, Dr. Susanne Schmidt; the German Ambassador to the U.S. and other German Embassy officers; German security personnel; and U.S. security personnel.

The Department of Defense has informed us that it would make available a U.S. government aircraft if: (a) it is instructed to do so by senior authority, and (b) the funding question is resolved at the outset. The Department of Defense's informal estimate is that the transportation costs will be between \$21,000 and \$29,000.

In view of the importance of U.S. relations with the Federal Republic of Germany, we believe it would be in the U.S. interest for the President to make an aircraft available to Chancellor Schmidt as a special courtesy. We, therefore, recommend that the White House instruct the Department of Defense to dispatch an aircraft to Florida on a Presidential mission to transport Chancellor Schmidt and party to Washington for the meeting with the President and back to Florida following the meeting. We request that the White House ask the Department of Defense to bear the cost of this transportation.
