

Dear Mr. Gibson,

It has been brought to my attention that you might well be the gentleman capable of assisting us in a most tedious endeavour: - namely, the enlisting of the collaboration of the U.S. Government in its offices at the Department of State, at the Department of Defense, and in its Embassy in Bonn in the production of the forthcoming project entitled "Judgment in Berlin".

"Judgment in Berlin" is to be a full length motion picture deriving its impetus from a book bearing the same title written by Judge Herbert J. Stern and relating the events surrounding the assignment in 1978/9 of Mr. Stern as judge of a U.S. occupational court in the United States Sector of West Berlin. The motion picture, starting principal photography in April, 1987, will star Martin Sheen and Sean Penn, and will be directed by Leo Penn; the Production entity is January Enterprises, and I am the Producer, with Martin Sheen and Bill Greenblatt as Executive Producers.

And now, briefly, the terms of the tedious endeavour referred to above. Since 1985 - when I and my company first became involved in the production of this multimillion-dollar film - I and those connected with this project felt that, for the sake of truth and objectivity (both so vital in a story of this import and delicate nature), the compiling of the screenplay on which the film would be based should reflect the advice, the comments, the viewpoint, and the first-hand accounts not only of Herbert Stern himself (as published in his book), but also of the other parties connected with the incident: i.e. the State Department, the Department of Defense, the U.S. Embassy and Mission in Germany and Berlin, as well as the Attorneys for the Prosecution and the Government witnesses who testified in the trial. With this in mind, I and those connected with this project set out to make contact with the State Department, with the Department of Defense, with the US Embassy in Bonn, and with Mr. Nelson in Munich. We told whomever would speak to us (secretaries mostly, and those who have the sad task of "taking messages") that we wished to hear "the other side of the story" (i.e. the side of those who fared least well in Mr. Stern's book). I and those connected with the production informed and, indeed, beseeched the U.S. Government (both at home and abroad, and in all manner and form) that, as decent, God-fearing citizens and as conscientious professionals, we sincerely sought to be impartial, to be fair to all concerned, -- that we fervently wanted to communicate with all relevant parties in order to do justice to the Truth, in order to work in concert to make the film a positive force within our society, a necessary critique that, far from "pointing a finger" with the pretence of judging who was right or wrong, would, without bias, trace the parameters of what can go amiss.

even within a system as admirable as Democracy, and how, in the end, the sound and immovable "rock" that is the Constitution will prevail against all human error and weather even the most inauspicious imbroglios. In a word, we of the Production of this film, in all fairness and in the name of human dignity and righteousness, sought repeatedly to secure the directives, the advice, the consultation, the guidance and the perspective of those people and institutions which could be negatively affected by the relating of "Judgment in Berlin" from Judge Stern's point of view and his point of view alone.

Yet, though the Department of Defense proved to be co-operative within the tapestry of Federal Authority, the State Department rewarded our efforts with a chilling silence and a stonewall gelidness reminiscent of States less versed in the true openness of genuine freedom. Our frequent telephone calls to Washington, to Munich, to Bonn (save for the apologetic kindness of Mr. Jeff Gallup) went unushered and unanswered, leaving us as frustrated as those whose intentions are less noble. And now, after many months of such humiliation, we find ourselves on the threshold of our production start date and with no recourse save for that of presenting you and the President with this sad state of affairs.

In closing, we reconfirm our desire to communicate, to collaborate, to liaise, and to listen and to learn the truth from those connected with the incidents of that "judgment in Berlin". In closing, we repeat (as we have been repeating for almost two years) that we will meet and be instructed by those in the Government who truly have nothing to hide and who truly wish to make "Judgment in Berlin" the vehicle of Peace and

Brotherhood it can become, the instrument created by the Artistic Community so that the Government and the Constitution of the people, by the people, and for the people shall not perish from the earth.




Dear Mr. Castillo:

SUBJECT: U.S.-Federal Republic Exchange

You will recall that the President and Chancellor Kohl signed an agreement to create a U.S.-German youth exchange council during the Chancellor's visit last month. I think this is potentially a very valuable action. It also happens to track with some initiatives that I had been trying to generate to ensure that U.S.-Fed Rep contacts continue on a broad and active level. There had been a significant increase in U.S.-Fed Rep contacts during the "German-American Tricentennial." This increase was particularly marked from 1983 to 1985. Several key Germans have raised the question whether in the aftermath of the Tricentennial the U.S. would "turn their attentions to other subjects" with a consequent drop-off in U.S.-German activity.

Several of us on the NSC Staff, including Don Fortier and Peter Sommer, raised the idea of the creation of a bi-national commission to ensure the continuancy of the private and public commitment on both sides of the Atlantic. The newly formed Youth Exchange Council provides a useful vehicle to maintain the symbols of contact and friendship. I will be discussing the form and substance of this Youth Council while in Bonn on November 20 with several German officials. One of the things I would hope to accomplish would be a recognition that the idea of youth exchange could include "successor generation" and permit us to involve more deeply people up to the age of 30. Most discussions that we have had on this subject have pointed out that we should be working on both school-aged people as well as young professionals.

As a first step to maintaining a public-private commitment in the U.S., Charlie Wick chaired a meeting on November 10 with a cross-section of representatives from the private sector. This was the first step in seeking to generate more active private-public attention to the issue on the American side. The meeting concluded with several taskings:

-- The need to establish priorities in the bilateral exchange field between the U.S. and the Federal Republic. A joint

public-private working group was charged with pursuing that issue on an expedited basis.

-- The need to create an inventory of exactly what is being done on the U.S. side. This will be carried out by USIA. When it is completed, a comparison of the priorities in the inventory of activities will point out gaps in areas requiring more attention in the field of exchange.

-- Following the development of a meaningful American position, selected officials from the American public-private group should meet with counterparts from the Federal Republic.

I have previously discussed this concept with Walter Leisler Kiep (CDU) in Germany in April of this year. I will follow up on this discussion while I am in Bonn next week. The bilateral conversation could take place either in the context of a meeting of the U.S.-German Youth Exchange Council or separately.

To restate the obvious, one of the principal reasons that I have been pressing this bilateral exchange program so actively, drawing on both public and private initiatives, is the fact that this relationship is one of the most critical in terms of our national security. Further, the Germans are very conscious of the symbolic aspects of this relationship. They were concerned about the symbolism involved in the proposed closure of a number of German-American institutes. They would have been closed for budgetary reasons. This was headed off largely because the Federal Republic was prepared to underwrite the cost of these institutes. They are further concerned about our plans to reduce the number of consulates in Germany. The closure of the consulate in Bremen and the possible closures of the consulates in Dusseldorf and Stuttgart are important symbols of our willingness to "stay the course."

Mr President,  
Dear Ron,

Thank you for your letter of 20 April 1987.

I fully share your concern about the agricultural situation. The serious worldwide crisis currently gripping agriculture requires comprehensive measures to adjust national agricultural policies. The costly excess production throughout the world of agricultural goods such as grain, beef, dairy products and sugar must be cut back, and the subsidies race must be halted. This would also create the conditions for the world agricultural markets to function more effectively.

Since the economic summit in Tokyo, this requirement has gained acceptance, as was reflected, much to my gratification, in the ministerial meeting of the OECD Council held in Paris on 12 and 13 May 1987. We all agree that the complex agricultural problems can be overcome only through a common concerted approach. Our talks on agricultural matters at the economic summit in Venice can also proceed from this common basis.

The Federal Government is determined to play its part within the European Community in the resolution of the worldwide agricultural problems, not least in view of the situation in the developing countries, which you aptly de-

scribed in your letter. At the same time, there must be enough scope for each country to carry out the reforms best suited to its particular agricultural and structural circumstances.

The recent meeting of the OECD Council also opened up encouraging prospects for the agricultural negotiations of the Uruguay Round. I am very hopeful that in implementing the Ministerial Declaration of Punta del Este we can arrive at effective solutions. Allow me in this context to reaffirm that the Federal Government will continue to reject emphatically the introduction in the European Community of a tax on oils and fats.

I look forward with great anticipation to meeting you again at the economic summit in Venice and to our talks.

für Ihr Schreiben vom 20. April 1987 danke ich Ihnen.

Ihre Sorge um die Situation der Landwirtschaft teile ich voll. Die tiefe Krise, in der sich die Agrarwirtschaft weltweit befindet, verlangt umfassende Maßnahmen zur Anpassung der nationalen Agrarpolitiken. Die kostspielige weltweite Überschußproduktion bei Agrarerzeugnissen wie Getreide, Rindfleisch, Milchprodukten und Zucker muß abgebaut und der Subventionswettlauf beendet werden. Dies schafft zugleich die Voraussetzungen für ein besseres Funktionieren der Weltagrarmärkte.

Diese Einsicht hat sich seit dem Wirtschaftsgipfel in Tokio durchgesetzt und sie hat auch - was ich sehr begrüße - ihren Niederschlag bei der am 12./13. Mai 1987 in Paris abgehaltenen Tagung des OECD-Ministerrates gefunden. Wir alle sind uns einig, daß die schwierigen Agrarhandelsprobleme nur durch ein gemeinsames, konzertiertes Vorgehen zu bewältigen sind. Von dieser gemeinsamen Grundlage können wir auch bei unseren Gesprächen zu Agrarfragen auf dem Weltwirtschaftsgipfel in Venedig ausgehen.

Die Bundesregierung ist fest entschlossen, im Rahmen der Europäischen Gemeinschaft ihren Beitrag zur Lösung der weltweiten Agrarprobleme zu leisten, nicht zuletzt auch im Hinblick auf die in Ihrem Schreiben zutreffend gekennzeichnete Situation der Entwicklungsländer. Dabei sollte ausreichender Spielraum bestehen, damit jedes Land die Reformmaßnahmen ergreifen kann, die seinen besonderen agrarwirtschaftlichen und strukturellen Verhältnissen entsprechen.

Die zurückliegende Tagung des OECD-Ministerrates hat positive Perspektiven auch für die Agrarverhandlungen der Uruguay-Runde eröffnet. Ich habe gute Hoffnung, daß wir bei Durchführung der Ministererklärung von Punta del Este tragfähige Lösungen erreichen. In diesem Zusammenhang darf ich erneut feststellen, daß die Bundesregierung die Einführung einer sogenannten Fettabgabe in der Europäischen Gemeinschaft weiterhin mit Nachdruck ablehnen wird.

Ich freue mich auf das Wiedersehen beim Weltwirtschaftsgipfel in Venedig und sehe unseren Gesprächen mit großer Erwartung entgegen.

THE FEDERAL CHANCELLOR'S MEETING WITH THE CHAIRMAN OF THE AMERICAN COUNCIL ON GERMANY

On June 15, 1987, the Federal Chancellor met with the new Chairman of the American Council on Germany, Senator Charles McC. Mathias. The Chancellor had an hour's discussion with the Senator. He congratulated the Senator on his election as Chairman, a position he assumed at the beginning of the year as the successor to John J. McCloy. The Chancellor expressed particular pleasure that a very experienced American parliamentarian had assumed special responsibility for the strengthening of German-American relations.

In their discussion, the Chancellor stressed the importance of strengthening German-American understanding and fully involving the successor generation. He therefore feels strongly about strengthening exchanges between the younger members of the German Bundestag and the American Congress as well as high school and university students. In connection with student exchanges, the Chancellor and President Reagan agreed during the Chancellor's last visit in Washington in October, 1986, on the establishment of a joint council for German-American youth exchanges.

Senator Mathias thanked the Chancellor for his kind remarks and expressed his determination to strengthen the efforts in those areas the Chancellor had identified and stressed the role which the media ought to play in the context of German-American relations. The media particularly should identify more clearly than they now do the pluralism in both societies.

In concluding the discussion, the Chancellor again expressed his appreciation for the President's great personal success on his June 12 visits in Berlin and Bonn, and particularly for the extended television coverage in which all Germans, both in the East and the West, could share.

THE FEDERAL CHANCELLOR'S MEETING WITH THE CHAIRMAN OF THE AMERICAN COUNCIL ON GERMANY

On June 15, 1987, the Federal Chancellor met with the new Chairman of the American Council on Germany, Senator Charles McC. Mathias. The Chancellor had an hour's discussion with the Senator. He congratulated the Senator on his election as Chairman, a position he assumed at the beginning of the year as the successor to John J. McCloy. The Chancellor expressed particular pleasure that a very experienced American parliamentarian had assumed special responsibility for the strengthening of German-American relations.

In their discussion, the Chancellor stressed the importance of strengthening German-American understanding and fully involving the successor generation. He therefore feels strongly about strengthening exchanges between the younger members of the German Bundestag and the American Congress as well as high school and university students. In connection with student exchanges, the Chancellor and President Reagan agreed during the Chancellor's last visit in Washington in October, 1986, on the establishment of a joint council for German-American youth exchanges.

Senator Mathias thanked the Chancellor for his kind remarks and expressed his determination to strengthen the efforts in those areas the Chancellor had identified and stressed the role which the media ought to play in the context of German-American relations. The media particularly should identify more clearly than they now do the pluralism in both societies.

In concluding the discussion, the Chancellor again expressed his appreciation for the President's great personal success on his June 12 visits in Berlin and Bonn, and particularly for the extended television coverage in which all Germans, both in the East and the West, could share.
