1. THE BOLIVIAN GOVERNMENT HAS MOVED FURTHER TO DISASSOCIATE ITSELF WITH THE STATEMENTS BY AIR FORCE GENERAL NATALIO MORALES MOSQUERA ON APRIL 12 BY ISSUING A DECLARATION BY FOREIGN MINISTER GONZALO ROMERO ON APRIL 14. THE DECLARATION STATES CATEGORICALLY THAT THE BOLIVIAN GOVERNMENT NEVER CONTEMPLATED ACTIONS OF MILITARY OR LOGISTICAL SUPPORT IN FAVOR OF ONE OF THE PARTIES OF THE CONFLICT, AND EMPHASIZED ITS EFFORTS IN INTERNATIONAL FORA TO BRING ABOUT A NEGOTIATED SOLUTION TO THE PROBLEMS.

2. THE EMBASSY'S UNOFFICIAL TRANSLATION OF THE FOREIGN MINISTRY'S STATEMENT IS AS FOLLOWS:

NECESSARY TO FORMULATE THE FOLLOWING DECLARATION:

(1) THE BACKING OF THE SOVEREIGN RIGHTS OF THE REPUBLIC OF ARGENTINA OVER THE MALVINAS ISLANDS HAS BEEN THE INVARIABLE POSITION OF BOLIVIA, EXERCISED ESPECIALLY IN WORLD AND REGIONAL ORGANIZATIONS

OF WHICH IT FORMS A PART; THIS ATTITUDE HAS BEEN REITERATED OFFICIALLY IN THE DECLARATION OF THE FOREIGN MINISTER OF THE REPUBLIC ISSUED ON FRIDAY, APRIL 2, OF THIS YEAR.

(2) THE INVARIABLELY PACIFIST SPIRIT AND CONDUCT OF THE COUNTRY HAVE BEEN EXPRESSED, ONE MORE TIME, IN REITERATING THE DESIRE THAT THE PROBLEMS BETWEEN ARGENTINA AND GREAT BRITAIN BE RESOLVED BY DIPLOMATIC MEANS, WITH THE EXCLUSION OF ALL ACTION OF FORCE.

(3) THE GOVERNMENT AND THE ARMED FORCES OF BOLIVIA DECLARE CATEGORICALLY THAT AT NO TIME HAVE THEY CONTEMPLATED TAKING ACTIONS OF MILITARY OR LOGISTICAL SUPPORT IN FAVOR OF ONE OF THE PARTIES IN CONFLICT.

(4) THE DECLARATION FORMULATED BY THE MOST EXCELLENT AMBASSADOR OF THE UNITED KINGDOM IN BOLIVIA, PUBLISHED IN TODAY'S (APRIL 14) PRESS (SEE REFTEL C), TRANSMITS, IN ONE OF ITS PARTS, AN ERRONEOUS INTERPRETATION OF THE INTENTIONS OF THE GOVERNMENT OF BOLIVIA, WHICH IS NECESSARY TO CLEAR UP IN ORDER TO PLACE THE THINGS IN THEIR TRUE PLACE.

(5) BOLIVIA, THROUGH ITS MISSIONS TO THE ORGANIZATION OF THE UNITED NATIONS AND THE ORGANIZATION OF AMERICAN STATES, IS TAKING AN ACTIVE PART IN THE SEARCH FOR NEGOTIATED SOLUTIONS IN ORDER TO PUT AN END TO THE CONFLICT WHICH IS ENDANGERING THE PEACE ON THE CONTINENT. THE ACTION OF BOLIVIA IN SAID INTERNATIONAL FORA IS THAT WHICH BEST REFLECTS ITS TRUE INTENTIONS WITH REFERENCE TO THIS CONFLICT.

(6) THE GOVERNMENT OF BOLIVIA DOES NOT BELIEVE THAT THREATS OR PRESSURES INTENDED TO MAKE IT CHANGE ITS CONDUCT IN THIS HOUR OF HARD TESTING FOR AMERICA WILL BE A POSITIVE CONTRIBUTION
LA PAZ, APRIL 14, 1982. END QUOTE.

3. ON APRIL 14 ALSO, THE LA PAZ DAILY "ULTIMAHORA" REPORTED THAT THE BOLIVIAN CABINET WILL ASK GENERAL MORALES TO EXPLAIN HIS STATEMENTS WHEN HE RETURNS FROM BUENOS AIRES. HE IS SUPPOSED TO COME BACK TO BOLIVIA ON SUNDAY, APRIL 18.

- B-8 Release would disclose information concerning the regulation of financial institutions [(b)(8) of the FOIA]
- B-9 Release would disclose geological or geophysical information concerning wells [(b)(9) of the FOIA]
