OF COORDINATED ACTION AGAINST GREAT BRITAIN BY ALL SIGNATORIES TO THE RIO TREATY.

2. PRESIDENT LUIS HERRERA CAMPINS WAS AMONG THE FIRST VENEZUELAN OFFICIALS TO REITERATE HIS SUPPORT FOR ARGENTINA. RETURNING FROM TRUJILLO, ON EVENING OF APRIL 23, HE TOLD AWAITING NEWSMEN THAT HE WAS IN CLOSE CONTACT WITH FOREIGN MINISTER ZAMBRANO IN WASHINGTON TO OBTAIN THE LATEST INFORMATION ON THE SOUTH ATLANTIC CRISIS AND THAT "VENEZUELA FIRMLY MAINTAINS ITS SOLIDARITY WITH THE REPUBLIC OF ARGENTINA."

3. ZAMBRANO, WHO LEFT APRIL 25 FOR THE WASHINGTON OAS MEETING, RELEASED A PRE-DEPARTURE STATEMENT TO THE PRESS IN WHICH HE DESCRIBED THE CURRENT--BUT PRE-ATTACK-- VENEZUELAN POSITION IN THE DISPUTE AND PROVIDED AN INSIGHT INTO THE INSTRUCTIONS HE CARRIED TO WASHINGTON. CONCERNING THE GOV POSITION, ZAMBRANO REITERATED THAT "VENEZUELA SUPPORTS THE ARGENTINE CLAIM TO THE MALVINAS" AND HOPES GREAT BRITAIN "WILL CEASE TO PRETEND TO MAINTAIN COLONIAL HOLDINGS THERE AND ORDERS ITS FLEET TO RETURN" HOME. AS TO WHAT VENEZUELA WILL DO AT THE OAS MEETING, ZAMBRANO SAID: "OUR DELEGATION WILL DEDICATE ITS GREATEST EFFORT TO SEE WHAT THIS MEETING RESULTS A TESTIMONY OF SOLIDARITY" WITH ARGENTINA. "WE ARE CONVINCED THAT THE RESULTS OF THIS MEETING WILL BE DECISIVE TO THE FUTURE OF THE REGIONAL SECURITY SYSTEM, AND WITH THE BEST INTENTIONS WE WILL ATTEMPT TO SEE THAT THE RECIPROCAL ASSISTANCE PLEDGE TO WHICH WE AGREED IS HONORED, SAID ZAMBRANO" BEFORE ADDING THAT VENEZUELA HOPED "THE RIO TREATY WILL NOT DISAPPOINT ONE'S EXPECTATIONS OF INTERNATIONAL ORGANIZATIONS".

4. ANOTHER TO EXPRESS SOLIDARITY WITH ARGENTINA WAS GODOFREDO GONZALEZ, PRESIDENT OF THE VENEZUELAN CONGRESS AND PRESIDENT OF COPEI. HE TOLD NEWSMEN HE THOUGHT THE ACTIONS OF THE BRITISH TO BE "INEXPLICABLE AND, OF COURSE, UNJUSTIFIABLE." ASKED IF VENEZUELA PLANNED TO BREAK RELATIONS WITH THE UK IMMEDIATELY, SENATOR GONZALEZ REPLIED: "NOT NOW, BUT IT COULD BE DECIDED LATER ON, BUT IT WOULD NOT BE AN ISOLATED OR UNILATERAL ACTION BY VENEZUELA." "IT WOULD HAVE TO BE, IN ANY CASE, A COMBINED AND COLLECTIVE ACTION OF LATIN AMERICA AGAINST ENGLAND," HE ADDED.

5. RAFAEL EMILIO MARQUEZ, EXECUTIVE SECRETARY OF THE FOREIGN AFFAIRS ADVISORY COUNCIL (CARE), ALSO CONSIDERED "INOPORTUNE TO ACT UNILATERALLY AT THIS TIME", AND BREAK RELATIONS WITH ENGLAND. HE FAVORED, HOWEVER, THE APPLICATION OF THE RIO TREATY AGAINST GREAT BRITAIN BECAUSE "IT WOULD BE A CYNICAL ACT TO OPPOSE ITS APPLICATION" AFTER THAT COUNTRY ATTACKED
