MEDIATOR, AND I HAVE COME BACK THIS WEEK TO CONSULT WITH
HIM AS AN ALLY. THE BRITISH PEOPLE ARE EXTREMELY GRATEFUL
TO THE UNITED STATES FOR GIVING THEM THE SUPPORT THEY ARE
NOW GOING TO GIVE US IN THIS STRUGGLE OVER THE FALKLAND
ISLANDS. I WANT TO SAY THAT WE RESPECT THE BASIS UPON
WHICH THE UNITED STATES HAS GIVEN THAT SUPPORT. IT HAS
BEEN OUR STRATEGY ALL ALONG TO BUILD UP THE PRESSURE ON THE
ARGENTINES SO THAT THEY WILL KNOW THAT AGGRESSION DOES NOT

PAY. WHAT HAPPENED YESTERDAY WAS, OF COURSE, A BUILD-UP OF THAT PRESSURE. INCIDENTALLY, THIS MORNING THERE IS NO FURTHER NEWS SINCE THE NEWS WE HAD LAST NIGHT. QUESTION: SIR, DID YOU ALSO DISCUSS THE SPECIFIC U.S. SUPPORT FOR BRITAIN?

FOREIGN SECRETARY PYM: WE JUST DISCUSSED THE WHOLE AREA TOGETHER THIS MORNING AND ARE GOING TO MEET AGAIN LATER ON TODAY, AND WE WILL HAVE A PRESS CONFERENCE LATER, SO I THINK NO FURTHER QUESTIONS AT THIS POINT.

QUESTION: SECRETARY HAIG, SPECIFICALLY WHAT IS THE U.S. NOW PREPARED TO DO IN THE LINE OF MORE HELP FOR THE BRITISH?

SECRETARY HAIG: WELL, I THINK WE DISCUSSED THIS SITUATION AT TIME OF PRESIDENT'S DECISION ANNOUNCED ON FRIDAY AND IT SERVES NO PURPOSE TO GO INTO ANY DETAILS TODAY.

QUESTION: NO DECISION TO GO BEYOND THAT?

IT'S BEEN OUR POSITION FROM THE OUTSET AND IT REMAINS THAT, HOWEVER, WE ARE EQUALLY CONCERNED THAT THE SITUATION NOW REQUIRED CLARIFICATION WITH RESPECT TO WHAT THE OBSTACLES TO A POLITICAL SOLUTION HAVE BEEN, AND THE

RESPONSIBILITY FOR THE GOVERNMENT IN BUENOS AIRES FOR THE CONTINUATION OF THESE OBSTACLES.

QUESTION: MR. SECRETARY, WHEN ARE YOU GOING TO WORK OUT THE SPECIFICS OF AMERICAN AID TO BRITAIN?
