PYM VISIT

1. THE GUARDIAN LEADS WITH A REPORT FROM ITS WASHINGTON
CORRESPONDENT THAT PYM "INDICATED LAST NIGHT THAT
BRITAIN DOES NOT ENVISAGE ANY FURTHER MILITARY ACTION
AROUND THE FALKLAND ISLANDS AT THE MOMENT, UNLESS
THE SECURITY OF THE MILITARY EXCLUSION ZONE IS
ENDANGERED. BUT HE REFUSED TO RULE OUT FUTURE MILITARY
ACTION." THE TIMES WASHINGTON CORRESPONDENT NOTES
THAT "MR PYM'S VISIT TO THE UNITED STATES WAS SEEN AS
A MOVE TO MAINTAIN BRITAIN'S DOMESTIC AND INTERNATIONAL
PRESSURE ON ARGENTINA TO OFFER THE ARGENTINE JUNTA AN
ESCAPE ROUTE TO SETTLE THE CRISIS. IT WAS ALSO

2. REPORTING ON MRS. THATCHER'S OFFER TO OPPOSITION PARTY LEADERS TO HOLD ALL-PARTY TALKS, THE TIMES MAINTAINS THAT "THE OFFER PLACED MR. FOOT IN DIFFICULTIES. HE HAS NOT SOUGHT CONSULTATIONS, WISHING TO BE FREE TO JUDGE, AND CRITICIZE IF NECESSARY, THE GOVERNMENT'S ACTIONS AS THEY HAVE DEVELOPED," AND GOES ON TO NOTE THAT "HIS (FOOT'S) QUESTIONING OF THE ACTION (SATURDAY'S STANLEY RAID) ADDED A NEW TWIST TO THE WIDENING LABOUR RIFT OVER THE USE OF MILITARY ACTION. HE SEEMED TO BE DISTANCING HIMSELF FURTHER FROM THE GOVERNMENT, BUT WAS ALSO TAKING A DIFFERENT LINE FROM SOME OF HIS SENIOR COLLEAGUES, NOTABLY MR. HEALEY AND MR. PETER SHORE, THE SHADOW CHANCELLOR." AND AN UNSYMPATHETIC TELEGRAPH NOTES "THAT FOOT IS TERRIFIED OF EARNING THE CONTEMPT OF THE ELECTORATE BY APPEARING TO UNDERMINE OUR FORCES IN THE SOUTH ATLANTIC, BUT EQUALLY HE KNOWS THAT THE LEFT WILL NEVER FORGIVE HIM UNLESS HE IS POISED TO RAT WHEN SOMETHING NASTY HAPPENS. IT IS A PROBLEM HE WILL HAVE TO WORK OUT FOR HIMSELF. MRS. THATCHER'S INVITATION MUST HAVE SEEMED VERY LIKE A POISONED CHALICE TO HIM."

EDITORIAL OPINION

3. MUST OF THE QUALITIES CONTINUE TO BACK THE GOVERNMENT. THE DAILY TELEGRAPH, FOR EXAMPLE, COMMENTS: "NOW THAT WE HAVE COME SO FAR, SO WELL, IT IS DIFFICULT TO SEE A MAJOR ROLE FOR COMPLICATED DIPLOMACY, LET ALONE FOR THE UNITED NATIONS IN TRYING TO SOLVE A PROBLEM WHICH HAS ALREADY DEFEATED THE UNITED STATES," AND THE TIMES, AS OFTEN OF LATE, TAKES THE HIGH ROAD: "IN LOOKING TO THE FUTURE THEN WE MUST HOLD OUT SOME HOPE FOR ARGENTINA, NOT THAT THE INVASION CAN BE REWARDED--BECAUSE THAT CANNOT AND SHOULD NOT BE DONE-- BUT THAT SOME FUTURE GOOD MAY EMERGE FROM CONTEMPORARY EVIL, FOR THAT TO OCCUR THERE FIRST HAS TO BE AN ARGENTINE RECOGNITION OF ITS OWN GUILT--NOT TO US, NOT TO THE UNITED NATIONS, BUT TO ITSELF."

4. ON THE OTHER HAND, THE GUARDIAN CONTINUES TO STRESS THAT THE LONGER TERM IMPLICATIONS OF BRITAIN'S ADOPTED COURSE ARE FRAUGHT WITH DANGERS WHICH HAVE BEEN INSUFFICIENTLY ADDRESSED. IN AN EDITORIAL HEAVILY CRITICAL OF THE WORST EXCESSES OF JINGOISTIC SENTIMENT
