SUBJECT: LETTER OF PROTEST RE US STAND ON FALKLAND ISLANDS

1. A LETTER OF PROTEST FROM THE SO CALLED "ARGENTINE COMMITTEE IN DEFENSE OF THE MALVINE ISLANDS" (COMITE ARGENTINO EM DEFESA DAS ILHAS MALVINAS) IN RIO WAS RECEIVED AT THE CONSULATE GENERAL TODAY.
2. THE ONE PAGE LETTER, ADDRESSED TO PRESIDENT REAGAN WAS WRITTEN IN SPANISH AND SIGNED BY PEDRO MARTIN AND DIMAS J. PETTINEROLI, LISTED RESPECTIVELY AS THE FINANCE SECRETARY AND PRESIDENT OF THE ORGANIZATION. THE LETTER PROTESTS BOTH US SUPPORT FOR GREAT BRITAIN AND ECONOMIC SANCTIONS AGAINST ARGENTINA. MENTION IS MADE OF THE MONROE DOCTRINE AND THE RIO TREATY WHICH THE US IS ACCUSED OF BREAKING ALONG WITH OTHER "CLASSIC AMERICAN CONCEPTS." FINALLY THE LETTER CALLS FOR AN IMMEDIATE END TO "ENGLISH AGGRESSION AND COMPLETE AND FINAL RECOGNITION OF ARGENTINE SOVEREIGNTY" (OVER THE ISLANDS).

3. THE CONSULATE FIRST BECAME AWARE THAT A PETITION MIGHT BE PRESENTED ONLY MINUTES BEFORE THE LETTER WAS DELIVERED WHEN CONSULATE SECURITY AGENTS APPROACHED A CAR FROM THE RIO DAILY "ULTIMA HORA", PARKED ILLEGALLY IN FRONT OF THE CONSULATE. THEY WERE TOLD BY A REPORTER THAT THE NEWSPAPER HAD RECEIVED INFORMATION THAT A "GROUP OF ARGENTINES" WERE ON THEIR WAY WITH A LETTER REGARDING THE "MALVINE ISLANDS." WITHIN MOMENTS THE LETTER WAS DELIVERED WITHOUT FANFARE BY AN UNACCOMPANIED YOUNG MAN AT 1 PM. A COMPANION WAS WAITING OUTSIDE THE CONSULATE AND THE TWO SPOKE BRIEFLY WITH THE "ULTIMA HORA" REPORTER BEFORE LEAVING. NO OTHER MEMBERS OF THE PRESS WERE PRESENT ALTHOUGH A CREW FROM TV GLOBO SHOWED UP ABOUT AN HOUR LATER BUT LEFT WITHOUT INTERVIEWING OR FILMING.
