THE GOA COMMUNIQUE STATES THAT THE CRUISER WAS SUNK AT 55 DEGREES 24 MINUTES SOUTH, 61 DEGREES 32 MINUTES WEST. THE GOA NOTES THAT THE HMG DECREE OF APRIL 28 ESTABLISHED THE ZONE AS "A CIRCLE WITH A RADIUS OF 200 NAUTICAL MILES MEASURED FROM 51 DEGREES 40 MINUTES SOUTH AND 59 DEGREES 30 MINUTES WEST." THUS, THE GOA STATES THE "BELGRAND" WAS BEYOND THE ZONE.
