SUBJECT: W/W AMCITS FALKLAND ISLANDS

1. JOHN LEONARD, SPOKESMAN FOR THE AMCITS ON FALKLANDS, CALLED THE EMBASSY AT 1250 MAY 5. HE REPORTED THAT ALL AMERICANS IN THE FALKLANDS WERE SAFE. HE OPINED, HOWEVER, THAT THE SITUATION IS BECOMING INCREASINGLY DANGEROUS AS DOES THE ANXIETY IN THE COMMUNITY. HE SAID TWICE THAT A VISIT BY THE ICRC WAS AN URGENT NECESSITY. HE ADDED THAT ARGENTINE AUTHORITIES CONTINUE TO BE HELPFUL AND COOPERATIVE AND THE COMMUNITY VERY MUCH APPRECIATES THEIR ASSISTANCE. MR. LEONARD

STATED THAT

HE WOULD TRY TO CALL AGAIN MAY 6 AT APPROXIMATELY THE SAME TIME. HE SAID THEY HAD MISSED CALLING OVER THE WEEKEND BECAUSE THE PHONES WERE NOT WORKING. HE SAID THAT AT THE TIME OF HIS CALL THERE WAS NO MILITARY ACTION IN PORT STANLEY.
