OF VIEW AND INTERESTS OF LOCAL INHABITANTS MUST BE  
TAKEN INTO ACCOUNT FOR THE PEACEFUL RESOLUTION  
OF THE PROBLEM.

6. A CONTACT GROUP WHICH WOULD INTERVENE IMMEDIATELY  
IN THE NEGOTIATIONS TO IMPLEMENT THIS AGREEMENT  
AND BE COMPOSED OF BRAZIL, PERU, THE FRG AND  
THE UNITED STATES.

7. A DEFINITIVE AGREEMENT WILL HAVE BEEN REACHED  
BEFORE 30 APRIL 1982 UNDER THE RESPONSIBILITY OF THE  
GROUP OF COUNTRIES MENTIONED ABOVE.

4. THE FOREIGN MINISTRY'S DESCRIPTION OF THE SUGGESTED  
MODIFICATIONS FOLLOWS: "THESE SEVEN POINTS WERE PRE-  
SENTED TO THE PRESIDENT OF ARGENTINA, WHO, IN A SUBSEQUENT  
RESPONSE, NOTED THE PRESENCE OF THE UNITED STATES IN THE  
CONTACT GROUP (POINT 6), AND ASKED THAT IN POINT 5, THE  
MENTION OF THE 'POINTS OF VIEW' OF THE LOCAL INHABITANTS  
BE EXCISED, LEAVING ONLY THE REFERENCE TO "INTERESTS".  
THE POINTS AS MODIFIED READ:

5. THE TWO GOVERNMENTS RECOGNIZE THAT THE ASPIRA-  
TIONS AND INTERESTS OF THE LOCAL INHABITANTS MUST BE  
CONSIDERED FOR THE DEFINITIVE SOLUTION OF THE  
PROBLEM.

6. A CONTACT GROUP WHICH WOULD IMMEDIATELY INTERVENE  
IN THE NEGOTIATIONS TO IMPLEMENT THIS AGREEMENT  
WOULD BE COMPOSED OF VARIOUS COUNTRIES TO BE  
DESIGNATED BY COMMON AGREEMENT.

LATER, PERU PROPOSED MODIFICATIONS TO POINT FOUR, WHICH  
WAS REDRAFTED IN THE FOLLOWING MANNER:

4. THE TWO GOVERNMENTS RECOGNIZE THE EXISTENCE  
OF VARYING AND CONFLICTING CLAIMS REGARDING THE

5. IN PUBLIC REMARKS MAY 7, BOTH PRESIDENT BELAUNDE AND PRIME MINISTER ULLOA REFERRED TO THE BRITISH ATTITUDE AS AN OBSTACLE TO PEACE, BUT OUR READING OF THE CONTEXT IS THAT THESE COMMENTS WERE DIRECTED AT BRITISH MILITARY MOVES, NOTABLY THE JUST-ANNOUNCED EXTENSION OF THE EXCLUSION ZONE, RATHER THAN TO THE NEGOTIATION PROCESS. IN HIS SUNDAY PRESS CONFERENCE MAY 9, BELAUNDE SAID THAT HIS PEACE EFFORT FAILED "NOT BECAUSE THE TERMS WERE BAD, BUT BECAUSE OF THE TORPEDGING OF THE 'BELGRAND', WHICH FORCED US TO SUSPEND THE EFFORT".

6. ELSEWHERE, IN THE PRESS CONFERENCE, BELAUNDE WAS ASKED ABOUT THE USG POSITION ON THE ISLANDS' SOVEREIGNTY, HE REPLIED BY CITING A PERSONAL LETTER FM PRESIDENT REAGAN WHICH HE SAID MADE CLEAR HIS (REAGAN'S) "ANTI-COLONIALIST SPIRIT". BELAUNDE SAID THAT THE LETTER WENT BEYOND THE "GENERAL TERMS" APPARENTLY INCLUDED IN LETTERS TO OTHER LATIN AMERICAN PRESIDENTS TO INCLUDE SPECIFIC COMMENTS ON BELAUNDE'S OWN PEACEMAKING ROLE. "FOR THIS REASON I UNDERTOOK MY EFFORT WITH SUCH DEDICATION, SINCE I HAD THIS IMPORTANT SUPPORT, WHICH ALSO ENTAILED A CONTACT WITH GREAT BRITAIN."
