CABINET, WHICH MET TWICE YESTERDAY, APPEARED TO BE INCREASINGLY SUSPICIOUS OF ARGENTINA'S READINESS TO SETTLE." SIMILARLY, THE FINANCIAL TIMES WRITES: "DOUBTS IN LONDON OVER THE ARGENTINE RESPONSE TO THE LATEST UNITED NATIONS PROPOSALS, AND IN PARTICULAR OF THE CHANCES OF GETTING A CLEAR AND BINDING REPLY, ARE SO STRONG THAT THE BRITISH GOVERNMENT HAS HELD BACK FROM GIVING A CATEGORIC REPLY....
